## AN ACT

## DECLARING THE IMMEDIATE ENVIRONS OF THE SAINT MATTHIAS PARISH CHURCH LOCATED IN THE MUNICIPALITY OF TUMAUINI, PROVINCE OF ISABELA, AS A TOURISM DESTINATION

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The immediate environs of the Saint Matthias Parish Church located in

2 the Municipality of Tumauini, Province of Isabela, are hereby declared as a tourism

3 destination. Pursuant thereto, the development of the immediate environs of the Saint

4 Matthias Parish Church shall be prioritized and supported by the Department of Tourism

(DOT), subject to the rules and regulations governing the development of tourism
 destinations.

3 SEC. 2. Within one (1) year after the approval of this Act, the municipal government 4 of Tumauini shall, in coordination with the DOT, Department of Public Works and 5 Highways, National Historical Commission of the Philippines and concerned agencies of the government, prepare a tourism development plan that shall include the construction, 6 installation and maintenance of such appropriate infrastructure and facilities to improve the 7 overall features of the immediate environs surrounding the Saint Matthias Parish Church, 8 thereby ensuring its accessibility and the security of tourists: Provided, That said 9 development plan shall ensure the preservation and conservation of the historical significance 10 of the church: Provided, further, That the implementation of the tourism development plan 11 shall be included in the budget of the municipal government of Tumauini. 12

SEC. 3. The DOT shall assist the municipal government of Tumauini in the implementation of the tourism development plan by providing technical assistance in tourism capacity building. It shall also include the immediate environs of the Saint Matthias Parish Church in its national and regional promotion programs.

SEC. 4. The funding for the implementation of this Act shall be included in the
annual budget of the municipal government of Tumauini. The DOT may augment such
allocation with internally-generated funds.

SEC. 5. Within sixty (60) days from the effectivity of this Act, the municipal government of Tumauini shall, in consultation with the DOT and concerned agencies of the government, promulgate rules and regulations to implement this Act.

23 SEC. 6. This Act shall take effect fifteen (15) days after its publication in the *Official*24 *Gazette* or in a newspaper of general circulation.
