**AN ACT
GRANTING PHILIPPINE CITIZENSHIP TO JUSTIN DONTA BROWNLEE**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** Justin Donta Brownlee is hereby granted Philippine citizenship with all
2 the rights, privileges and prerogatives, as well as the duties and obligations
3 appurtenant thereto, under the Constitution and the laws of the Republic of the
4 Philippines.

6 **SEC. 2.** Justin Donta Brownlee shall take the Oath of Allegiance to the Republic of
7 the Philippines before an officer duly authorized to administer the same. The Oath of
8 Allegiance shall be registered with the Bureau of Immigration.

9
10 **SEC. 3.** Upon registration of the Oath of Allegiance, the Bureau of Immigration
11 shall issue a Certificate of Naturalization to Justin Donta Brownlee who shall
12 thereupon enter into the full enjoyment of Philippine citizenship.

13
14 **SEC. 4.** This Act shall take effect immediately upon its publication in the *Official*
15 *Gazette* or in a newspaper of general circulation.
