SESSION NO. 32 Monday, November 28, 2022

CALL TO ORDER

At 3:02 p.m., the Senate President, Hon. Juan Miguel "Migz" F. Zubiri, called the session to order.

PRAYER

Sen. Joel Villanueva led the prayer, to wit:

Senator Escudero attended the session online due to his exposure to COVID-19.

Senator Cayetano (A) was absent.

APPROVAL OF THE JOURNAL

Upon motion of Senator Villanueva, there being no objection, the Body dispensed with the reading of the Journal of Session No. 31 (November 23, 2022) and considered it approved.

At this juncture, Senator Villanueva acknowledged the presence in the gallery of the following guests:

Senate President Zubiri welcomed the guests to the Senate.

MANIFESTATION OF SENATOR CAYETANO (P)

Senator Cayetano (P) informed the Body that the Senate, in collaboration with the Embassy of Israel, was holding a photo exhibit in the premises, entitled "Bridging Innovation Between Israel and the Philippines." She stated that the exhibit would highlight various joint projects between the two countries, including agricultural projects. She also stated that her conversation with Mr. Or Haviv, partner and head of Global Innovation at Arieli Capital, centered on the same advocacy that the Body supported over the years—the advancement of science, technology, engineering, and mathematics (STEM) at the university level, as well as the ability to commercialize the innovations created as a result. She expressed hope that the conversation would be just the beginning of exploring other opportunities in the countryside.

REMARKS OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri extended his warmest greetings to Ambassador Fluss and the Israeli delegation. He then informed his fellow senators that his visit to Israel had allowed him to personally observe how Israeli farmers were able to produce so much with such limited resources as water and soil in a desert country. He added that Israel's expertise in drip irrigation has also benefited his province of Bukidnon, which has several private sector projects utilizing the country's technological advancements.

MANIFESTATION OF SENATOR POE

Senator Poe expressed her delight in the Israeli government's willingness to help the country in addressing its water issues by sharing its expertise and technological innovations. Furthermore, she observed that despite its desert location, Israel has made most out of its scarce water resources, a technological feat she was thankful Israel for sharing with the Philippines. Senate President Zubiri also informed the senators of Israel's status as a world leader in the production of desalination facilities.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva associated himself with the statements of Senate President Zubiri and Senator Poe. He also stated that he had been a member of the two countries' interparliamentary association for 20 years and was a proud supporter of Ambassador Fluss.

MANIFESTATION OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri further shared some information about Israel during World War II. He stated that during that time, President Quezon granted visa-free entry to Jewish patriots seeking safe refuge in the Philippines, and that the Philippines was the first to embrace Israeli nationals as brothers during the war.

AN ACT DECLARING THE FIRST DAY OF FEBRUARY OF EVERY YEAR AS NATIONAL HIJAB DAY.

Senator Villanueva stated that the parliamentary status was the period of interpellations.

Thereupon, the Chair recognized Senator Padilla, sponsor of the measure, and Senator Pimentel for his interpellation.

INTERPELLATION OF SENATOR PIMENTEL

At the outset, Senator Pimentel asked what the proposed law aims to accomplish. Senator Padilla responded that the bill has cultural and religious implications because Filipinos, whether Christians or Muslims, are known for their strong religious faith. He pointed out that wearing the hijab is not something new because wearing veils is an age-old tradition.

He stated that in the Philippines, those who were unaware of the significance of wearing the hijab tend to discriminate against Muslim women, perceiving them as terrorists at times. He lamented that female Muslim job applicants had experienced rejection, were denied access to public transportation, or harassed due to the misconception that they are bad people.

He explained that the idea behind observing a National Hijab Day was to raise public awareness about the practice of wearing a head covering. He also stated that it would serve as a reminder that there is no distinction between Muslim and Christian women, as exemplified by the Virgin Mary herself, who is frequently depicted wearing a hijab.

When asked about the difference between the hijab and the niqab, he stated that the wearing of niqab, which almost completely covers the entire face, is not encouraged in Islamic schools, but only the hijab is. He stated that the niqab is traditionally worn in Middle Eastern countries such as Saudi Arabia to protect one's face during sandstorms, which does not apply in the Philippines.

On what to expect should the bill pass into law, Senator Padilla stated that he envisioned a situation similar to his experience during the Partners for Peace campaign, in which participating

Catholic school students expressed interest in learning about the hijab and its cultural and religious characteristics. He stated that the bill's intention is to encourage people to learn about the hijab and does not, in any way, intend to make its wearing mandatory.

When asked on the nature of the designated day, Senator Padilla clarified that it would be considered a day of commemoration rather than a holiday. He allayed fears, especially of employers, that the measure would lead to the creation of another holiday.

Senator Pimentel surmised that commemorative activities could include features about the hijab in traditional and online media. Senator Padilla likened it to the declaration of National Indigenous People's Day, on which initiatives highlighting Indigenous Peoples are created and celebrated.

On the designation of the National Commission on Muslim Filipinos as the lead agency, Senator Padilla stated that the agency had already been implementing similar activities that promote religious education and the hijab, but he emphasized the need to institutionalize its mandate in order to scale up the programs and activities. Senator Pimentel expressed hope that with the passage of the measure, the NCMF and its efforts would become more prominent.

Asked if the bill had any budget implications, Senator Padilla said that he had met with NCMF officials and requested that the agency perform its mandate without incurring any additional budgetary costs, at least for the current fiscal year. He underscored the importance of passing the bill, adding that any funding concerns may be addressed during future budget deliberations. Senator Pimentel pointed out that the budget implication should be limited by the objectives of the law as stated in Section 6 of the bill.

Queried on the stakeholders that were consulted during the committee hearing, and if anyone opposed the bill, Senator Padilla replied that the NCMF, the Bangsamoro Autonomous Region of Muslim Mindanao, as well as other well-known advocates for the institutionalization of the Hijab Day like Atty. Maisara Latiph and Ms. Samira Gutoc, were among the consulted stakeholders. He stated that only the imams and ustads who attended the hearing indicated their disagreement to having the Hijab Day proclaimed as a holiday considering that Eid'l Fitr and Eid Al-Adha are the only two holidays celebrated in Islam.

On a related matter, Senator Pimentel asked for details regarding a hijab-related incident in Iran. Senator Padilla stated that the case involved a young female vlogger who died in police custody after being arrested by local authorities for wearing the hijab, as required by Iranian law, improperly. He opined that such a law is in contrast with the Philippine Constitution, which guarantees the free exercise of religion and religious worship. He stated that in Islam, all actions must be "ikhlas," or performed with complete sincerity; thus, Muslim women in the Philippines are not compelled to wear the hijab.

Asked on the impact of the legislation on Philippine society, he stated that it would help Filipinos come to a deeper understanding of the various religions and cultures in the country. He emphasized that such understanding would eliminate unfavorable biases against different religions, which were exacerbated by fake news and sensationalism.

As he noted the commonalities between the Christian and Muslim religions, Senator Padilla believed that knowing and understanding them is the initial step toward national unity. Senator Pimentel concurred, saying that the passage of the bill can be seen as a gesture of solidarity with Filipino Muslim women.

Senate President Zubiri interjected at this point, agreeing that the bill's passage would be interpreted as an expression of respect toward Muslim Filipinos. He pointed out that although some Western countries prohibit the wearing of the hijab in schools to promote equality, the Philippines allows people to freely practice their religion. He then highlighted the similarity between the hijab and the veil worn by Roman Catholic women.

Asked by Senate President Zubiri if the wearing of the hijab and the veil is similar expression of religious practice, Senator Padilla replied in the affirmative.

Senator Pimentel proposed that, at the proper time, Section 3 include the historical reality of the hijab, so that the definition would not be limited to Muslim women. Senator Padilla welcomed Senator Pimentel's suggestion, saying that it would raise people's awareness about Islam and lead to acceptance by other faiths.

Senate President Zubiri recalled that his wife and Senator Pimentel's wife traveled to Maguindanao wearing hijab. He stated that it was their way of showing respect to the Muslim religion.

Senator Pimentel concluded by thanking Senator Padilla for allowing him to clarify certain concepts in a meaningful bill. He urged the public to read Senate Bill No. 1410 and understand that it is not a holiday and it does not impose anything on anyone, but rather serves to promote solidarity, mutual understanding, and respect.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva stated that it was a tremendous blessing that Senator Padilla was able to sponsor the bill in which he learned the distinction between the hijab and niqab. He echoed the sentiments of Senators Pimentel and Padilla that they share a belief in serving the country and people, as well as an interest in politics.

He stated that there is much to learn about the Muslim and Christian faiths. He recalled that, as a child raised in a church, he had the incorrect impression that Christians could not live in Mindanao, but when he met Cong. Mujiv Hataman, who was godfather to his son, and vice versa, he learned a great deal about their culture and traditions.

Senator Villanueva emphasized the importance of solidarity, respect for culture, and respect for the various sectors of society because they provide a proper, orderly, and clear perspective on how to interact with one another.

As coauthor of the measure, he expressed his desire to learn more about the culture and the people in order to better care for them. He stated that they may hold their own beliefs, but they can rest assured that their inherent rights are respected even more than their freedom of religion.

MANIFESTATION OF SENATOR HONTIVEROS

As coauthor of Senate Bill No. 1410, Senator Hontiveros expressed her appreciation for Senator Padilla's statement that the bill does not seek to compel anyone to wear a hijab, or *kombong* in Filipino.

She emphasized the importance of understanding the proper use of the hijab to prevent its misuse and abuse. She recalled that during the investigation into POGO-related prostitution, illegal detention, pastillas scam, and human trafficking, several BARMM constituents complained that the hijab was used to conceal trafficked minor women. In addition, she recalled the time when the reproductive health bill was being discussed and the Bangsamoro community, through its grand imam, issued a *fatwa* expressing its support for the RH Law and the Breastfeeding Law, which would protect their women and children, particularly the girls.

Senator Hontiveros then thanked Senator Padilla for bringing to fore a bill that would promote the wearing of the hijab regardless of religion and culture, raise the dignity of the women, and inform people of its proper use.

Senator Padilla expressed appreciation to Senators Pimentel, Hontiveros, and Villanueva for their manifestations of support.

MANIFESTATION OF SENATOR CAYETANO (P)

Senator Cayetano (P) informed the Body that Taguig City is home to the largest Muslim community outside of Mindanao. Had Senator Cayetano (A) been present, she believed, he would have provided a great deal of insight on the subject, as Christians and Muslims have coexisted in Taguig City with great harmony.

She stated that it is essential to discuss religion on the floor, as it can be a means of fostering harmony amid the hatred in the world. And while she knew the underlying cause of the misunderstanding, she said that she would approach the subject with care and compassion.

Senator Cayetano (P) recalled that three years ago, a video of a girls' football game went viral when members of the opposing team formed a human shield to help a player fix her hijab. She underscored that the declaration of policy in the bill exemplifies the necessity of policies to protect women and their beliefs.

She then stated that because she still had questions and concerns on the matter for her education, she would resume her interpellation as soon as she had completed her notes.

MANIFESTATION OF SENATOR TULFO

Senator Tulfo, in expressing his full support for Senate Bill No. 1410, stated that the nation would recognize the significance of Muslim women wearing the hijab, which is especially significant in countries where Muslims are a minority. He stated that the recognition would mean that the Muslims would be accepted for who they are and their identity would be respected, in contrast to societies where minority rights are violated.

He added that the Philippines would serve as a shining example, reassuring those who wear the hijab that the country is a caring country with a caring government, and that all can live together while facing challenges and adversities.

He concluded that this simple, yet meaningful, gesture would further improve the lives of Filipinos and strengthen the nation.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 1410

SPONSORSHIP SPEECH OF SENATOR EJERCITO

Senator Ejercito, on behalf of the Committee on Local Government, submitted for plenary consideration House Bill No. 3968, entitled "An Act Converting the Municipality of Carmona in the Province of Cavite into a Component City to be Known as the City of Carmona," under Committee Report No. 12.

The full text of Senator Ejercito's sponsorship speech follows:

Your Committee Chairperson on Local Government understands fully the importance of this measure and its contribution to the future of Carmona and its people. Being former mayor who saw and worked for the progress of a small town to a highly-urbanized and developed city, I can only support this wholeheartedly and acknowledge the toil and dedication of the people behind this measure.

Ang atin pong layunin ay maparami pa ang mga lungsod sa ating bansa. Higit marahil sa karangalan na matawag na isang "city" ang isang bayan, ay kaakibat nito ang kaunlaran at mas maginhawang buhay para sa mga mamamayang naninirahan dito. Kaya po naunawaan ko po kung bakit umaapaw sa suporta ang panukalang batas na ito mula sa mga kasamahan natin sa Kapulungan na ito na mula sa Lalawigan ng Cavite.

We especially acknowledge the support of our colleagues to this measure—a true and respected Caviteño, Sen. Bong Revilla—by filling a counterpart bill, Senate Bill No. 1355.

This is a historic legislation not just for Carmona, but for this august Chamber. Today, we sponsor the first bill on conversion of a municipality into a component city following the passage of Republic Act No. 11683. This law, which was passed in the last Congress, amended the Local Government Code on the requisites for conversion and effectively recognizes thriving municipalities that are fiscally competent as reflected in their locally-generated income but could not qualify as city because of limitations in their land area or population.

Ngunit ito ay maituturing na bunga rin ng walang pagod na pagsisikap ng kanilang mga mamamayan upang mas mapaganda at mapaunlad ang kanilang munting bayan. Karapat-dapat ang Carmona na matawag at kilalanin bilang isang lungsod. Kinapos man noon sa populasyon, o nalimita man ang lupain, ngunit umaapaw naman sa progreso.

We laud the champions of local government units—the sponsor and author of RA 11683, our distinguished colleague, Sen. Francis "Tol" Tolentino—and former Sen. Panfilo Lacson.

Since the early 1990s, Carmona has been an industrialized and highly commercialized first-class municipality and boasts of major characteristics of a city.

It is an industrial community that, to date, hosts 12 industrial estates and four industrial compounds housing more than 329 manufacturing, garments, semiconductor, electronic, and steel fabrication industries. Its proximity to Metro Manila and, at the same time, being the gateway to the south has made it an ideal venue for business and development.

Ngunit higit sa bilang ng mga pagawaan at pabrika, marahil ay mas mahalaga na mabigyan ng pansin ang mga trabaho at oportunidad na naibigay ng mga ito hindi lamang para sa kanilang bayan kung hindi pati na rin sa kanilang mga karatig lugar.

Carmona is also a rising smart city, and its biggest ongoing development investment is expected to further transform Carmona into one of the most modern and highly urbanized communities in the Philippines.

In terms of its basic services for its constituents, it has no shortage of hospitals, universities, playgrounds and leisure parks, public market, commercial establishments, and highways and transportation networks. In addition, there are also numerous subdivisions and real estate developments, as well as BPO companies within the locality.

Indeed, Carmona has all the characteristics of a city but does not enjoy such privilege despite being one of the most prosperous municipalities in the country today.

Under R.A. No. 11683, the Municipality of Carmona is now qualified for conversion into a component city. It has complied with the two criteria set forth by the said law:

First, it has an average locally-generated annual income of P499.907 million for fiscal years 2020 and 2021 based on 2012 constant prices, as certified by the Bureau of Local Government. In terms of finance, Carmona has reached the required P400 million under Republic Act No. 11683 and five times more than the required income in Sec. 450 of the Local Government Code of 1991, as amended.

Second, its population as of May 1, 2020, based on the 2020 census of population and housing conducted by the Philippine Statistics Authority, was 106,256. It is projected to significantly increase in the near future with the recent developments. It is compliant with the population of not less than 100,000 as required by law.

This humble Representation believes that the income requirement would be the greatest hurdle that any municipality that aspires to be a city must comply with. However, the Municipality of Carmona has passed this obstacle with flying colors. Though it has already complied with the population requirement, I firmly believe that because of its beauty and continued industrialization, more and more would choose to live in Carmona. It is not only the lights that fascinate one to live in a city but the opportunities it can bring to his or her life.

During the committee hearing for this measure, we had the chance to invite the authors of this measure, Cong. Roy Loyola and Cong. Jolo Revilla, who both attested to the progress and qualifications of the Municipality of Carmona. For our counterparts in the House of Representatives and for the people of Carmona, it has been 12 long years of pursuit for their cityhood. We have high hopes that during this Congress, we will finally pave the way for the realization of this dream.

In cosponsoring House Bill No. 3968, Senator Revilla delivered the following speech:

It is my honor to associate myself as a cosponsor of this measure and express my full support in converting the Municipality of Carmona in the Province of Cavite into a component city to be known as the City of Carmona.

Being a first-class urban municipality in the Province of Cavite, the Municipality of Carmona has long proven its economic viability and stability. For fiscal year 2020 and 2021, it generated an average local annual income of more than P400 million. Its conversion will enhance its capability of attracting investments, further improving services to the constituency, enhancing development and progress, as well as promoting peace and order in the locality. Sa madaling salita, ang pagpasa ng panukalang ito ay nangangahulugan ng mas mahusay na serbisyo para sa kapakanan ng mga nasasakupang mamamayan ng Carmona.

Bilang anak ng Cavite, isang malaking hakbang ito upang kilalanin ang patuloy na pagyabong ng probinsya.

Cavite, in recent years, has truly been a melting pot of Filipinos who have either found stable jobs in the province, been born and raised in its fertile grounds, or have simply made it home. *Ito na po ang tamang panahon*. Aside from all its accomplishments, it has already complied with all the requirements set forth by existing laws.

This Representation also commends the effort and great help of our chairperson of the Committee on Local Government, Sen. Joseph Victor "JV" Ejercito, for sponsoring this measure.

Senator Villanueva stated that in a letter to Senate President Zubiri, Senator Gatchalian had manifested that he was withdrawing Senate Bill. No. 387 (Senior High School ROTC), which he authored and was referred to the Committees on Basic Education, and Finance.

Upon motion of Senator Villanueva, there being no objection, the Body approved the withdrawal of the bill.

WITHDRAWAL OF SENATE BILL NO. 231

Senator Villanueva stated that Senator Padilla had also written Senate President Zubiri to express his desire to withdraw Senate Bill No. 231 (amending RA 8178, as amended), which

he authored and was previously referred to the Committees on Agriculture, Food and Agrarian Reform, Ways and Means, and Finance, in view of the filing of an improved version thereof.

Upon motion of Senator Villanueva, there being no objection, the Body approved the withdrawal of the bill.
