## AN ACT

## ESTABLISHING THE PHILIPPINE ENTREPRENEURS ACADEMY AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Short Title. This Act shall be known as the "Philippine Entrepreneurs Academy Act."
- 2 SEC. 2. Establishment. There is hereby established a learning institution, under the supervision of the
- 3 Commission on Higher Education (CHED), to be known as the "Philippine Entrepreneurs Academy",
- 4 hereinafter referred to as the Academy.
- 5 SEC. 3. General Mandate. The Academy shall provide undergraduate and graduate degree programs,
- 6 short-term technical-vocational nondegree courses and modular trainings that will enhance the core
- 7 competencies of individuals on entrepreneurship. It shall cater to technical-vocational, college and
- 8 graduate students. It shall promote the relevance of entrepreneurship to job generation and its significant
- 9 role to the sustainable economic growth of the country.
- 10 The Academy shall formalize and integrate, under a school system, the nonformal entrepreneurship
- 11 programs and short-term technical-vocational courses of the Technical Education and Skills Development
- Authority (TESDA), Department of Trade and Industry (DTI), Department of Science and Technology
- 13 (DOST), and other government agencies. It shall administer education and consultancy, and supervise
- 14 publication on entrepreneurship. It shall also conduct scientific and policy-oriented research and training.
- 15 The Academy shall comply with the requirements and standards of the CHED and the provisions of
- Republic Act No. 8292, otherwise known as the "Higher Education Modernization Act of 1997", and
- other pertinent laws on higher education.
- 18 SEC. 4. Curricular Offerings. The Academy shall offer undergraduate and graduate degree programs
- 19 and short-term diploma or certificate courses on entrepreneurship, including entrepreneurship
- development in the fields of agriculture, trade, technology, and the manufacturing sector. The curriculum
- 21 and modules of the programs shall be designed and developed following the competency-based curriculum
- 22 model and in accordance with the mandate of this Act.
- SEC. 5. School Sites. The Academy shall have two (2) campuses, with the main campus to be established
- 24 in the Clark Freeport and Special Economic Zone located in the Provinces of Pampanga and Tarlac, to be
- 25 known as the "Philippine Entrepreneurs Academy Main Campus-Clark". The other campus shall be
- located in the City of Baguio, to be known as the "Philippine Entrepreneurs Academy-Baguio City
- 27 Campus".

- 1 SEC. 6. Governing Board. The governing board of the Academy shall be the Board of Trustees,
- 2 hereinafter referred to as the Board, which shall be chaired and co-chaired by the Chairperson of the
- 3 CHED, and the President of the Academy, respectively, with the following as members:
- 4 (a) Chairperson of the Committee on Higher, Technical and Vocational Education of the Senate;
- 5 (b) Chairperson of the Committee on Higher and Technical Education of the House of Representatives;
- 6 (c) Director General of the TESDA:
- 7 (d) Director General of the National Economic and Development Authority (NEDA);
- 8 (e) Secretary of the DOST;
- 9 (f) Secretary of the DTI:
- 10 (g) President of the federation of faculty associations of the Academy;
- 11 (h) President of the federation of student councils of the Academy;
- 12 (i) President of the federation of alumni associations of the Academy; and
- 13 (j) two (2) prominent citizens from the private sector who have distinguished themselves in their
- 14 professions or fields of specialization.
- The members of the Board shall not receive any compensation or remuneration for their services as
- such, but may be reimbursed for actual and necessary expenses incurred in discharging the business of the
- 17 Academy.
- 18 SEC. 7. Powers and Duties of the Board. The Board shall be the highest policymaking body of the
- 19 Academy. In addition to its general powers of administration and the exercise of all the powers granted to
- 20 the Board of a corporation under existing laws, the Board shall have the following specific powers and
- 21 duties:
- 22 (a) Promulgate and implement policies in accordance with the declared State policies and pertinent
- 23 provisions of the Philippine Constitution on education, as well as policies, standards and thrusts of the
- 24 CHED under Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994";
- 25 (b) Adopt rules and regulations not contrary to law, as may be necessary to carry out the purposes and
- 26 functions of the Academy, and to effectively discharge its responsibilities;
- 27 (c) Receive assistance from any legitimate source to augment the internal sources of funds, as may be
- 28 provided, for the support of the Academy in the manner it may determine, in its discretion, to carry out
- 29 the purposes and functions of the Academy;
- 30 (d) Constitute the Board, as herein defined;
- 31 (e) Appoint the President, and as many Vice-Presidents as may be necessary to assist the President in the
- 32 administration of the affairs of the Academy;
- 33 (f) Review periodically the administrative procedures and programs of the Academy;
- 34 (g) Receive, in kind and in trust, legacies, gifts and donations of real and personal properties of all kinds,
- 35 and to administer and dispose the same when necessary for the benefit of the Academy, subject to
- limitations, discretions and instructions of the donors, if any;

- 1 (h) Fix the tuition fees and other school charges such as matriculation fees, graduation fees, laboratory
- 2 fees, and other miscellaneous fees as the Board may deem proper to impose after due consultations with
- 3 the involved sectors: Provided, That these fees shall not be prohibitive or unreasonable as to deviate from
- 4 the purpose for which the Academy was created based on the guidelines of the CHED;
- 5 Such fees and charges, including government subsidies and other incomes generated by the Academy,
- 6 shall constitute its regular fund and shall be deposited in any authorized government depository bank, and
- 7 all interests that shall accrue therefrom shall form part of the same fund for the use of the Academy.
- 8 Any provision of existing law, rule and regulation to the contrary notwithstanding, any income generated
- 9 by the Academy from tuition fees and other charges, as well as from the operation of auxiliary services
- and land grants, shall be retained by the Academy, and may be disbursed by the Board for instruction,
- 11 research, extension services, or other programs and projects of the Academy: Provided, That all fiduciary
- fees shall be disbursed for the specific purposes for which they were collected.
- 13 If for reason beyond its control, the Academy shall not be able to pursue any project for which funds have
- 14 been appropriated and allocated under its approved program of expenditures, the Board may authorize the
- use of said funds for any reasonable purpose which, in its discretion, may be necessary and urgent for the
- attainment of the objectives and goals of the Academy;
- 17 (i) Adopt and implement a socialized tuition scheme for greater access of poor, but deserving students
- in accordance with Republic Act No.10931 or the "Universal Access to Quality Tertiary Education Act";
- 19 (j) Authorize the construction or repair of its buildings, machineries, equipment, and other facilities,
- as well as the purchase and acquisition of real and personal properties, including the necessary supplies,
- 21 materials, and equipment;
- 22 (k) Appoint, upon the recommendation of the President of the Academy, the deans, executive directors,
- 23 heads of departments, faculty members, and other officials and employees;
- 24 (1) Prescribe the salaries of faculty members and administrative officials and employees, subject to the
- provisions of Republic Act No. 11466, otherwise known as the "Salary Standardization Law of 2019",
- and by such other laws amendatory thereto, which may hereinafter be enacted, and civil service rules and
- 27 regulations governing hours of service and related concerns, and other pertinent laws;
- 28 (m) Formulate and implement the curricula and institutional programs of the Academy: Provided, That
- 29 they comply with the minimum CHED requirements and guidelines;
- 30 (n) Formulate and promulgate the rules of discipline for the students of the Academy to ensure orderly
- and effective governance thereof;
- 32 (o) Set policies on admission and graduation of students: Provided, That they conform with CHED
- 33 guidelines;

- 1 (p) Award honorary degrees upon persons in recognition of outstanding contribution in the field of
- 2 education, public service, arts, science and technology, or any field of specialization within the academic
- 3 competence of the Academy and to authorize the issuance of certificates of completion of non-
- 4 baccalaureate programs and nontraditional or innovative courses: *Provided*, That these conform with the
- 5 applicable guidelines of the CHED and TESDA;
- 6 (q) Establish research and extension centers of the Academy where such will promote the development
- 7 of the latter;
- 8 (r) Establish professorial chairs in the Academy and provide fellowships for qualified faculty
- 9 members and scholarships to deserving students;
- 10 (s) Enter into any agreements or joint ventures with business and industry for the profitable management
- of the economic and manpower assets of the Academy, the proceeds from which shall be used for the
- 12 upgrading of facilities and its development;
- 13 (t) Authorize an external management audit of the Academy, to be financed by the CHED, subject to the
- rules and regulations of the Commission on Audit, and institute reforms, including academic and structural
- changes, on the basis of the audit results and recommendations;
- 16 (u) Import economic, technical, and cultural books and publications;
- 17 (v) Develop consortia, academe-industry linkages and other forms of networks with other institutions
- and agencies, both public and private, local and foreign: *Provided*, That these comply with the applicable
- 19 guidelines of the CHED in furtherance of the purposes and objectives of the institution as well as develop
- 20 academic arrangements for institution capacity and capability building with appropriate institutions and
- agencies, public and private;
- 22 (w) Appoint experts and specialists as consultants, or visiting or exchange professors, scholars,
- 23 researchers, as the case may be: *Provided*, That the appointment shall conform with CHED guidelines;
- 24 (x) Set up the adoption of modern and innovative modes of transmitting knowledge, such as the use of
- 25 information technology, the dual training system, open distance learning, and community laboratory for
- 26 the promotion of greater access to education;
- 27 (y) Outsource, where most advantageous to the institution, the management of non-academic services
- such as health, food, building or grounds or property maintenance and similar objectives;
- 29 (z) Delegate any of its powers and duties to the President or the other officials of the Academy, as it
- may deem appropriate, so as to expedite the administration of the affairs of the Academy;
- 31 (aa) Extend the term of the President of the Academy beyond the age of retirement, when deemed
- meritorious due to outstanding performance, but not beyond the age of seventy (70) years old; and
- 33 (bb) Promulgate rules and regulations, as may be necessary, to carry out the purposes and functions of
- 34 the Academy.

- 1 SEC. 8. President of the Academy. The Academy shall be headed by a President, who shall render full-
- 2 time service and shall be appointed by the Board upon the recommendation of a duly constituted Search
- 3 Committee. The President shall also be the chief executive officer of the Academy.
- 4 The President shall have a term of four (4) years and shall be eligible for reappointment to another term.
- Within six (6) months before the expiration of the term of office of the incumbent President of the
- 6 Academy, the Board shall constitute the Search Committee for the Presidency.
- 7 The President shall receive such compensation and remuneration in accordance with Republic Act No.
- 8 11466 or the "Salary Standardization Law of 2019", and by such other laws amendatory thereto, which
- 9 may hereinafter be enacted, and shall be comparable to that being received by the Presidents of similar
- 10 educational institutions.
- 11 The President shall exercise the following powers and duties:
- 12 (a) Submit, for the consideration of the Board and the Executive Committee, the policies and measures
- which are necessary to carry out the purposes of the Academy;
- 14 (b) Recommend, coordinate, and administer the programs and projects of the Academy;
- 15 (c) Direct and supervise the operations and internal administration of the Academy, and delegate
- administrative responsibilities in accordance with the rules and regulations of the Academy;
- 17 (d) Submit an annual report to the Board setting forth the accomplishments of the Academy during
- the year, its financial operations and status, and a program and budget for the ensuing year; and
- 19 (e) Exercise other powers and discharge other functions, as may be vested by the Board and the
- 20 Executive Committee.
- 21 The Board shall designate an Officer-In-Charge (OIC) of the Academy in case of vacancy in the Office
- of the President by reason of death, compulsory retirement, resignation, removal for cause or incapacity
- of the President to perform the functions of the office, pending the appointment of a new President:
- 24 Provided, That the OIC shall serve only during the unexpired portion of the term.
- 25 The powers and duties of the President of the Academy, in addition to those provided in this Act, shall be
- 26 those usually pertaining to the Office of the President of similar educational institutions, and those
- delegated by the Board.
- SEC. 9. Executive Committee. There shall be an Executive Committee consisting of the President of the
- Academy and four (4) other members to be elected by the Board from its members. Each Members of the
- 30 Executive Committee, other than the President of the Academy, shall hold office for a term of two (2)

- 1 years, and shall be eligible for re-election, unless at the time of election, a shorter term is specified. The
- 2 Board shall elect the Chairperson of the Executive Committee from the membership of the Board.
- 3 SEC. 10. Functions of the Executive Committee. The Executive Committee shall administer the affairs
- 4 of the Academy in accordance with such functions, powers and responsibilities as may be delegated by
- 5 the Board.
- 6 SEC. 11. Government Support and Coordination. The CHED Chairperson is hereby authorized to call
- 7 upon any department, bureau, agency or instrumentality of the government for such assistance as may be
- 8 necessary for the effective implementation of this Act.
- 9 SEC. 12. Tax Exemption. The importation of economic, technical and cultural books and publications,
- which are for the economic, technical, vocational, scientific, philosophical, historical or cultural purposes
- of the Academy, upon certification by the CHED, shall be exempt from customs duties in accordance with
- the provisions of Republic Act No. 10863, otherwise known as the "Customs Modernization and Tariff
- 13 Act".
- All grants, bequests, endowments, donations and contributions made to the Academy, to be used actually,
- directly and exclusively by it, shall be exempt from donor's tax and the same shall be considered as
- 16 allowable deduction from the gross income in the computation of the income tax of the donor, in
- accordance with the provisions of the National Internal Revenue Code of 1997, as amended.
- 18 SEC. 13. Appropriations. The amount necessary to carry out the provisions of this Act shall be included
- in the annual General Appropriations Act.
- 20 SEC. 14. Implementing Rules and Regulations. Within ninety (90) days from the effectivity of this Act,
- 21 the CHED shall, in coordination with the TESDA and the DTI, formulate the necessary rules and
- regulations to fully implement the provisions of this Act.
- 23 SEC. 15. Separability Clause. If, for any reason, any part or provision of this Act is declared invalid or
- 24 unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.
- 25 SEC. 16. Repealing Clause. All laws, presidential decrees, executive orders, proclamations or
- administrative regulations that are inconsistent with the provisions of this Act are repealed, amended, or
- 27 modified accordingly.
- 28 SEC. 17. Effectivity. This Act shall take effect fifteen (15) days after its publication in the Official
- 29 Gazette or in a newspaper of general circulation.
