AN ACT

CREATING A BARANGAY IN THE MUNICIPALITY OF TANAY, PROVINCE OF RIZAL, TO BE KNOWN AS BARANGAY MADILAY-DILAY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 2	SECTION 1. Creation of Barangay Madilay-Dilay. – There is hereby created a barangay in the Municipality of Tanay, Province of Rizal, to be known as Barangay Madilay-Dilay.
3 4	SEC. 2. Territorial Boundaries. – The territorial boundaries of Barangay Madila-Dilay are hereby described as follows:
5 6	"Bounded on the Southeast, along lines 1-2 by CAD 720-D Sta. Maria Cadastre, Province of Laguna;
7 8	On the Northwest along lines 2, 3 and 4 by PLS 411-D (PORTION) Tanay Cadastre, Barangay Sampaloc, Municipality of Tanay, Province of Rizal;
9 10	On the Northwest, along lines 4, 5 and 6 by portion of GSS-1333-D and Portion of PLS 411-D, Barangay Daracatan, Municipality of Tanay, Province of Rizal;
11 12	On the Northeast, along lines 6-1 by portion of GSS-1333-D Tanay Cadastre, Municipality of Tanay, Province of Rizal;
13 14	Beginning at a point marked "1" on plan, being S. 64 degrees 23' E., 3,799.46 meters from Bureau of Land Management No. 28 Group Settlement Survey 1333-D, Tanay Cadastre;
15	Thence S. 71 degrees 39" W., 6,769.59 m to point 2;
16	Thence N. 05 degrees 06' E., 1,119.22 m to point 3;
17	Thence N. 13 degrees 07' E., 1,329.63 m to point 4;
18	Thence N. 60 degrees 16' E., 2,672.66 m to point 5;
19	Thence N. 65 degrees 13' E., 1,983.53 m to point 6;

3 4 5 6 7	SEC. 3. Conduct and Supervision of Plebiscite. – The plebiscite conducted and supervised by the Commission on Elections pursuant to Sangguniang Panlalawigan Ordinance No. 29, Series of 2017, which was duly ratified and proclaimed by the Plebiscite Board of Canvassers shall serve as substantial compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.
8 9 10	SEC. 4. Incumbent Barangay Officials. – The incumbent elected barangay officials of Barangay Madilay-Dilay shall continue to hold office until such time that their successors have been duly elected and qualified.
11 12 13	SEC. 5. Public Infrastructures and Facilities. – All public infrastructures and facilities existing therein at the time of the approval of this Act are hereby transferred without cost or compensation to and shall be administered by the new barangay.
14 15 16	SEC. 6. National Tax Allotment Shares. – Barangay Madilay-Dilay shall be entitled to National Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as amended.
17 18	SEC. 7. Repealing Clause. – All laws, decrees, executive orders, rules, regulations, which are inconsistent with this Act are hereby amended, repealed or modified accordingly.
19 20	SEC. 8. Effectivity. – This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
