### CONVERTING THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET INTO A COMPONENT CITY TO BE KNOWN AS THE CITY OF LA TRINIDAD

#### EXPLANATORY NOTE

The Municipality of La Trinidad is a first-class municipality in the Province of Benguet. It is composed of sixteen (16) barangays, the largest in the province, namely: Alapang, Alno, Ambiong, Bahong, Balili, Beckel, Betag, Bineng, Cruz, Lubas, Pico, Poblacion, Puguis, Shilan, Tawang, and Wangal. During the colonial era, La Trinidad is relatively the most developed settlement in the Benguet area as it served as the gateway from the Southern Lowlands in to the mountain region and the center of administration for colonizers. La Trinidad is well cultivated with rice, sweet potatoes, gabi, sugarcane by its original settlers.

La Trinidad is the Strawberry and Rosa Capital of the Philippines. On 18 March 2024, the municipality enters a larger Larger Giant Strawberry Cake into the Guinness Book of World Records. A year later, the record is confirmed with the title "Largest Fruit Shortcake". At present, La Trinidad is home to several higher learning institutions, a center for banking and finance, and an expanding area of socio-economic activities.

This bill seeks to convert the Municipality of La Trinidad into a component city of the Province of Benguet to be known as the City of La Trinidad. This will tap into the full economic potential of the Municipality of La Trinidad, Benguet, paving the way for additional development and services for the growing population.

#### AN ACT

#### CONVERTING THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET INTO A COMPONENT CITY TO BE KNOWN AS THE CITY OF LA TRINIDAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

 SECTION 1. Short Title. – This Act shall be known as the "Charter of the City of La Trinidad".

**SEC. 2.** *City of La Trinidad.* – The Municipality of La Trinidad is hereby converted into a component city to be known as the City of La Trinidad, hereinafter referred to as the City, which shall compromise of the present territory of the Municipality of La Trinidad in the province of Benguet.

La Trinidad is located 3 kilometers north of Baguio City and is 256 kilometers north of Manila. It is bounded on the north by the municipality of Tublay, on the south by the City of Baguio, on the west by Sablan and Tuba. Its geographical coordinates are 16°21" north latitude 120°35" east longitude.

The foregoing provision shall be without prejudice to the resolution of appropriate agency or forum of existing boundary disputes or cases involving questions of territorial jurisdiction between the Municipality of La Trinidad and the adjoining local government units. *Provided*, That the territorial jurisdiction of the disputed area or areas shall remain with the local government unit the fin al resolution of the case.

19 **SEC. 3.** *Corporate Powers of the City.* – The City constitutes a political body that 20 is corporate in nature and as such is endowed with the attributes of perpetual

succession and possessed the powers which pertain to a municipal corporation to be 1 exercised in conformity corporate powers: 2

- a. To have a continuous succession in its corporate name;
- b. To sue and be sued; 5
  - c. To have and use a corporate seal;
    - d. To acquire, hold and convey real or personal;
    - e. To enter into any contracts or agreements; and
  - f. To exercise such other powers, prerogatives or authority subject to the limitations provided under this Act or in existing laws.

SEC. 4. General Powers of the City. - The City shall have a common seal and 12 may alter the same at pleasure. Provided, That any change of corporate seal shall be 13 registered with the Department of Interior and Local Government (DILG). It shall 14 exercise the power to levy taxes; to close and open roads, streets, alleys, parks or 15 squares; to take, purchase, receive, hold lease, convey and dispose of real and personal 16 property for public use; to contract and be contracted with; to sue and be sued; to 17 prosecute and defend to final judgment and execution suits wherein the City is involved 18 or interested in and to exercise all powers as are granted to corporations or as 19 hereinafter conferred. 20

SEC. 5. Liability for Damages. - The City and its officials shall not be exempt from liability for death or injury to persons or damage to property. 23

SEC. 6. Jurisdiction of the City. - The jurisdiction of the City of La Trinidad for 25 police purposes only, shall be coextensive with its territorial jurisdiction and, for 26 purposes of protecting and ensuring the purity of water supply of the City, such police 27 jurisdiction shall also extend over all the territory within the drainage area of such water 28 supply, or within one hundred meters (100 m.) of any reservoir, conduit, canal, 29 aqueduct or pumping station used in connection with the city water service. 30

The regional trial courts and the city courts of the City of La Trinidad shall have 32 concurrent jurisdiction with the regional trial courts and the metropolitan trial courts or 33 city or municipal trial courts of the adjoining municipalities or cities to try crimes and 34 misdemeanors committed within said drainage area or within said spaces of one 35 hundred meters. 36

The court first taking cognizance of such an offense shall have jurisdiction to try 38 cases to the exclusion of others. The police forces of the municipalities and cities 39 concerned shall have concurrent jurisdiction with the police forces of the City for the 40 maintenance of good order and enforcement of ordinances throughout the said zone, 41 area or space shall be granted by the proper authorities of the city or municipality 42 concerned, and the fees arising therefrom shall accrue to the treasury of the said city 43 or municipality concerned and not the City. 44

c.During the incumbency of the City Mayor, he shall hold office in the city hall.

SEC. 9. The City Vice Mayor. - a. There shall be a City Vice Mayor who shall be elected in the same manner as the City Mayor and at the time of his election shall possess the same qualification as the City Mayor. The City Vice Mayor shall hold office for a term of three (3) years, unless sooner removed, and shall receive a monthly compensation corresponding Salary Grade Twenty-six (26) as prescribed under Republic Act No. 6758, otherwise known as the "Compensation and Position Classification Act of 1989", as amended, and the implementing guidelines issued pursuant thereto. 

- b. The City Vice Mayor Shall:
   1. Act as the presiding officer of the Sangguniang Panlungsod and sign all warrants drawn on the City Treasury for all expenditures appropriated for the operations of the Sangguniang Panlungsod;
- 2. Subject to civil service law, rules and regulations, appoint all officials and employees of the *Sangguniang Panlungsod*, except those who manner of appointment is specifically provided under the Local Government Code of 1991, as amended;
  - 3. Assume the office of the City Mayor for the unexpired term of the latter in the event of the permanent vacancy;
    - 4. Exercise the powers and perform the duties functions of the city Mayor in case of temporary vacancy; and
  - 5. Perform other duties and functions and exercise such other powers as provided for under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, as amended.

### CHAPTER IV THE SANGGUNIANG PANLUNGSOD

 43 SEC. 10. Composition. – a. The Sangguniang Panlungsod, the legislatives body
 44 of the City, shall be composed of the City Vice Mayor as presiding officer, the ten (10)

Sanggunian members, the President of the City Chapter of the Liga ng mga Barangay, 1 the President of the Panlungsod na Pederasyon ng mga Sangguniang Kabataan and 2 the three (3) sectoral representatives, who shall come from the following sectors, as 3 members; one (1) from the women sector; and, as shall be determined by the 4 Sangguniang Panlungsod within the ninety (90) days prior to the holding of local 5 elections; one (1) from the agricultural or industrial workers sector; and one (1) from 6 the other sectors, including urban poor, indigenous cultural communities or persons 7 with disabilities (PWDs). 8

b. The regular members of the *Sangguniang Panlungsod* and the Sectoral Representatives shall be elected in the manner as may be provided by law.

c. The members of the *Sangguniang Panlungsod* shall receive a minimum monthly compensation corresponding to Salary Grade Twenty-five (25) as prescribed under the "Compensation and Position Classification Act of 1989", as amended, and the implementing guidelines issued pursuant thereto.

**SEC. 11.** *Powers, Duties, Functions and Compensation.* – The *Sangguniang Panlungsod*, as a legislative body of the City, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the City and its inhabitants pursuant to Section 16 of the Local Government Code of 1991, as amended, and in the proper exercise of the corporate powers of the City as provided under Section 23 of the Local Government Code of 199, as amended and shall:

- a. Approve ordinances and pass resolutions necessary for an efficient and effective
  city government and in this connection shall:
- 1. Review all ordinances approved by the *Sangguniang Barangay* and Executive Orders issued by the *Punong Barangay* to determine whether these are within the scope of the prescribed powers of the *Sangguniang Barangay* and of the *Punong Barangay*;
  - 2. Maintain peace and order by enacting measure to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances;
- for the violation of said ordinances;
  Approve ordinances imposing a fine not exceeding five thousand pesos (P
  5,000.00) or an imprisonment for a period not exceeding one (1) year, or both
  at the discretion of the court, for violation of a city ordinance;
- 4. Adopt measure to protect the inhabitants of the City on the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events;
- 5. Enact ordinances intended to prevent, suppress and impose appropriate penalties for habitual drunkenness in public places, vagrancy, mendicancy, prostitution, establishment and maintenance of houses of ill repute, gambling and other prohibited games if chance, fraudulent devices and ways to obtain

money or property, drug addiction, maintenance of drug dens, drug pushing, juvenile delinquency, the printing or distribution or exhibition of obscene or pornographic materials or publications, and such other activities inimical to the welfare and morals of the inhabitants of the City;

**SEC. 16.** *Approval of Ordinances.* – a. Every ordinance enacted by the *Sangguniang Panlungsod* shall be presented to the City Mayor. If the City Mayor approves the same, the signature shall be affixed on each and every page thereof; otherwise, he shall veto it and return the same with his objections to the Sanggunian, which may proceed to reconsider the same. The Sanggunian may override the veto of the City Mayor by two-thirds (2/3) vote of all its members, thereby making the ordinance or resolution effective for all legal intents and purposes.

b. The veto shall be communicated by the City Mayor to the Sanggunian within ten (10) days, otherwise, the ordinance shall be deemed approved as if it had been.

SEC. 17. Veto Power of the City Mayor. – a. The City Mayor may veto any
 ordinance of the Sangguniang Panlungsod on the ground that it is ultra vires or
 prejudicial to the public welfare, stating his reasons thereof in writing.

b. The City Mayor shall have the power to veto any particular item or items of an appropriations ordinance, an ordinance or resolution adopting a local development plan, any public investment program or an ordinance directing the payment of money or creating liability. In such case, the vetoed item or items shall not affect the item or items which are not objected to. The vetoed item or items shall not take effect unless the Sangguniang Panlungsod overrides the veto in the manner herein provided; otherwise, the item or items in the appropriations ordinance of the previous year corresponding to those vetoed, if any, shall be deemed enacted.

- c. The City Mayor may veto an ordinance or resolution only once. The Sanggunian may override the veto of the City Mayor by two-thirds (2/3) vote of all its members, thereby making the ordinance effective without the approval of the City Mayor.

**SEC. 18**. *Review of City Ordinance by the Sangguniang Panlalawigan.* – (a) Within three (3) days after the approval, the Secretary to the *Sangguniang Panlungsod* shall forward to the Sangguniang Panlalawigan for review, copies of the approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils.

6) Within thirty (30) days after receipt of copies of such ordinances and resolutions, the *Sangguniang Panlalawigan* shall examine the documents or transmit them to the provincial attorney or provincial prosecutor for prompt examination. The provincial attorney or the provincial prosecutor shall, within a period of ten (10) days from receipt of the documents, inform the Sangguniang Panlalawigan in writing of his comments and recommendations., which may be considered by the Sangguniang Panlalawigan in making its decision.

(d) If no action has been taken by the *Sangguniang Panlalawigan* within thirty
(30) days after submission of such an ordinance or resolution, the same shall be
presumed consistent with law and therefor valid.

SEC. 19. Review of Barangay Ordinances by the Sangguniang Panlungsod. –
 (a) Within ten (10) days after its enactment, the Sangguniang Barangay shall furnish
 copies of all barangay ordinances to the Sangguniang Panlungsod for review as to
 whether the ordinances are consistent with law or city ordinances.

(b) If the *Sangguniang Panlungsod* fails to take action on barangay ordinances
within thirty (30) days from receipt thereof, the same shall be deemed approved.

(c) If the *Sangguniang Panlungsod* finds a barangay ordinance inconsistent with law or city ordinances, the *Sangguniang Panlungsod* shall, within thirty (30) days from receipt thereof, return the same with its comments and recommendations to the Sangguniang Barangay concerned for adjustment, amendment or modification; in which case, the effectivity of the barangay ordinance is suspended until such time as the revision called for is effected.

**SEC. 20.** *Enforcement of Disapproved Ordinances or Resolutions.* – Any attempt to enforce any ordinance or any resolution approving the local development plan and public investment program, after the disapproval thereof, shall be sufficient ground for the suspension or dismissal of the official or employee concerned.

SEC. 21. Effectivity of Ordinances or Resolutions. - (a) Unless otherwise stated 1 in the ordinance or the resolution approving the local development plan and public 2 investment program, the same shall take effect after ten (10) days from the date a 3 copy thereof is posted in a bulletin board at the entrance of the city hall of La Trinidad, 4 and in at least two (2) other conspicuous places in the City of La Trinidad not later than 5 five (5) days after approval thereof. 6

15 (c) The main feature of the ordinance or resolution duly enacted or adopted 16 shall, in addition to being posted, be published once in a local newspaper of general 17 circulation within the City: Provided, That in the absence thereof, the ordinance or 18 resolution shall be published in any newspaper or general circulation: Provided, further, 19 That the gist of all ordinances with penal sanctions shall also be published in a 20 newspaper of general circulation. 21

### **CHAPTER VI** DISQUALIFICATION AND SUCCESSION FOR **ELECTIVE CITY OFFICIALS**

SEC. 22. Disqualifications for Elective Public City Officials. -- The following persons are not qualified from running for any elective position in the City:

- a. Those sentenced by final judgment for an offense involving moral turpitude or an offense punishable by one (1) year or more of imprisonment within two (2) years after serving the sentence;
  - b. Those removed from office as a result of an administrative case;
  - c. Those convicted by final judgment for violating the oath of allegiance to the Republic of the Philippines;
- d. Those with dual citizenship;
  - e. Fugitives from justice in criminal or nonpolitical cases here and abroad:
  - f. Permanent residents in a foreign country or those who have acquired the right to reside abroad and continue to avail of the same right after the effectivity of the Local Government Code of 199, as amended; and
    - g. The insane and feeble-minded.

SEC. 23. Permanent Vacancy in the Office of the City Mayor and City Vice Mayor. 1 - (a) If a permanent vacancy occurs in the office of the City Mayor, the City Vice Mayor 2 concerned shall become the City Mayor. If a permanent vacancy occurs in the office of 3 the City Vice Mayor, the highest ranking Sangguniang Panlungsod member or, in a case 4 of his or her permanent incapacity, the second highest ranking Sangguniang 5 Panlungsod member becomes the City Mayor or the City Vice Mayor, as the case may 6 be. Subsequent vacancies in the said offices shall be filled automatically by the other 7 Sanggunian members according to their ranking as defined herein 8

(b) If a permanent vacancy occurs in the office of the Punong Barangay, the highest ranking Sangguniang Barangay member or, in case of his or her permanent incapacity, the second highest ranking *Sanggunian* member shall become the Punong Barangay.

(c) A tie between or among the highest ranking *Sangguniang Panlungsod* members shall be resolved by drawing of lots.

(d) The successor as defined herein shall serve only the unexpired terms of their
 predecessors.

(e) For purposes of this Act, a permanent vacancy arises when an elective local
official fills a higher vacant office, refuses to assume office, fails to qualify, dies, is
removed from office, voluntarily resigns or is otherwise permanently incapacitated to
discharge the functions of his or her office.

(f) For purposes of succession as provided in this Act, ranking in the *Sanggunian* shall be determined on the basis of proportion of votes obtained by each winning candidate to the total number of registered voters in the City immediately preceding local election.

 31 SEC. 24. Permanent Vacancies in the Sanggunian Panlungsod. – Permanent
 32 vacancies in the Sangguniang Panlungsod where automatic succession as provided

Temporary Vacancy in the Office of the City Mayor. - (a) When the 12 City Mayor is temporarily incapacitated to perform his duties for physical or legal 13 reasons, including leave of absence, travel abroad and suspension from office, the City 14 Vice Mayor of the highest ranking Sangguniang Panlungsod member shall automatically 15 exercise the powers and perform the duties and functions of the City Mayor, except the 16 power to appoint, suspend, or dismiss employees which only be exercised if the period 17 of temporary incapacity exceeds thirty (30) working days. 18

(10) Take custody of the local archives and where applicable, the local library and annually account for the same; and

(11) Perform other duties and function and exercise such other powers as provided under the Local Government Code of 1991, as amended, and those that are prescribed by law or ordinance.
