AN ACT

GRANTING FULL INSURANCE COVERAGE TO ALL QUALIFIED AGRARIAN REFORM BENEFICIARIES OF THE COMPREHENSIVE AGRARIAN REFORM PROGRAM, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 6657, AS AMENDED BY REPUBLIC ACT NO. 9700, OTHERWISE KNOWN AS THE "COMPREHENSIVE AGRARIAN REFORM LAW OF 1988"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 37 of Republic Act No. 6657, as amended, is hereby further 2 amended to read as follows:

2.14

"SEC. 37. Support Services for the Agrarian Reform Beneficiaries. – The State shall adopt the integrated policy of support services delivery to agrarian reform beneficiaries. To this end, the DAR, the Department of Finance, and the *Bangko Sentral ng Pilipinas* shall institute reforms to liberalize access to credit by agrarian reform beneficiaries. The PARC shall ensure that support services for agrarian reform beneficiaries are provided, such as:

- "(e) x x x; [and]
 - "(f) xxx

"The Bagong Kilusang Kabuhayan sa Kaunlaran (BKKK) Secretariat shall be transferred and attached to the LBP, for its supervision including all its applicable and existing funds, personnel, properties, equipment and records. [.]; AND

"(G) FULL INSURANCE COVERAGE FOR COMPENSABLE LOSSES TO ALL QUALIFIED AGRARIAN REFORM BENEFICIARIES, WHO ARE ACTUALLY TILLING THE LAND.

27THE DAR SHALL PROVIDE THE PROCEDURES FOR SUCH28REGISTRATION AND CERTIFICATION OF ACTUAL BENEFICIARIES29AND FARMING INVESTMENTS AND PROJECTS UNDERTAKEN BY30SUCH. FOR PURPOSES OF THIS SECTION, "QUALIFIED AGRARIAN31REFORM BENEFICIARIES" SHALL BE AS DEFINED IN SECTION 3(b)32OF REPUBLIC ACT NO. 10000, OTHERWISE KNOWN AS THE "AGRI-33AGRA REFORM CREDIT ACT OF 2009".

- COMPENSABLE LOSSES INCLUDE THOSE RESULTING FROM:
- i. NATURAL CALAMITIES SUCH AS TYPHOON, FLOOD, DROUGHT, EARTHQUAKE, VOLCANIC ERUPTION, FROST, AND OTHER DESTRUCTIVE NATURAL PHENOMENA SUCH AS HEAT AND HOT WIND;
 - ii. PLANT DISEASES CAUSED BY PATHOGENS, BACTERIA, FUNGI, VIRUSES, VIRUS-LIKE PATHOGENS, AND OTHER SIMILAR FOREIGN BODIES;

1 iii. PEST INFESTATIONS CAUSED BY NEMATODES. 2 INSECTS, MITES AND SPIDERS, MILLIPEDES AND 3 CENTIPEDES, SYMPHYLANS, SLUGS AND SNAILS, 4 SOW BUGS AND PILLBUGS, PARASITIC HIGHER 5 PLANTS, AND OTHER PARASITES; AND 6 7 iv. LOSS OF LIFE OR INJURY TO THE QUALIFIED 8 AGRARIAN REFORM BENEFICIARY DUE TO ACCIDENT 9 OR ANY OF THE AFOREMENTIONED CAUSES. 10 "THE FOLLOWING CROPS AND OTHER FARMING AND FISHERY 11 12 **PRODUCE ARE COVERED:** 13 14 **i**. PALAY, CORN, SUGARCANE, HIGH-VALUE CROPS AS 15 DEFINED IN SECTION 4(b) of REPUBLIC ACT NO. 7900, 16 OTHERWISE KNOWN AS THE 'HIGH-VALUE CROPS 17 DEVELOPMENT ACT OF 1995', COCONUT, TOBACCO; 18 19 ij, **CROPS OR STOCKS IN FISHERIES FARMS:** 20 İİİ. LIVESTOCK; AND 22 iv. NON-CROP AGRICULTURAL ASSETS USED IN ACTUAL 24 FARMING AND REPORTED TO AND CERTIFIED BY THE DAR. 26 27 "Misuse or diversion of the financial and support services herein provided 28 shall result in sanctions against the beneficiary guilty thereof, including the 29 forfeiture of the land transferred to him/her or lesser sanctions as may be provided by the PARC, without prejudice to criminal prosecution. 30 32 **"THE SECRETARY OF THE DA AND THE SECRETARY OF THE DAR** 33 SHALL IMMEDIATELY INCLUDE IN THEIR DEPARTMENTS' 34 PROGRAMS THE OPERATIONALIZATION OF THIS INSURANCE 35 COVERAGE, THE INITIAL FUNDING FOR WHICH SHALL BE 36 CHARGED AGAINST THE CURRENT APPROPRIATIONS OF THE 37 PHILIPPINE CROP INSURANCE CORPORATION (PCIC) FOR THE 38 **REGISTERED BENEFICIARIES UNDER THE RSBSA. THEREAFTER.** 39 PROJECTIONS OF THE ANNUAL PREMIUM REQUIREMENT SHALL **4**0 BE SUBMITTED BY THE PCIC AND THE DAR TO THE PRESIDENT 41 WHO SHALL INCLUDE IN THE ANNUAL **GENERAL** 42 APPROPRIATIONS ACT THE NECESSARY BUDGET FOR THE INSURANCE COVERAGE MANDATED IN THIS ACT: PROVIDED. 43

THAT IN CASE OF INSUFFICIENCY OF THE INITIAL FUND TO COVER

ALL QUALIFIED ARBS AND LEASEHOLDERS. COVERAGE SHALL

BE PRIORITIZED IN THE FOLLOWING MANNER: FIFTY PERCENT

1 (50%) TO THOSE NEWLY INSTALLED AND QUALIFIED ARBS WITH 2 **ISSUED CERTIFICATE OF LANDOWNERSHIP AWARDS (CLOAs) OR** 3 LEASEHOLD INSTRUMENTS. IN DESCENDING CHRONOLOGICAL 4 ORDER; AND THE REMAINING FIFTY PERCENT (50%) TO THOSE 5 EARLIEST INSTALLED AND QUALIFIED ARBs WITH ISSUED 6 **EMANCIPATION** PATENTS 1 **CLOAs** OR LEASEHOLD 7 INSTRUMENTS. IN ASCENDING **CHRONOLOGICAL ORDER:** 8 PROVIDED FURTHER, THAT ADDITIONAL QUALIFIED ARBs AND 9 LEASEHOLDERS SHALL BE COVERED YEARLY BASED ON 10 ANNUAL PROJECTIONS. AND IN THE SAME MANNER AS 11 PROVIDED, UNTIL SUCH TIME THAT ALL QUALIFIED ARBS AND 12 LEASEHOLDERS ARE COVERED UNDER THIS ACT. 13

14 "FURTHER. A CONGRESSIONAL OVERSIGHT COMMITTEE FOR THE 15 FULL **INSURANCE** COVERAGE OF AGRARIAN REFORM 16 BENEFICIARIES (COCFICARB) IS HEREBY CREATED. IT SHALL BE 17 COMPOSED OF THE CHAIRPERSON OF THE COMMITTEE ON 18 AGRARIAN REFORM OF THE HOUSE OF REPRESENTATIVES AND THE CHAIRPERSON OF THE COMMITTEE ON AGRICULTURE, FOOD 19 20 AND AGRARIAN REFORM OF THE SENATE OF THE PHILIPPINES, 21 THREE (3) MEMBERS OF THE HOUSE OF REPRESENTATIVES, AND 22 THREE (3) MEMBERS OF THE SENATE OF THE PHILIPPINES, TO BE 23 DESIGNATED RESPECTIVELY BY THE SPEAKER OF THE HOUSE OF 24 **REPRESENTATIVES AND THE PRESIDENT OF THE SENATE OF THE** 25 PHILIPPINES."

SEC. 2. Within thirty (30) days from the effectivity of this Act, the DAR, shall, in coordination with the Land Bank of the Philippines submit to the Department of Agriculture (DA), the complete list of qualified ARBs and leaseholders to be included in the Registry System for Basic Sectors in Agriculture (RSBSA), their respective locations, and size of landholdings.

SEC. 3. Within thirty (30) days from the approval of this Act, the DAR, shall, in coordination
with the DA, PCIC, and Department of Budget and Management, issue the rules and
regulations for the effective implementation of this Act.

36 **SEC. 4.** All laws, acts, decrees, executive orders, issuances, and rules and regulations 37 or parts thereof which are contrary to and inconsistent with this Act are hereby repealed, 38 amended, or modified accordingly.
