(a) "Adaptive reuse" shall refer to the utilization of buildings, other built 1 f-1 structures, and sites of value for purposes other than THOSE [that] 2 3 for which they were **ORIGINALLY** intended [originally], in order to conserve the site, their engineering integrity and authenticity of design. 4 (b) "Anthropological area" shall refer to any **LOCATION** [place] where 5 studies of specific ethnolinguistic groups are undertaken [, the] AND 6 7 WHOSE properties CONTRIBUTE [of which are of value] to THE [our] **NATION'S** cultural heritage. 8 (c) "Antique" shall refer to a cultural property found locally which is AT 9 10 **LEAST** one hundred (100) years **OLD**, [in age, more or less,] the production of which has ceased. 11 12 (d) "Archaeological area" shall refer to any place [, whether above or underground, underwater or at sea level, containing fossils, artifacts, 13 and other cultural, geological, botanical, AND zoological materials THAT 14 [which] depict and document culturally relevant paleontological, 15 16 prehistoric, and/or historic events ... WHETHER ABOVE OR BELOWGROUND, UNDERWATER, OR AT SEA LEVEL. 17 (e) "Archives" shall refer to public and private records in any format 18 **THAT** [which] have been selected for permanent preservation because 19 of their evidential, historical, AND informational value; ALSO 20 [otherwise] known as archival materials collections or archival holdings; 21 **A [the]** place (building/room/storage area) where archival materials are 22

kept and preserved; **OR** [and] an organization or agency, **ALSO KNOWN AS ARCHIVAL AGENCY**, or part thereof whose **PRIMARY**[main] responsibility is to appraise, arrange, describe, conserve, promote, and make archival materials available for reference and research [, also known as archival agency].

- (f) "Built heritage" shall refer to architectural and engineering structures such as, but not limited to, bridges, government buildings, houses of ancestry, traditional dwellings, **QUARTERS** [quartels], train stations, lighthouses, small ports, educational, technological, and industrial complexes, and their settings [7] and landscapes with notable historical and cultural significance. THE **PROTECTION OF** THESE **STRUCTURES MUST ALSO TAKE** INTO **ACCOUNT** MAINTENANCE OF THE INTEGRITY OF THEIR VISUAL **CORRIDOR AND/OR LINE OF SIGHT.**
- (g) "Collector" shall refer to any person who or institution that acquires cultural property for purposes other than sale.
- (h) "Commission" shall refer to the National Commission for Culture and the Arts (NCCA).
- (i) "Conservation" shall refer to all [the] processes and measures FOR [of] maintaining the cultural significance of a cultural property, including, but not limited to, preservation, restoration, reconstruction, protection, adaptation, or any combination thereof.

1	(j) "Cultural agencies" shall refer to the following national government
2	agencies with their specific areas of responsibility: National Museum <b>OF</b>
3	THE PHILIPPINES (cultural property); [the] National Library OF THE

**(P)** "Cultural property" shall refer to all products of human creativity by which a people and a nation reveal their identity, including churches, mosques and other places of religious worship, schools and natural history specimens and sites, whether **OWNED PUBLICLY** [public] or privately [-owned], movable or immovable, **OR** [and] tangible or intangible.

**E(p)** (**Q)** "Dealers" shall refer to natural or juridical persons who acquire cultural property for the purpose of engaging in the acquisition and disposition of the same.

- (R) 'GABALDON SCHOOL BUILDINGS" SHALL REFER TO SCHOOL BUILDINGS DESIGNED BY AMERICAN ARCHITECT WILLIAM PARSONS AND FUNDED THROUGH ACT NO. 1801 AUTHORED BY ASSEMBLYMAN ISAURO GABALDON.
- (S) 'HERITAGE HOUSES" SHALL REFER TO HOUSES OF ANCESTRY OF NOTABLE HISTORICAL, CULTURAL, SOCIAL, ARCHITECTURAL, AND ARTISTIC VALUE AND SIGNIFICANCE,

1	AS DECLARED BY THE NATIONAL HISTORICAL COMMISSION OF
2	THE PHILIPPINES.
3	{(q)} (T) "Heritage zone" shall refer to historical, anthropological,
4	archaeological, AND artistic geographical areas and settings that are
5	culturally significant to the NATION [country], as declared by the

7	[Institute] COMMISSION OF THE PHILIPPINES.

23	or structures hallowed and revered for their history or association, as

[(v)] (Z) "Historical street name" shall refer to a street name **THAT** [which] has been in existence for at least fifty (50) years and [over time] has **BECOME** [been considered] historic **OVER TIME**.

[(w)] (AA) "Important cultural property" shall refer to a cultural property THAT HAS [having] exceptional cultural, artistic, and historical significance to the Philippines, as RECOGNIZED [shall be determined] by the National Museum OF THE PHILIPPINES [-] and/or THE National Historical [Institute] COMMISSION OF THE PHILIPPINES.

**{(x)} (BB)** "Intangible cultural heritage" shall refer to the practices, representations, expressions, knowledge, and skills, as well as the instruments, objects and artifacts associated therewith, that communities, groups, and individuals recognize as part of their cultural heritage, such as: (1) oral traditions, languages, and expressions; (2) performing arts; (3) social practices, rituals, and festive events; (4) knowledge and practices concerning nature and the universe; and (5) traditional craftsmanship.

**E(y)** (CC) "Intangible cultural property" shall refer to [the] peoples' learned processes, along with the knowledge, skills, and creativity that inform and are developed by them, the products they create, and the

resources, spaces, and other aspects of social and natural context **THAT**ARE necessary for their sustainability.

**{(z)} (DD)** "Library" shall refer to an institution where the collection of books, manuscripts, computerized information, and other materials **IS** [are] organized to provide physical, bibliographic, and/or intellectual access to the public, with a librarian **WHO** [that] is trained to provide services and programs related to the information needs of its clientele.

[(aa)] (EE) "Museum" shall refer to a permanent institution that researches, acquires, PRESERVES [conserves], communicates, and exhibits [the] material evidence of humans and their environment for EDUCATIONAL AND RECREATIONAL purposes [of education or leisure].

**[(bb)] (FF)** "National cultural treasure" shall refer to a unique cultural property found locally [7] possessing outstanding historical, cultural, artistic, and/or scientific value, [which] is highly significant and important to the country and nation, and **HAS BEEN** officially declared as such by **THE** pertinent cultural agency.

**[(cc)] (GG)** "Nationally significant" shall refer to historical, aesthetic, scientific, technical, social, and/or spiritual values that unify the nation by a deep sense of pride in their **DIVERSE** [various] yet common identities, cultural heritage, and national patrimony.

{(dd)} (HH) "Natural property of cultural significance" shall refer to Tareas possessing outstanding ecosystem with flora and fauna of national scientific importance under 1 NATURAL HERITAGE WITH SIGNIFICANCE FOR ITS TANGIBLE OR INTANGIBLE CULTURAL HERITAGE, WHETHER OR NOT COVERED BY the National Protected System **ACT** Integrated Areas OR BY **ENVIRONMENTAL LAWS.** 

(II) "NATURAL HERITAGE" SHALL REFER TO FLORA AND FAUNA, PHYSICAL, GEOLOGICAL, AND PHYSIOGRAPHICAL FORMATIONS OF THE ENVIRONMENT, WHETHER TERRESTRIAL, WETLAND, OR MARINE, AND THE ECOSYSTEM WITH WHICH PARTICULAR COMMUNITIES HAVE HAD LONGTERM RELATIONSHIPS.

[(ee)] (JJ) "NCCA Portal Cultural Databank" SHALL refer[s] to the specific domain in the Commission's [intranet for cultural information that is accessed only internally with control and confidentiality] ONLINE DATABASE WHERE DIGITIZED CULTURAL MAPS ARE LODGED FOR PUBLIC INFORMATION, SCIENTIFIC RESEARCH, AND ACADEMIC PURPOSES. It includes the registry of national cultural property.

(KK) "PHILIPPINE CULTURAL STATISTICS FRAMEWORK"

SHALL REFER TO THE CONCEPTUAL MODEL ADOPTED JOINTLY

BY THE COMMISSION AND THE PHILIPPINE STATISTICS

AUTHORITY FOR DEFINING CULTURE FOR STATISTICAL PURPOSES. IT IS A TOOL FOR ORGANIZING NATIONALLY AND INTERNATIONALLY COLLECTED CULTURAL STATISTICS IN ORDER TO SUPPORT THE DEVELOPMENT OF DATA COLLECTION INSTRUMENTS AND INDICATORS AND OF A METHOD FOR PRODUCING HARMONIZED DATA AND INDICATORS.

(MM) "RECONSTRUCTION" SHALL REFER TO RETURNING A CULTURAL PROPERTY, OR A PORTION THEREOF, TO A KNOWN EARLIER STATE BY ADDING NEW MATERIALS, FORMS, METHODOLOGIES, AND TECHNOLOGY. All cultural properties declared as important cultural property may also receive government funding for **THEIR** [its] protection, conservation, and restoration. An official heritage marker shall likewise be placed on an immovable cultural property to identify the same as important cultural property.

  THE COMMISSION SHALL PROVIDE LGUS WITH TECHNICAL ASSISTANCE FOR THE INVENTORY AND UPDATING OF LOCALLY AND NATIONALLY DECLARED CULTURAL PROPERTIES AND TANGIBLE AND INTANGIBLE HERITAGE;
- (d) All government agencies and instrumentalities, government-owned and/or -controlled corporations and their subsidiaries, including public and private educational institutions, shall report their ownership and/or possession of such items to the pertinent cultural agency and shall register such properties within three (3) years from the effectivity of this Act; **AND**
- (e) Private collectors and owners of cultural property shall register such properties within three (3) years from the effectivity of this Act. The private collectors and owners of cultural property shall not be divested

of their possession and ownership thereof even after registration of said property as herein required.

Information on registered cultural properties owned by private individuals shall remain confidential and may be given only upon prior consent of the private owner. The Commission shall operate the Registry in the NCCA portal cultural databank.

THE INCLUSION IN THE REGISTRY OF CULTURAL PROPERTIES BELONGING TO THE INDIGENOUS CULTURAL COMMUNITIES OR INDIGENOUS PEOPLES SHALL BE SUBJECT TO PRIOR CONSULTATION WITH THEM AND TO THEIR FREE, AND PRIOR INFORMED CONSENT AS PROVIDED IN SECTION 15-B OF THIS ACT."

SEC. 7. A new Section 15-A under Article V of RA 10066 is hereby inserted to read as follows:

"SEC. 15-A. CULTURAL MAPPING BY LOCAL GOVERNMENT UNITS. - LOCAL GOVERNMENT UNITS ARE HEREBY MANDATED TO CONDUCT A COMPREHENSIVE CULTURAL MAPPING OF THEIR AREAS OF JURISDICTION. THEY SHALL MOBILIZE AND ESTABLISH PARTNERSHIPS WITH CONCERNED GOVERNMENT AGENCIES TO ENSURE THE PROMPT AND EFFECTIVE IMPLEMENTATION OF THE PROVISION OF THIS ACT. - (c) The National Parks Development Committee as an attached agency of the Department of Tourism, which shall be responsible **FOR [in]** supervising the development (beautification, preservation, and maintenance) of the Quezon Memorial, Fort Santiago, Luneta, Paco Park, Pook ni Maria Makiling and other national parks and satellite projects;

- (d) The Department of Education, which shall be responsible FOR IMPLEMENTING THE BASIC EDUCATION ACT [in instituting the governance of basic education act] and the conservation and restoration of its built heritage, INCLUDING [such as] the significant Gabaldon school buildings as [determined by the National Historical Institute] GOVERNED BY THE PROVISIONS UNDER THE GABALDON SCHOOL BUILDING CONSERVATION ACT;
- (e) The Department of Public Works and Highways, which shall be responsible **FOR** [in] undertaking major infrastructure projects specifically in the planning, design, construction, and maintenance of national roads and bridges as they impact on heritage structures or aspects of heritage conservation;

# (M) THE DEPARTMENT OF FOREIGN AFFAIRS, WHICH SHALL BE RESPONSIBLE FOR THE OPERATIONALIZATION OF SENTRO RIZAL OVERSEAS BRANCHES AS PART OF THEIR CULTURAL DIPLOMACY PROGRAM."

Sec.12. *Appropriations.* - The amount necessary for the implementation of this Act shall be charged against the current appropriations of the NCCA and other implementing partner agencies. Thereafter, the amount necessary for its continued implementation shall be included in the budgetary allocation of NCCA and other implementing partner agencies.

Sec.13. Joint Congressional Oversight Committee. — There is hereby created a Joint Congressional Committee (JCOC) to oversee, monitor, and evaluate the implementation of this act. The JCOC shall be composed of five (5) members each from the Senate and the House of Representatives, with the Chairpersons of the Senate Committee on Culture and the Arts and House Committee on Basic Education and Culture serving as Co-Chairpersons. The Senate President and the Speaker of the House of Representatives shall designate the other four (4) members of the Joint Congressional Oversight Committee from among the members of the Senate Committee on Culture and the Arts and House Committee on Basic Education, respectively, one (1) member of which shall be from the minority.

Sec. 14. *Implementing Rules and Regulations.* – Within sixty (60) days from the effectivity of this Act, the Commission shall, in coordination with concerned agencies of the government, promulgate the necessary rules and regulations for the proper implementation of this Act.

Sec. 15. *Separability Clause.* – Any portion or provision of this Act that may be declared unconstitutional shall not have the effect of nullifying other portions or provisions hereof as long as such remaining provisions can still subsist and be given effect.

Sec. 16. *Repealing Clause.* – All other laws, presidential decrees, executive orders, and rules and regulations inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

Sec. 17. *Effectivity.* - This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
