AN ACT
CONVERTING THE CEBU TECHNOLOGICAL UNIVERSITY INTO A
UNIVERSITY SYSTEM TO BE KNOWN AS THE CEBU TECHNOLOGICAL
UNIVERSITY SYSTEM, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. Declaration of Policy.** – It is the policy of the State to give priority to
2 education, foster patriotism and nationalism, accelerate the development of human capital,
3 and protect the rights of its citizens to accessible quality education. To this end, the State
4 shall strengthen higher educational institutions, especially the state colleges and universities
5 in the countryside.

6
7 **SEC. 2. Conversion.** – The Cebu Technological University (CTU) in Cebu City,
8 including all its constituent units and regular and extension campuses, is converted into a
9 university system to be known as the Cebu Technological University (CTU) System,
10 hereinafter referred to as the CTU System.

11
12 **SEC. 3. University System.** – As a university system, the CTU System shall be
13 composed of constituent units established solely by its Board of Regents upon the
14 recommendation of the President of the CTU, to be collectively known as the CTU System
15 Constituent Units.

16
17 The existing constituent units, namely the Cebu Technological University-Metro
18 Cebu, the Cebu Technological University-North Cebu, and the Cebu Technological
19 University-South Cebu, as well as all the campuses under each constituent unit, shall
20 comprise the CTU System.

1 **SEC. 4. General Mandate.** – The CTU System shall primarily offer higher and
2 advance professional and technical instruction and training in technology, engineering,
3 mathematics, education, industrial programs, agriculture, fisheries, forestry, veterinary
4 medicine, medical and natural sciences, aeronautics and space programs, land-based
5 programs, information technology, digital programs, arts, humanities, and sciences, public
6 administration, business, management and allied fields, online courses, nontraditional
7 courses, applied arts and sciences and other relevant fields of study. As a university system,
8 it shall promote advance instruction, research, extension, production, and resource
9 generation in line with the latest science technology and industrial revolution and shall
10 provide progressive leadership in its areas of specialization.

11 **SEC. 5. The Board of Regents.** – The governing body of the CTU System shall be
12 the Board of Regents, hereinafter referred to as the Board, which shall be chaired and co-
13 chaired by the Chairperson of the Commission on Higher Education (CHED) and the
14 President of the CTU System, respectively, and with the following, as members:

- 15
16
17 a. Chairperson of the Committee on Higher, Technical and Vocational Education of the
18 Senate;
19 b. Chairperson of the Committee on Higher and Technical Education of the House of
20 Representatives;
21 c. Regional Director of the National Economic and Development Authority;
22 d. Regional Director of the Department of Science and Technology;
23 e. President of the federation of faculty associations of the CTU System;
24 f. President of the federation of student councils of the CTU System;
25 g. President of the federation of alumni associations of the CTU System;
26 h. Representative of the nonteaching or personnel association of the CTU System; and
27 i. Two (2) prominent citizens from the private sector who have distinguished themselves in
28 their professions or fields of specialization.

29
30 The Board shall appoint two (2) prominent citizens who shall be selected from a list
31 of at least five (5) qualified persons from the Province of Cebu, as recommended by a search
32 committee constituted by the President of the CTU System, in consultation with the
33 Chairperson of the CHED and other members of the Board, based on the guidelines on
34 qualification standards for the position set by the Board. They shall serve for a term of two
35 (2) years from the date of appointment.

36
37 The President of the federation of faculty associations, the President of the federation
38 of student councils, the President of the federation of alumni associations, and the
39 Representative of the non-teaching personnel shall serve contemporaneously in the Board
40 and their terms of office as provided under their respective associations' constitutions and
41 bylaws.

42
43 In case of vacancy among appointive positions in the Board, the vacancy shall be
44 filled by the Board following guidelines set by it, and the appointee shall hold office only
45 for the unexpired portion of the term.

46
47 **SEC. 6. Powers and Duties of the Board.** – In addition to its general powers of
48 administration and the powers granted to the board of directors of a corporation under
49 existing laws, the Board shall have the following specific powers and duties:

- 1 a. Promulgate and implement policies in accordance with the declared State policies on
2 education, other pertinent provisions of the Constitution on education, agriculture, science
3 and technology, and the policies, standards and thrusts of the CHED under Republic Act No.
4 7722, otherwise known as the "Higher Education Act of 1994";
5
- 6 b. Approve the curricula, instructional programs, and rules on student discipline drawn by
7 the Administrative and Academic Councils as herein provided;
8
- 9 c. Appoint, upon the recommendation of the President of the CTU System, the vice
10 presidents, chancellors, deans, directors, heads of the campuses, faculty members, and other
11 officials and employees of the CTU System;
12
- 13 d. Fix and adjust the salaries of faculty members, administrative officials and employees,
14 subject to the provisions of the Revised Compensation and Position Classification System
15 and other pertinent budget and compensation laws governing hours of service, and such other
16 duties and conditions as it may deem proper; grant them, at its discretion, leaves of absence
17 under such regulations as it may promulgate, any provision of existing law to the contrary
18 notwithstanding; and remove them for cause in accordance with the requirements of due
19 process of law;
20
- 21 e. Hear and decide administrative cases or matters brought before it on appeal from the
22 Office of the President involving CTU officials and employees, in accordance with the Civil
23 Service Commission (CSC) Rules on Administrative Cases;
24
- 25 f. Fix the tuition fees and other necessary school charges, such as matriculation fees,
26 graduation fees and laboratory fees, as the Board may deem proper to impose, after due
27 consultation with the concerned sectors. The fees and charges, including government
28 subsidies and other income generated by the CTU System, shall constitute its special trust
29 funds, and shall be deposited in any authorized government depository bank. All interests
30 that shall accrue therefrom shall form part of the same funds for the use of the CTU System;
31
- 32 Any provision of existing law, rule or regulation to the contrary notwithstanding, any
33 income generated by the CTU System from tuition fees and other charges, as well as from
34 the operation of auxiliary services and land grants, shall be retained by the CTU System and
35 may be disbursed by the Board for instruction, research, extension services or other programs
36 or projects of the CTU System: *Provided*, That all fiduciary fees shall be disbursed for the
37 specific purposes for which these are collected: *Provided, however*, That if, for reasons
38 beyond its control, the CTU System shall not be able to pursue any project for which the
39 funds have been appropriated and allocated under its approved program of expenditures, the
40 Board may authorize the use of said funds for any reasonable purpose which, in its discretion,
41 may be necessary and urgent for the attainment of the objectives and goals of the CTU
42 System;
43
- 44 g. Adopt and implement a socialized scheme of tuition and other school fees for greater
45 access of poor but deserving students in accordance with Republic Act No. 10931, otherwise
46 known as the "Universal Access to Quality Tertiary Education Act";
47
- 48 h. Establish professorial chairs in the CTU System and provide fellowships for qualified
49 faculty members, and scholarships to deserving students;

- 1 i. Receive and appropriate sums as may be provided for by law for the support of the CTU
2 System, and all other sums in the manner it may, in its discretion, determine to carry out the
3 purposes and functions of the CTU System;
4
- 5 j. Set the policies on admission and graduation of students;
6
- 7 k. Award honorary degrees upon persons in recognition of their outstanding contributions in
8 the fields of education, public service, arts, science and technology, sports and human
9 kinetics or any field of specialization within the academic competency of the CTU System,
10 and authorize the awarding of certificates of completion of non-degree and nontraditional
11 courses;
12
- 13 l. Develop academic arrangements for institutional capability building with appropriate
14 institutions and agencies, whether public, private, local or foreign, and appoint experts or
15 specialists as consultants, part-time, visiting or exchange professors, scholars or researchers,
16 as the case may be;
17
- 18 m. Adopt modern and innovative modes of transmitting knowledge to allow greater access
19 to education such as the use of information technology, online programs, the dual training
20 system, open distance learning, and community laboratory;
21
- 22 n. Absorb non-chartered tertiary institutions within the province of Cebu and Region VII as
23 branches, extension or external centers, in coordination with the CHED and in consultation
24 with the Department of Budget and Management (DBM), and offer therein programs or
25 courses to carry out the constitutional mandate of providing equal access to educational
26 opportunities;
27
- 28 o. Authorize an external management audit of the CTU System, to be financed by the CHED,
29 subject to the rules and regulations of the Commission on Audit (COA), and institute reforms,
30 including academic and structural changes, on the basis of the audit results and
31 recommendations;
32
- 33 p. Create, organize, reorganize, merge or abolish regular and extension campuses, colleges,
34 institutes, and other academic and administrative units of the CTU System;
35
- 36 q. Develop consortia and other economic forms of linkages with local government units
37 (LGUs), as well as public, private, local or foreign institutions and agencies for the
38 furtherance of the purposes and objectives of the CTU System;
39
- 40 r. Import economic, technical and cultural books and publications;
41
- 42 s. Enter into joint ventures with business industry for the profitable growth and management
43 of economic assets, the proceeds of which shall be used for the development and
44 strengthening of the CTU System;
45
- 46 t. Receive, in trust, legacies, gifts and donations of real and personal properties of all kinds
47 and administer and dispose of the same, when necessary, for the benefit of the CTU System
48 and subject to the limitations, directions and instructions of the donor, if any;

1 u. Delegate any of its powers and duties to the President and other officials of the CTU
2 System, as it may deem appropriate, so as to expedite the administration of the affairs of the
3 CTU System;

4
5 v. Establish policy guidelines and procedures for participative and transparent decision-
6 making within the CTU System;

7
8 w. Where most advantageous to the CTU System, privatize the management of non-academic
9 services such as health, food, buildings or grounds or property maintenance, and such other
10 similar activities;

11
12 x. Authorize the construction or repair of its buildings, machinery, equipment and other
13 facilities, and the purchase and acquisition of real property, including the necessary supplies,
14 materials, and equipment; and

15
16 y. Promulgate rules and regulations, as may be necessary, to carry out the purposes and
17 functions of the CTU System.

18
19 **SEC. 7. *Quorum and Service of Processes.*** – A quorum of the Board shall consist
20 of a majority of all members. All processes against the Board shall be served on the President
21 or Secretary of the Board.

22
23 **SEC. 8. *Meetings of the Board.*** – The Board shall regularly convene once every
24 three (3) months. The Chairperson of the Board may, however, call a special meeting
25 whenever necessary: *Provided*, That members are notified in writing at least three (3) days
26 prior to the conduct of said meeting.

27
28 A quorum of the Board shall consist of a majority of all its members holding office
29 at the time of the meeting: *Provided, however*, That the Chairperson of the Board or the
30 President of the CTU System is among those present in the meeting.

31
32 In case the Chairperson of the CHED cannot attend a meeting of the Board, a CHED
33 Commissioner duly designated by the Chairperson of the CHED as representative to the
34 meeting, shall have all the rights and responsibilities of a regular member: *Provided*, That
35 during the meeting, the President of the CTU System, as Vice Chairperson, shall be the
36 presiding officer: *Provided, further*, That this provision notwithstanding, the Chairperson of
37 the CHED may designate a CHED Commissioner as the regular Chairperson of the Board,
38 in which case, the said CHED Commissioner shall act as the presiding officer.

39
40 In case the Chairpersons of the Senate Committee on Higher, Technical and
41 Vocational Education and the House Committee on Higher and Technical Education shall
42 not be able to attend the Board meeting, they may designate their respective representatives
43 who shall have the same rights and responsibilities as regular members of the Board.

44
45 The members of the Board shall serve without compensation other than
46 reimbursements for actual and necessary expenses incurred, either for their attendance to the
47 meetings of the Board or in connection with other official business authorized by resolutions
48 of the Board, subject to existing laws and regulations.

49
50 **SEC. 9. *The University Administration.*** – The administration of the CTU System
51 shall be headed by a President who shall be appointed by the Board, subject to its guidelines

1 on qualification standards, and based on the recommendation of a search committee duly
2 constituted for the purpose of selecting the President. The CTU System President shall render
3 full-time service, serve a term of four (4) years, and may be reappointed to another term:
4 *Provided*, That this provision shall not adversely affect the term of the incumbent President.
5

6 Within six (6) months before the expiration of the term of office of the incumbent
7 President of the CTU System, the Board shall constitute the Search Committee for the
8 Presidency.
9

10 The salary of the President of the CTU System shall be in accordance with Republic
11 Act No. 11466 or the "Salary Standardization Law of 2019", and such other laws amendatory
12 thereto, which may hereinafter be enacted, and on the joint circular for state universities and
13 colleges' leveling instruments, and guidelines of the CHED and the DBM.
14

15 In case of a vacancy in the Office of the President by reason of death, compulsory
16 retirement, resignation, removal for cause, or incapacity of the President to perform the
17 functions of the office, the Board shall designate an Officer-in-Charge of the CTU System,
18 pending the appointment of a new President: *Provided*, That the Officer-in-Charge shall
19 serve only during the unexpired portion of the term.
20

21 The President of the CTU System shall be assisted by the following officials: an
22 Executive Vice President; Vice President for Academic Affairs; Vice President for
23 Administration, Planning, and Finance; Vice President for Research, Development, and
24 Extension; Vice President for Linkages, Production, and Research Generation; and a Vice
25 President for Quality Assurance. They shall all be appointed by the Board upon the
26 recommendation of the President of the CTU System from a list submitted by the search
27 committee. Realignment of vice-president functions and title may be allowed upon approval
28 of the Board.
29

30 **SEC. 10. Powers and Duties of the President.** – The President of the CTU System is
31 the chief executive of the CTU System, chief academic officer, and head of the university
32 faculty and shall exercise the following powers and functions:
33

- 34 a. Provide progressive and dynamic, ethical, intellectual, and administrative leadership;
35
- 36 b. Exercise general supervision over all academic, administrative, business and financial
37 operations;
38
- 39 c. Determine and prepare the agenda of all meetings of the Board: *Provided, however*, That
40 any member of the Board shall be entitled to have any matter included in the agenda;
41
- 42 d. Recommend to the Board the creation of administrative offices, as well as changes in the
43 organizational structure to enhance the operations and functions of the CTU System;
44
- 45 e. Enforce general policies affecting any unit of the CTU System and take such actions,
46 which one's judgement are necessary for the protection of property and general interest
47 of the CTU System, its student and personnel, and the operation of the CTU System as a
48 whole, and to inform the Board on all matters relating to the operation and welfare of the
49 CTU System;

- 1 f. Make *ad interim* appointments to fill in new positions and crucial vacancies, subject to
2 the subsequent approval of the Board, and to make such arrangements to meet
3 emergencies occurring between meetings of the Board so that the efficient operations of
4 the CTU System may not suffer;
5
- 6 g. Hear and decide administrative cases or matters instituted by or brought before it directly,
7 involving the CTU officials and employees, in accordance with the CSC Rules on
8 Administrative Cases and subject to appeal to the Board;
9
- 10 h. Grant or withhold permission to reveal confidential matters affecting the CTU System or
11 any unit thereof, on any action taken by the Board;
12
- 13 i. Grant permission for the use of the building and the premises of the CTU System for
14 academic, professional and specific convention, student and other related activities;
15
- 16 j. Represent the CTU System in the execution of contracts, deeds, and instruments for the
17 proper conduct of the business of the CTU System;
18
- 19 k. Prepare an annual report on the programs, projects, and accomplishments of the CTU
20 System for the previous year, as well as the needs for the current year, including a budget
21 covering the estimates of income and expenditures; and
22
- 23 l. Exercise such other powers as elsewhere provided in this Act, or as authorized by the
24 Board.
25

26 **SEC. 11. *CTU Officials.*** – The CTU System President shall be assisted by the
27 executive vice-president, vice-presidents, chancellors, the secretary of the CTU, and such
28 other academic and administrative officials, whose positions and functions are deemed
29 necessary in the effective and efficient administration of the CTU System, as may be
30 determined by the Board. The president, executive vice-president, vice-presidents,
31 chancellors, campus directors, college deans and directors, shall be given the appropriate
32 representation and transportation allowance (RATA). Other CTU officials may also be
33 provided with RATA upon proper justification and approval of the Board and compliance
34 with DBM guidelines and policies.
35

36 **SEC. 12. *Search Committee.*** – Within six (6) months before the expiration of the
37 term of office of the incumbent president, executive vice-president, and vice-presidents of
38 the CTU System, the Board shall constitute a search committee, whose composition shall be
39 determined by the Board, and taking into consideration representatives from the academic
40 community, one (1) private sector representative who shall not be in anyway connected to or
41 associated with the CTU System, two (2) representatives from the Philippine Association of
42 State Universities and Colleges (PASUC), and one (1) representative from the CHED.
43

44 **SEC. 13. *Minimum Qualifications for Presidency.*** – The applicant for the
45 presidency of the CTU System shall possess the qualification standards set by the Board and
46 Republic Act No. 8292, otherwise known as the “Higher Education Modernization Act of
47 1997”.
48

49 **SEC. 14. *Appointment Papers of the CTU President.*** – After the selection and
50 appointment of the new president by the Board, the appointment papers shall be signed by

1 the Chairperson of the CHED or the CHED Commissioner who has been duly designated as
2 regular chairperson of the Board.

3
4 **SEC. 15. Heads of the CTU System Constituent Units.** – Each CTU System
5 Constituent Unit shall be headed by a Chancellor to be appointed by the Board, upon the
6 recommendation of the President from a shortlist of candidates prepared by a Search
7 Committee created for the purpose, subject to the guidelines on qualification standards set
8 by the Board. The Chancellor shall serve for a term of four (4) years, and shall stay on until
9 a qualified successor shall have been appointed.

10
11 **SEC. 16. The Chancellor of a CTU System Constituent Unit.** – The Chancellor shall
12 be the Chief Executive Officer of the CTU System Constituent Unit and shall exercise
13 general supervision over all its business and financial operations.

14
15 **SEC. 17. Heads of Campuses.** – A campus shall be headed by a campus director who
16 shall render full-time service. All campus directors shall be appointed by the Board, upon
17 the recommendation of the CTU President, subject to the guidelines on qualification
18 standards set by the Board. The Campus Directors shall serve a term of two (2) years, and
19 shall stay on until a qualified successor shall have been appointed.

20
21 **SEC. 18. The CTU System Council.** – There shall be a CTU System Council
22 consisting of the CTU System President as its chairperson, the Executive Vice-President, all
23 Vice Presidents, all Chancellors, all Campus Directors, Deans, and other officials of equal
24 rank, as members, whose duty is to review and recommend to the Board policies governing
25 the administration, management, development, and planning of the CTU System.

26
27 Each of the colleges of the CTU System shall be headed by a dean who shall be
28 appointed by the Board upon the recommendation of the CTU System President from a
29 shortlist of at least three (3) nominees submitted by the Chancellor, subject to the guidelines
30 on qualification standards set by the Board. The College Dean shall serve a term of two (2)
31 years, and shall stay on until a qualified successor shall have been appointed.

32
33 In case of vacancy in the position of chancellors, campus directors, and college deans,
34 the President shall appoint or designate temporary appointments preferably from the
35 incumbent heads of the campuses.

36
37 If a dean fails to complete the term of office, the Chancellor shall appoint an acting
38 dean and commence the search and appointment process. In no case shall the search and
39 appointment of the next dean be longer than sixty (60) calendar days from the date of
40 vacancy.

41
42 **SEC. 19. The Faculty.** – The teaching personnel of each college shall constitute its
43 faculty. The college faculty shall be headed by a dean.

44
45 Each CTU System constituent unit must have the following minimum number of
46 CTU professor positions: two (2) for CTU-Metro Cebu, one (1) for CTU-North Cebu, one
47 (1) for CTU-South Cebu. Additional CTU professor positions may be created, subject to
48 existing guidelines and qualification standards. The president shall be given a CTU professor
49 position without prejudice to the allocated number of professors per constituent unit:
50 *Provided*, That the President is able to comply with the requirements as a CTU professor
51 according to PASUC guidelines.

1 **SEC. 20. *Academic Freedom and Institutional Autonomy, and Excellence.*** – The
2 CTU System shall enjoy academic freedom and institutional autonomy pursuant to Section
3 5, Paragraph 2 of Article XIV of the Constitution, as well as the responsibility to maintain
4 and enhance its high academic standards in the performance of its functions in instruction,
5 research, extension, and community service.
6

7 **SEC. 21. *Commitment to National Development and Sustainable Development***
8 ***Goals.*** – The CTU System shall harness the expertise of the members of its community and
9 other individuals to regularly study the state of the nation in relation to its quest for national
10 development in the primary areas of research, innovation, sustainable education, and
11 economics, among others; identify key concerns, formulate responsive policies regarding
12 these concerns, and give advice and recommendations to Congress and the President of the
13 Philippines. It shall also formulate policies that promote the sustainable development goals
14 of the United Nations.
15

16 **SEC. 22. *Social Responsibility.*** – The CTU System is committed to serve the Filipino
17 nation and humanity. While it fulfills its obligation to pursue universal principles, it shall
18 formulate its plans and activities towards the fulfillment of the aspirations of the Filipino
19 people for progress and social transformation.
20

21 **SEC. 23. *Internationalization.*** – The CTU System is a technological university with
22 an international character. It shall adopt internationally-recognized curricula and collaborate
23 with international universities to co-host courses or programs. In line with the direction of
24 the CHED to attain the international recognition of Philippine higher education institutions,
25 the CTU System shall exert best efforts to be recognized by prestigious world university
26 ranking bodies, including the *Quacquarelli Symonds* and the Times Higher Education. It
27 shall likewise subject its program offerings to prestigious international accreditation and
28 certification bodies.
29

30 **SEC. 24. *Research, Development, and Extension (RDE) Centers.*** – Each campus
31 shall have at least one (1) RDE center with an annual appropriated budget of at least Five
32 million pesos (PhP5,000,000.00). For the campuses under the CTU System Constituent Unit
33 in Metro Cebu, each college shall have at least one (1) RDE center with an annual
34 appropriated budget of at least Five million pesos (PhP5,000,000.00). Currently recognized
35 RDE centers shall be carried over as established RDE centers. Thereafter, the establishment
36 of new RDE centers must be approved by the Board. The Office of the Vice-President for
37 RDE shall, as endorsed by the President, recommend to the Board the creation of new RDE
38 centers. Each of the RDE centers shall be headed by a director, who shall be appointed by
39 the Board upon the recommendation of the CTU President and the Vice-President for RDE,
40 and the respective Chancellors of the campus where the RDE center is hosted. The RDE
41 Directors shall have a term of two (2) years, subject to reappointment, and must possess the
42 academic training and work experience that is aligned with the field of research and extension
43 services conducted by the RDE center. The Office of the Vice-President for RDE shall
44 monitor and evaluate the operations and performance of the RDE centers in cooperation with
45 the respective chancellors. The respective RDE Directors shall prepare and manage the
46 budget of the RDE centers based on the recommendation of their respective chancellors. The
47 said budget shall be approved by the Office of the Vice-President for RDE and the CTU
48 President.

1 **SEC. 25. Recognition and Financial Rewards.** – The CTU System shall recognize
2 and provide rewards for the outstanding achievements of teaching and non-teaching
3 personnel and students in instruction, research, extension, and administration. These include
4 topping the licensure examinations, scientific publications in reputable peer-reviewed
5 journals, patents, utility models and the like, and performance of highly outstanding
6 employees. The criteria to be used in selecting the recipients of such recognition and the
7 amount of the financial reward to be given shall be determined by the appropriate CTU
8 council and subject to the approval of the Board.

9
10 **SEC. 26. Income Generating Projects and Viable Demonstration Projects.** – The
11 CTU System shall implement feasible income generating projects (IGPs) and viable
12 demonstration projects. These projects shall serve as vital links to the functions of the CTU
13 System in instruction, research, production, extension services, and resource generation.

14
15 To this end, an IGP Manual of Operations shall be formulated for the operation of
16 the IGPs of the CTU System which shall provide for the share of the CTU System, and the
17 incentives of employees involved in the implementation of the projects based on existing
18 circulars of the DBM, COA, CSC, and other pertinent laws, rules, and regulations.

19
20 **SEC. 27. Non-teaching Personnel.** – Regular employees not performing regular
21 teaching functions shall compose the non-teaching personnel of the CTU System. The
22 creation and opening of new non-teaching plantilla positions shall be vested in the Board,
23 subject to the CSC rules and regulations and the availability of funds.

24
25 **SEC. 28. Assets, Liabilities, and Personnel.** – All assets, both real and personal,
26 personnel and records of the CTU, as well as its liabilities or obligations, shall be transferred
27 to the CTU System: *Provided*, That the positions, rights, and security of tenure of faculty
28 members and personnel therein employed under existing laws prior to the conversion into a
29 CTU System shall be respected.

30
31 All parcels of land belonging to the government that are occupied by the CTU and all
32 its satellite campuses are hereby declared property of the CTU System, and titled under its
33 name: *Provided*, That should the CTU System cease to exist or be abolished or should such
34 aforementioned parcels of land be no longer needed by the CTU System, the same shall
35 revert to the Province of Cebu or to the Republic of the Philippines, as the case may be.

36
37 **SEC. 29. Land Grants and Other Real Properties.** –

- 38
39 a) The State shall support the CTU System in the form of a lump sum amount in the annual
40 General Appropriations Act (GAA), other financial benefits, and in kind, such as through
41 land grants and donations and use of other real properties. To carry out the intent of these
42 grants, income derived from the development of all land grants and real properties shall
43 be used to further the ends of the CTU System, as may be decided by the Board;
44
45 b) The absolute ownership of the CTU System over such parcels of land ceded by law,
46 decree, or presidential issuance to the CTU System, including those covered by original
47 and transfer certificates of title in the name of the CTU System and their future
48 derivatives, is hereby confirmed. Where the issuance of proper certificates of title for
49 these landholdings is still pending, the appropriate government office shall expedite the
50 issuance thereof within six (6) months from the date of effectivity of this Act: *Provided*,

1 That all registration requirements necessary for the issuance of the said titles are
2 submitted and complied with;

- 3
- 4 c) The Board may plan, design, approve and cause the implementation of land leases:
5 *Provided*, That such mechanisms and arrangements shall sustain and protect the
6 environment in accordance with law, and be exclusive of the academic core zone of the
7 campuses of the CTU System: *Provided, further*, That such mechanisms and
8 arrangements shall not conflict with the academic mission of the CTU System;
9
- 10 d) The Board may allow the use of the income coming from real properties of the CTU
11 System as security for transactions to generate additional revenues when needed for
12 educational purposes;
13
- 14 e) The Board may approve the implementation of joint ventures: *Provided*, That in the event
15 real properties of the CTU System are involved, only the income derived from the use of
16 the real properties shall be the subject of its participation or obligation in the joint
17 ventures: *Provided, further*, That no joint venture shall result in the alienation of the real
18 properties of the CTU; and
19
- 20 f) Any plan to generate revenues and other sources of income from land grants and other
21 real properties entrusted to the CTU System shall be consistent with its academic mission
22 and devoid of any undue influence and control from commercial interests. The programs,
23 projects or mechanisms shall be approved by the Board subject to a transparent and
24 democratic process of consultation with the constituents of the CTU System: *Provided*,
25 That funds generated from such programs, projects or mechanisms shall not be meant to
26 replace, in part or in whole, the annual appropriations it is receiving as provided by the
27 national government.
28

29 **SEC. 30. Safeguards on Assets Disposition.** – The preservation of the value of the
30 assets of the CTU System shall be of primordial consideration.
31

32 The sale of any existing real property of the CTU System shall be prohibited:
33 *Provided*, That the Board may alienate real property donated after the effectivity of this Act
34 if the terms of the donation specifically allow it.
35

36 Notwithstanding the provision of this Act or any other law to the contrary, the lease
37 of more than five (5) years of the assets of the CTU System and any transaction referred to
38 under this section shall be subject to the following conditions and procedures:
39

- 40 a) That the transactions shall be discussed with the members of the Board in any of its
41 formally convened regular or special meetings at least one (1) month before a decision is
42 made;
43
- 44 b) That they shall be based on a multi-year comprehensive development plan, crafted, and
45 developed by qualified urban planning professionals having at least five (5) years experience,
46 with prior consultations with and concurrence of third-party experts and duly approved by a
47 majority vote of all the members of the Board;
48
- 49 c) That they shall be subject to competitive and public bidding as provided for under Republic
50 Act No. 9184, otherwise known as the “Government Procurement Reform Act”; and

1 d) That when such transactions involve an amount of more than Fifty million pesos
 2 (PhP50,000,000.00), they shall be approved by at least three-fourths of all the members of
 3 the Board: *Provided*, That the splitting of contracts, such as by breaking up a contract into
 4 smaller quantities or amounts, or dividing contract implementation into artificial or arbitrary
 5 phases or subcontracts for the purpose of circumventing this provision, shall not be allowed.
 6

7 **SEC. 31. *Duty and Tax Exemptions.*** – Subject to the provisions of the National
 8 Internal Revenue Code of 1997, as amended, and Republic Act No. 10863, otherwise known
 9 as the “Customs Modernization and Tariff Act (CMTA)”, as the case maybe:
 10

11 a) All revenues and assets of the CTU System used for educational purposes, or in support
 12 thereof, shall be exempt from taxes and duties;
 13

14 b) All grants, bequests, endowments, donations, and contributions made to and used actually,
 15 directly, and exclusively for educational purposes by the CTU System, shall be exempt from
 16 donor’s tax and the same shall be considered as allowable deductions from gross income for
 17 purposes of computing the taxable income of the donor in accordance with the provisions of
 18 the National Internal Revenue Code of 1997, as amended;
 19

20 c) Importation by the CTU System of economic, technical, vocational, scientific,
 21 philosophical, historical, legal, and cultural books, supplies, and materials shall, upon
 22 certification by the Board and the CHED, including scientific and educational computer and
 23 software equipment, be exempt from customs duties in accordance with the provisions of
 24 Republic Act No. 10863, otherwise known as the “CMTA”; and
 25

26 d) All academic awards shall be exempt from taxes.
 27

28 **SEC. 32. *Transitory Provision.*** – For purposes of transition into the CTU System
 29 status, the incumbent President of the CTU shall serve a new first term as the first President
 30 of the CTU System. The President shall designate, preferably among the incumbent campus
 31 directors, officers-in-charge for the position of chancellors of the CTU System constituent
 32 units until such time that the appointed chancellors have assumed their positions in
 33 accordance with Section 16 of this Act.
 34

35 **SEC. 33. *Development Plan and Organizational Structure.*** – Within one hundred
 36 twenty (120) days after the approval of this Act, the CTU System shall accomplish the
 37 following:
 38

39 a) Submit a five (5)-year development plan, including its corresponding program budget to
 40 the CHED and the DBM;
 41

42 b) Submit the revised Land Use Development and Infrastructure Plan (LUDIP) in accordance
 43 with Republic Act No. 11396, otherwise known as the “SUCs LUDIP Act”;
 44

45 c) Undergo a management audit in cooperation with the CHED; and
 46

47 d) Set up its organizational, administrative as well as academic structure, including the
 48 designation of the key officials and other administrative personnel of the CTU System.
 49

50 **SEC. 34. *Filing of Report.*** – On or before the fifteenth (15th) day of the second (2nd)
 51 month after the opening of regular classes each year, the Board shall file a detailed report on

1 its compliance with the requirements for university system status with the Office of the
2 President of the Philippines and both Houses of Congress, through the Chairperson of the
3 CHED.

4
5 The CHED shall regularly provide technical assistance to the CTU System and
6 monitor compliance with all the requirements. They shall designate a panel of experts who
7 shall prepare, provide, and define the specific indicators and levels of accomplishments based
8 on the acceptable international practices to be used as benchmarks in declaring the CTU as
9 a university system. These benchmarks prepared by the panel of experts shall be
10 recommended to the CHED through a resolution of the Commission *en banc*.

11
12 The CTU shall retain its status prior to the effectivity of this Act, until it complies
13 with the requirements provided herein.

14
15 **SEC. 35. Rules of Construction.** – Unless subsequent legislation expressly provided
16 for the repeal, amendment or modification, no other issuances shall diminish the powers,
17 rights, privileges, and benefits accorded to the CTU System under this Act or under the
18 issuances not otherwise modified or repealed under this Act.

19
20 **SEC. 36. Appropriations.** – The amount necessary to carry out the initial
21 implementation of this Act shall be charged against the current year’s appropriation of the
22 CTU. Thereafter, such sums as may be necessary for the continued implementation of this
23 Act shall be included in the annual GAA.

24
25 **SEC. 37. Suppletory Application.** – The provisions of Republic Act No. 8292,
26 otherwise known as the “Higher Education Modernization Act of 1997”, shall form part of
27 this Act.

28
29 **SEC. 38. Implementing Rules and Regulations.** – Within sixty (60) days of the
30 approval of this Act, the Board shall, in consultation with the CHED, issue rules and
31 regulations to implement its provisions.

32
33 **SEC. 39. Separability Clause.** – If, for any reason, any part or provision of this Act
34 is declared invalid or unconstitutional, the remaining parts or provisions not affected are in
35 full force and effect.

36
37 **SEC. 40. Repealing Clause.** – Republic Act No. 9744, entitled “An Act Converting
38 the Cebu State College of Science and Technology System in the City of Cebu and All its
39 Satellite Campuses Located in the Province of Cebu into a State University to be Known as
40 the Cebu Technological University (CTU) and Appropriating Funds Therefor”, is hereby
41 amended. All other laws, presidential decrees, executive orders, and rules and regulations
42 contrary to or inconsistent with the provisions of this Act are amended, repealed or modified
43 accordingly.

44
45 **SEC. 41. Effectivity.** – This Act shall take effect fifteen (15) days after its publication
46 in the *Official Gazette* or in a newspaper of general circulation.
