And taking into consideration **Senate Bill No. 1681**, introduced by Sen. Manuel "Lito" M. Lapid, entitled:


"AN ACT

**DECLARING JULY 2 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN PASIG CITY
TO BE KNOWN AS THE "ARAW NG PASIG"**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. July 2 of every year is hereby declared a special nonworking holiday in
2 Pasig City to be known as the Araw ng Pasig.

3 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official*
4 *Gazette* or in a newspaper of general circulation.
