and taking into consideration **Senate Bill No. 1828**, introduced by Sen. Manuel "Lito" M. Lapid, entitled:



AN ACT

**DECLARING APRIL 4 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN  
THE CITY OF ANTIPOLO, PROVINCE OF RIZAL, IN COMMEMORATION OF ITS  
CITYHOOD ANNIVERSARY**

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           **SECTION 1.** April 4 of every year is hereby declared a special nonworking holiday in  
2 the City of Antipolo, Province of Rizal, in commemoration of its Cityhood Anniversary.

3           **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
4 *Gazette* or in a newspaper of general circulation.
