**"AN ACT**



AN ACT

DECLARING JULY 15 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN  
THE CORDILLERA ADMINISTRATIVE REGION TO BE KNOWN AS "CORDILLERA  
DAY", IN COMMEMORATION OF ITS FOUNDATION DAY

*Be it enacted by the Senate and House of Representatives  
of the Philippines in Congress assembled:*

1           SECTION 1. July 15 of every year is hereby declared a special nonworking holiday in  
2 the Cordillera Administrative Region to be known as "Cordillera Day", in commemoration of  
3 its foundation day.

4           SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official*  
5 *Gazette* or in a newspaper of general circulation.
