SESSION NO. 56 Wednesday, March 1, 2023

CALL TO ORDER

At 3:22 p.m., the Senate President, Hon. Juan Miguel "Migz" F. Zubiri, called the session to order.

PRAYER

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 3:31 p.m.

RESUMPTION OF SESSION

At 3:38 p.m., the session was resumed with Senator Gatchalian presiding.

Upon resumption, Senator Villanueva also acknowledged the presence in the gallery of Rep. Marlyn "Len" B. Alonte-Naguiat, who was welcomed by the presiding officer.

QUESTION OF PRIVILEGE OF SENATE PRESIDENT ZUBIRI

On a matter of personal and collective privilege, Senate President Zubiri made the following statements:

I had seen the news today and it was really quite disturbing. I urgently call on our law enforcement to immediately hunt down and arrest the suspects behind the death of John Matthew Salilig who died because of hazing.

And as we know, the enhanced Anti-Hazing Law was a bill of mine, together with the gentleman from Valenzuela, the Presiding Officer, and Senator Lacson, which I filed when the brother of my staff, Atio Castillo, died about four years ago.

But, since then, it seems that ang daming pasaway. Ang dami pa ring nanggugulpi ng bata, ng mga inosente, on the guise of brotherhood and sisterhood. As I said, nakapanghihina na magising sa balita na may isa na namang batang nasawi dahil sa hazing. My prayers and condolences go out to John's family and friends, as well as my assurance that we are with them in finding justice for his death.



Our laws are clear on this: any individual who participates in hazing that leads to the victim's death, is punishable with reclusion perpetua. Let me repeat, they are punishable with reclusion perpetua, or lifetime imprisonment.

Hazing should not be tolerated by any society; and we have the laws in place to make sure that it should never happen on hapless young men and women only longing for friendship and camaraderie. Those barbarian perpetrators should all rot in jail for the rest of their lives. The culture of secrecy in the guise of fraternal brotherhood is abhorrent. And each and every single person involved—from those who planned the hazing, to those who participated in the brutality, even those who were just present but did nothing to stop the hazing—should be thrown in jail as well. Under our laws, they are all responsible.

Iyon lamang po ang gusto kong sabihin ngayong araw na ito, and I hope that the Majority Leader can forward this to the proper committee for proper follow-up and investigation.

REMARK OF SENATOR GATCHALIAN

Senator Gatchalian joined Senate President Zubiri in condemning the brutal act of hazing on John Matthew Salilig. He also agreed that the practice would only stop when the perpetrators are arrested and brought to the court of law.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva gave the following statement in support of the Senate President's appeal for swift justice on the death of John Matthew Salilig:

Hindi po lingid sa kaalaman ng Bulwagang ito na tayo ay miyembro ng Tau Gamma Phi, o Triskelion Grand Fraternity.

Nakapanlulumo, nakakagalit, sobra, nakapanglalata, lalo na noong panoorin natin iyong video kung saan natagpuang patay sa Imus, Cavite ang isang 3rd year chemical engineering student ng Adamson University, dahil umano sa fraternity hazing. Kinilala po mismo ni Brod John Michael, who is also a member of Tau Gamma Phi, ang bangkay ng kaniyang kapatid.

The victim was John Matthew Salilig, who was last seen with members of Tau Gamma Phi fraternity in Biñan City, Laguna, and had been reported missing since February 18. Ten days already. Police said that at least 18 suspects are involved in the death of John Matthew.

Sabi ng isa sa mga suspects, hindi raw po bababa sa pitumpung palo ang tinamo ni John Matthew sa initiation o welcoming rites ng fraternity.

I would like to put this on record, hindi po siya pumapasok as a new member of the fraternity. He has been a member of Tau Gamma Phi in Zamboanga. Welcoming rites lamang po ito, kaya nagngangalit lalo, nakapanlulumo. And, I have to say this, nakakahiya na rin na maging miyembro ng isang organisasyon na kumukunsinte, tumu-tolerate sa mga ganitong gawain.

His battered body was unceremoniously dumped on an open field in Imus, Cavite. May mga kuwento po na mula doon sa pinangyarihan, dadalhin sa ospital, ngunit nagbago ang isip. Mayroon din pong kuwentong may nagsasabi na huwag nang dalhin, ilibing na lamang dito sa Imus, Cavite.

Wala pong puwang sa mundong ito ang kaharasan. Wala pong salita sa mundong ito strong enough to express that disgust. And I am appalled by what happened to my brother, our brother, John Matthew. Hindi ko po kayang tingnan iyong mga picture; nasa akin, ang dami, pinadala sa aking cell phone.

Muli, sasabihin ko, wala pong lugar sa atin ang karahasan at pagpatay. Sayang po ang buhay ng batang ito; nag-aaral sa Adamson University, wanted to be a lawyer; sayang ang kaniyang mga pangarap. His potential as an engineer will never be realized.

Kulang po iyong salita para magsabing sorry, pero nais nating sabihin na we are so sorry to the family and loved ones of John Matthew. I join his family in mourning. Wala pong katumbas na sakit at hapdi ang sinapit ng kanilang anak, ng kanilang kapatid, ng kanilang kaibigan.



Muli po, I am not speaking on behalf of the entire fraternity brotherhood ng Tau Gamma Phi. Kausap ko po si Rep. Marlyn B. Alonte, who is also a member at Triskelion—Sis; si Vice Mayor Angelo B. Alonte, nandito po. Lahat po kami ay nanlulumo; lahat po kami ay nanlulata; lahat po kami ay nagulat; lahat po kami ay shocked at hindi makapayag sa nangyayaring ito.

As mentioned a while ago by our dear Senate President and the Presiding Officer, we passed in the Seventeenth Congress *ito pong* Anti-Hazing Act of 2018. And yet some are still very bold to commit such senseless acts of violence that took another innocent life.

Iyong huling nag-hearing po tayo rito, doon sa isyu ni Atio, doon naman sa UST sa may Navarra Street—doon ginawa iyong karumal-dumal na krimen.

When we were deliberating in 2018, we noted the following: 18 hazing-related deaths since the passage of the 1995 Anti-Hazing Law; 300 suspects at-large, according to the Philippine National Police (PNP); the first and only conviction under RA 8049 is the case of the University of the Philippines, Los Baños student, Marlon Villanueva—Villanueva pa po—in 2006, in the hands of the Alpha Phi Omega Fraternity. This case, which sentenced the two suspects to reclusion perpetua, was decided in 2015.

I said this before in this august Hall of the Senate, when the news of the death of Horacio "Atio" Castillo III due to hazing broke: "no type of brotherhood can ever equate to the sanctity of life. Hinding-hindi nasusukat sa karahasan ang tunay na kapatiran."

Ang mismong Tau Gamma Phi, ilang panahon na, ilang taon nang ini-implement iyon pong tinatawag na "No contact policy." We were so proud of it na ito na iyong pinapa-implement sa bawat chapter ng Tau Gamma Phi; sa bawat chapter ng mga school and university all over the country.

Claiming hazing as an initiation to a brotherhood or sisterhood rather than an active blood-thirsty act of violence is like insisting that black is white, and that night is day.

I strongly urge the police to investigate and hold all those accountable for this unacceptable incident, kahit na kapatiran pa ng Tau Gamma Phi. We would also like to get an update on the implementation of the Anti-Hazing Law of 2018. How many hazing-related deaths have occurred since then? How many have been convicted? How many complaints have been filed? We need this information, so that we can address any gaps hindering the full implementation of the law. We have to be proactive. Hindi po puwedeng passive na lamang tayo. Baka dapat mayroon tayong magandang reward system, lalo na sa mga university. Mga batang-bata, sinasaktan. Ayaw padapuan ng lamok ng kanilang magulang, tapos papatayin sa hazing na parang masahol pa sa pagpatay sa isang kikilawing hayop.

I also urge the full implementation of the Anti-Hazing Law, as called by our Senate President, in all universities and colleges, upang tuluyan nang mabasura ang karahasan sa ating pamantasan.

Ako po'y umaasa na makakamit ng ating kapatid na si John Matthew Salilig at ng kanyang pamilya—ang ating fraternity brother also na si John Michael at ang kanyang ama na isang fraternity brother din—ang hustisya.

At this juncture, Senator Gatchalian relinquished the Chair to Senate President Zubiri.

REFERRAL OF SPEECH TO COMMITTEE

Upon motion of Senator Villanueva, there being no objection, the Chair referred the privilege speech of Senate President Zubiri and the manifestations thereon to the Committee on Justice and Human Rights as the primary committee, and to the Committee on Public Order and Dangerous Drugs as the secondary committee.

Upon motion of Senator Villanueva, there being no objection, the Body dispensed with the reading of the *Journal* of Session No. 55 (February 28, 2023) and considered it approved.



PROPOSED SENATE RESOLUTION NO. 316

Upon motion of Senator Villanueva, there being no objection, the Body considered Proposed Senate Resolution No. 316, entitled

RESOLUTION CONGRATULATING AND COMMENDING THE WINNERS OF THE 29TH ANNUAL GALING POOK AWARDS,

taking into consideration Proposed Senate Resolution Nos. 323,335, 337, and 511.

With the permission of the Body, only the title of the resolution was read without prejudice to the insertion of its full text into the *Record of the Senate*.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva stated that in the interest of time, Senator Lapid and himself would just submit their sponsorship and cosponsorship speeches, respectively, on Proposed Senate Resolution No. 316 for insertion into the *Journal* and *Record of the Senate*.

SPONSORSHIP SPEECH OF SENATOR LAPID

Pursuant to the manifestation of Senator Villanueva, following is the sponsorship speech of Senator Lapid on Proposed Senate Resolution No. 316:

Mga ginagalang kong kasama sa Bulwagang ito, isang karangalan para sa akin na magsponsor ng resolusyon nating ito na nagbibigay-pugay sa sampung mga programa mula sa mga lokal na pamahalaan na nagwagi sa 2022 Galing Pook Awards.

Ang Galing Pook Awards ay unang inilunsad noong 1993 kung saan nagkaroon ng pambansang kampanya para sa pinakamakabago at malikhaing mga proyekto ng mga lokal na pamahalaan na nagbibigay solusyon sa mga pangkaraniwan at pang araw-araw na suliranin na kinakaharap ng ating mga kababayan. Sinusuri sa pamamagitan ng isang multilevel screening process batay sa mga positibong resulta at epekto; pagsulong ng partisipasyon at empowerment ng mga mamamayan; innovation, transferability at sustainability; at kahusayan ng paghahatid ng serbisyo ng programa sa komunidad.

Ang mga itinanghal na nagwagi ng Galing Pook Awards taong 2022 ay ang mga sumusunod:

The Green Wall of Alcala (Alcala, Cagayan)

Pagkatapos maranasan ang pinakamalalang pagbaha sa loob ng isang siglo, na sumalanta sa sampung libong (10,000) pamilya at nagpalubog sa limang libong (5,000) kabahayan, inilunsad ng lokal na pamahalaan ang Green Wall of Alcala na may layuning magtanim ng mga puno sa malawak na bahagi ng bayan at gamitin ang pamamaraang "agro-forestry" sa pagsasaka upang iwasan na muling maulit ang pangyayaring tinaguriang "100-year-old flood."

Advancing and Sustaining Good Governance and Community Acions Towards Resiliency and Empowerment (Basilan Province)

Ang peace and good governance initiatives ng pamahalaang panlalawigan ng Basilan kung saan mahigit 364 kasapi ng mga rebeldeng grupo ang matagumpay na napababa ang armas at nagbalik sa kanilang komunidad kung saan sila ay mapayapang nagsasaka at nangingisda.

Bataan Public-Private Partnership Programs (Bataan Province)

Ang programang public-private partnership ng pamahalaang panlalawigan ng Bataan ay magandang halimbawa ng pagtutulungan at pagkakaisa ng pamahalaan at ng pribadong sektor para sa pagsusulong ng kaunlaran ng bayan. Isa sa matatagumpay na proyekto sa ilalim ng Bataan Public-Private Partnership Programs ay ang "The Bunker," isang seven-story na haligi na tatayong sentro ng pamahalaang panlalawigan ng Bataan.



Balik-Biñan Project: Tourism Development Through Heritage Conservation (Biñan, Laguna)

Ang proyekto ng pamahaalng bayan ng Biñan ay may layuning panatilihin ang lokal na kasaysayan at tradisyon ng bayan ng Biñan. Isinama ng pamahalaang lungsod ang pagkakakilanlang pangkultura nito sa mga pangunahing proyekto ng pamahalaan sa edukasyon, kalusugan, agrikultura, pabahay at imprastraktura, kapayapaan at kaayusan, at pag-unlad ng ekonomiya. Ang pamamahalang nakabatay sa kultura ay naging isa sa mga prayoridad ng lungsod. Nanguna ito sa mga pagsisikap sa muling pagpapasigla sa bayan ng Biñan na mayaman sa kasaysayan at kultura.

From Black to Green: Fishponds, Eco-Tourism, and Full Employment (Brgy. Cayabu, Tanay, Rizal)

Ang pagsusulong ng pamahalaang bayan ng Tanay sa Barangay Cayabu ng food security at sustainability sa gitna ng pandemya at epekto ng climate change sa malalayong lugar ng mga kabundukan ng Tanay. Sa pagtutulungan ng pribadong sektor at ng pamahalaan, sinisigurong may sapat na pagkain sa hapag kainan at dagdag na pagkakakitaan ang mga pamilya sa pamamagitan ng komprehensibong programa sa agrikultura.

Trekking to Unlock Community Ailments and Difficulties (Tucad) (Goa, Camarines Sur)

Ang pagmomobilisa ng mga volunteers ng pamahalaang bayan ng Goa upang maabot at mabigyan ng serbisyong medikal ang kanilang mga kababayan nakatira sa mga liblib at malayong lugar sa kabundukan.

"I-Bike" A Program Promoting the Development of the Iloilo City Bike Culture (Iloilo City)

Ang programa ng pamahalaang panlungsod ng Iloilo na nagtataguyod ng alternatibong transportasyon at pagpapalaganap sa kamalayan ng mga mamayan ang malasakit sa kapaligiran at kalusugan, gayon din ang pagpapalawak ng mga bike lanes sa lungsod.

Yaru: A Whole-of-Community Approach toward Disaster Management (Itbayat, Batanes)

Matatagpuan sa hilagang dulo ng bansa ang Munisipalidad ng Itbayat na lantad sa malalakas na serye ng mga bagyo taon-taon. Gayon pa man, napapapanatili nila ang zero-casualty record sa pamamagitan ng kanilang diwa ng sama-samang pagkilos na kilala bilang "Yaru." Dahil sa Yaru, ang buong komunidad ay nagsasama-sama upang tulungan ang isa't isa na maghanda, umunlad, at makabangon mula sa bawat sakuna.

Libertad Fish Forever Savings Club (Libertad, Antique)

Ang proyekto ng pamahalaang bayan ng Libertad na may layuning tugunan ang mga suliraning kinakaharap ng mga komunidad sa tabing dagat, tulad ng mabilis na pagbaba ng stock ng isda, mas maraming bilang ng mga mangingisda, climate change, iligal na pangingisda, mahinang pangangasiwa ng pangisdaan, pangingisda ng mga komersyal na mangingisda sa dagat, pandemya, at hindi matatag na mga pamilihan—karamihan sa mga mamamayang bahagi ng sektor na ito ay kulang, kung hindi man walang, sapat na kaalaman sa pananalapi o financial literacy o access sa pangunahing insurance upang maprotektahan sila laban sa kawalang katiyakan.

Ang programa ay nagbigay sa komunidad ng pagsasanay at kinakailangang kaalaman sa pananalapi. Layunin nitong mabawasan ang sobra-sobrang panghuhuli ng isda, at kaalaman sa epektibong climate change adaptation, at mas ganap na lumahok sa pamamahala ng kanilang mga pangisdaan para sa pagpapanatili ng yamang dagat.

Basta Piddigueño, Agrihenyo: Consolidated Farm Production System (Piddig, Ilocos Norte)

Ang proyekto ng pamahalaang bayan ng Piddig na kinumbinsi ang kanilang mga magsasaka na lumipat sa pinagsama-samang sistema ng pagsasaka. Ang Consolidated Farm Production System ay isang komprehensibong programa na layong punan ang mga pangangailangan ng mga maliliit na magsasaka mula sa pagsasanay, kaalamang teknikal at mga kagamitan.

Sa likod ng bawat mauunlad na mga komunidad ay ang isang local government unit na tumutugon sa pangangailangan ng mga mamamayan nito. Sa gitna ng krisis na hatid ng pandemya, ang tagumpay ng inyong mga proyekto ay tila liwanag sa gitna ng dilim; na ang bawat kwento tungkol sa pinagdaanang mga suliranin, paghihirap at sakripisyo, maging mga paunang tagumpay, ay inspirasyon at huwaran na sa mas marami pang mga local government unit na handang maglingkod sa bayan at baguhin ang kinasasadlakan ng mga kanilang mga mamamayan.



Kaya mga kagalang galang na mga kasama sa Bulwagang ito, ating kilalanin at bigyang pagpupugay ang mga natatanging proyekto ng ating mga LGU na huwaran hindi lamang sa kanilang mga lugar, kundi ng buong sambayanan. Ang kanilang tagumpay ay nagbibigay ng pag-asa sa ating bansa na kaya nating makapagsagawa ng makabuluhang pamamahala sa ating mga bayan.

Congratulations po sa mga Galing Pook Awardees. Mabuhay po kayo.

- "Bataan Public-Private Partnership Programs" of the Provincial Government of Bataan led by Governor Joet Garcia;
- "Balik-Biñan Project: Tourism Development through Heritage Conservation" of Biñan City, Laguna led by Mayor Walfredo Dimaguila Jr.
- "From Black to Green: Fishponds, Eco-Tourism and Full Employment" of Brgy. Cayabu, Tanay, Rizal led by Brgy. Chairman Antonio Bolaños;
- "Trekking to Unlock Community Ailments and Difficulties (TUCAD)" of Goa, Camarines Sur led by Mayor Marcel Pan;
- "I-BIKE: A Program Promoting the Development of the Iloilo City Bike Culture" of Iloilo City led by Mayor Jerry Treñas;

SPONSORSHIP SPEECH OF SENATOR MARCOS

In sponsoring Proposed Senate Resolution No. 469, Senator Marcos delivered the following speech:

In science, it has been said that the opinions of thousands are not worth as much as one tiny spark of reason in an individual man. Dr. Angel C. Alcala was just such a man of reason, of wisdom, and of prophecy.

This afternoon, I am honored to sponsor Proposed Senate Resolution No. 469, expressing this Body's profound condolences on the demise of a staunch advocate for the preservation of our marine environment, a Philippine National Scientist and biodiversity hero, Dr. Angel C. Alcala.

Many times, at the risk of his own life, Doctor Alcala passionately pursued his prescient advocacy of protecting the Philippine marine ecosystem. Starting the First Marine Protected Area (MPA) in Sumilon, Island, Southern Cebu in 1974; Apo Island, Southern Negros in 1982; creating thereafter the Sumilon Marine Reserve and Apo Marine Sanctuaries. These MPAs continue to this day to protect our marine ecosystems and diversity and to promote sustainable fishing in all these areas. Dozens of similar marine reserves in the Bohol Sea and elsewhere, through Dr. Alcala's relentless advocacy and influence, have since flourished and prospered.

From Doctor Alcala, we also learned the concept of community-based coastal resource management as well as the use of artificial reefs in fisheries development. His extensive research on Philippine amphibians and reptiles since the mid-1950s led to the discovery of 50 additional species out of the 400 known species in the country.

He won the Guggenheim Fellowship for Natural Sciences; was awarded the Ramon Magsaysay Award for pioneering scientific leadership in 1992; the Field Museum Founder's Council Award of Merit for his contributions to environmental biology; and became a member in the Fulbright for Philippines Hall of Fame.

Yet, even in his final years, Doctor Alcala lamented the neglect and overexploitation that persisted in the actions regarding our marine resources. Exploiting the award that he received from the ASEAN, he raged at human greed and irresponsibility, and its dire, fatal consequences. Everything in this world, he said, is reduced to business. The resources that are used for business will eventually be gone, extinct, he said.

He emphasized the private sector's biodiversity conservation as one of its most prolific users. Businesses can actually earn and benefit from biodiversity. You do not exceed the limit or the capacity of the resource to cover. The natural resource capital must be kept intact and only production from that capital should be used in establishing MPAs. You produce more fish and you use only the fish produced by the marine reserves. The capital shall forever be left intact.

"For successful biodiversity conservation, the support of the people is needed," he explained. "But more important," he said, "the people will need good leaders to follow." We need the support of people who will lead the people. Agencies of government, policemen, soldiers as good partners, local government, and leaders of the communities are good partners, people close to you and other sectors. We have to involve everybody. Everybody, he said, again and again, should invest in the earth and the seas biodiversity because it is the key to human survival.

Doctor Alcala shall be greatly missed by the nation he served so faithfully and so well, as he is already by the people closest and dearest to him.

The world lost an important scholar, a brilliant scientist, an educator, public servant, and a staunch environmental advocate and leader.

But the Philippines, through him, has gained environmental wisdom and activism through the life of our very own national scientist, Dr. Angel C. Alcala.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva delivered the following manifestation on Proposed Senate Resolution No. 469:

First and foremost, let me put on record that I would like to extend my sincerest condolences to the family left behind by our national scientist, Filipino biologist Dr. Angel C. Alcala. My thoughts and prayers are with you all.

Doctor Alcala, who would have celebrated his 94th birthday today, remains to be a pillar in the field of biological sciences, conducting extensive research on the taxonomy and ecology of amphibians and reptiles since 1955; and introducing the concept of marine protected areas in 1974.



His body of work helped shape policy, including marine protected areas, in our Fisheries Code and the Local Government Code.

Of all the things that he has done in his career as a scientist and academician, Doctor Alcala's greatest legacy is, perhaps, the promotion and advancement of marine protected areas as a means to manage fishery species and allow biodiversity to thrive.

Since introducing the concept in the 1970s, we now have over 1,000 marine protected areas where we can say that its impact can be considered tremendous, not just for biodiversity, but for our people as well.

At this juncture, Senator Ejercito relinquished the Chair to Senate President Pro Tempore Legarda.

As a result of protection, our fisherfolk have more fish to catch, while tourism in these areas have allowed our coastal communities to add another means to earn a living.

Today, Sumilon and Apo islands are a living testament to Doctor Alcala's vision of having a series of marine reserves in all the islands, all contributing to keeping the surrounding seas healthy.

Muli, maraming salamat, Doctor Alcala, for your life well-lived, and may God bless us all.

MANIFESTATION OF SENATOR HONTIVEROS

In expressing her sympathies to the family, friends, and colleagues of Dr. Alcala, Senator Hontiveros stated that scientists were lamentably some of the most unappreciated professionals in the country and that they deserve to be valued more by the public. She believed that Dr. Alcala's passing will be felt most by the fisherfolk and marine ecology sector, whom he had served best. She also said that his work on Philippine coastal resource management and marine protection are invaluable contributions to the Filipino people.

COSPONSORSHIP SPEECH OF SENATOR REVILLA

Upon motion of Senator Villanueva, there being no objection, the Body approved the insertion of the cosponsorship speech of Senator Revilla on Proposed Senate Resolution No. 469 into the Record of the Senate:

I join my colleagues today in expressing our profound sympathy and condolences on the passing of national scientist, Dr. Angel C. Alcala.

A biologist by profession, Doctor Alcala is named the first Filipino ASEAN biodiversity hero and considered father of marine protected areas (MPAs) for his vast contributions in building sanctuaries and promoting biodiversity in the aquatic ecosystems in our country.

He then expressed his hope that more Filipinos will follow in the footsteps of Doctor Alcala.

PRIVILEGE SPEECH OF SENATOR CAYETANO (P)

Availing herself of the privilege hour, Senator Cayetano (P), as the head of the Philippine delegation of the Philippine Women's National Football Team that competed in February 2023 in Murcia, Spain, reported to the Body on her official trip to promote sports diplomacy.

Following is the full text of her speech:

I take the floor to report on my official trip to promote sports diplomacy.

I joined the Philippine Women's National Football Team as their head of delegation as they competed in the 2023 Pinatar Cup in Murcia, Spain.

It was such an uplifting experience to see our girls in action. Our athletes competed against Wales which is ranked 32nd, Scotland which is ranked 25th, and Iceland which is 16th in the international standings. The girls played very well against Wales, the score was just 1-0; against Iceland, it was actually 2-1 and although they lost, it was a great showing and a great experience. This was really the objective of joining the Pinatar Cup. The Philippines, for the record, is ranked 53rd in the international standings.

I am happy to share that Filipinos from different corners of the world also came to cheer for them. There were busloads of our *kababayans* who came all the way from Madrid, Alicante, Valencia, Tarragona, the U.K., and Rome. The chants from the Pinoy crowd were overwhelming and heartwarming, especially in the games against Iceland as it was a weekend and that was when many of our *kababayans* were able to come and support our team.

The team's journey is proof that Philippine women's football has arrived. They made "herstory" by qualifying for the 2023 FIFA World Cup. This is the first time for any Filipino Football team—men's or women's—to secure a spot in the world's most prestigious football game.

Seeing the girls play at a professional level also sends the signal to all, especially the little girls and the little boys that were watching, that women can thrive in sports, which only until recently was considered a male-dominated field. In fact, when I was in college, women's football was not yet a UAAP sport. I do not even know of any organized league that existed at that time, save for a few girls who would just play on the field.

After the football event, I had the opportunity to promote another sport, Padel, which is a sport I recently took up. Padel is considered the fastest growing sport in Europe, if not in the entire world,



where Spain is currently number one. Along with the Philippine Ambassador to Spain, Philippe Lhuillier, I met Spanish Padel Federation President Ramón Morcillo Valle.

As I mentioned earlier in my speech, to be able to have the opportunity to talk to the world's best, to ask how they got to the point where they are, is really a learning experience that I could take home with me, and again, consistent with the mandate of our embassy to promote sports diplomacy.

Meanwhile, in Portugal, I had a similar meeting with Ambassador Celia Anna Feria and Portuguese Federation of Padel President Ricardo Oliveira.

In line with the mandate of the Philippine Embassy in Portugal to promote cooperation between Philippine and Portuguese sports organizations, we discussed the existing cultural agreement between the two countries, with emphasis on sports. Through sports diplomacy, the embassy envisions many opportunities for the Philippines and Portugal to have closer ties.

I also discussed with Ambassador Feria a proposed labor agreement between the Philippines and Portugal that would make it easier for Filipinos to get a working visa in Portugal, since they are in much need of workers especially for their tourism industry.

I glanced at the Majority Floor Leader as I was delivering this, and already he was nodding his head, because I really was going to point this out to him. As we here in the Senate have witnessed the "inhumane" treatment of our *kababayans* in some countries, I actually welcome that there would be a proposed labor agreement between a country like Portugal and the Philippines. Like many of you, I would prefer that our countrymen did not have to leave the country for work. But if they were to leave, I would prefer that they would be in a country like Portugal, that I have seen through my own personal contacts with Portuguese, have very similar values as us and who would truly respect our Filipino workers there. I think there is still work that has to be done to make this a reality, but I hope we will be able to do this.

And also joining us in the discussions was Member of Parliament Ricardo Baptista-Leite, and the one that can be seen in the photo is coach Bryan, who received his training both in Spain and in Portugal.

And then, back to Spain, I had the opportunity to join our *kababayans*, mostly women, in their post-Valentine's Day celebration. It is always a wonderful opportunity to mingle with our *kababayans*, especially this opportunity to celebrate a very special day with them.

So, on that note, that is the end of my report. As I always say, I learned from the best. The late Sen. Nene Pimentel told me to always be sure to report on my official missions as soon as we come back. So, thank you for this opportunity to share the official work that I did.
