**AN ACT
DECLARING AUGUST 11 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY
IN THE PROVINCE OF SAMAR TO BE KNOWN AS "SAMAR DAY", IN
COMMEMORATION OF ITS FOUNDATION DAY**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

- 1 **SECTION 1.** August 11 of every year is hereby declared a special nonworking holiday in
2 the Province of Samar to be known as "Samar Day", in commemoration of its Foundation Day.
- 3 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
4 *Gazette* or in a newspaper of general circulation.
