



AN ACT
DECLARING MARCH 2 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN
THE PROVINCE OF LA UNION TO BE KNOWN AS "LA UNION DAY", IN
COMMEMORATION OF ITS FOUNDING ANNIVERSARY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** March 2 of every year is hereby declared a special nonworking holiday in
2 the Province of La Union to be known as "La Union Day", in commemoration of its founding
3 anniversary.

5 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
6 *Gazette* or in a newspaper of general circulation.
