AN ACT

SEPARATING THE TUKURAN TECHNICAL-VOCATIONAL HIGH SCHOOL – BACLAY EXTENSION IN BARANGAY BACLAY, MUNICIPALITY OF TUKURAN, PROVINCE OF ZAMBOANGA DEL SUR FROM THE TUKURAN TECHNICAL-VOCATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS THE BACLAY NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Tukuran Technical-Vocational High School – Baclay Extension in
2 Barangay Baclay, Municipality of Tukuran, Province of Zamboanga del Sur is hereby separated
3 from the Tukuran Technical-Vocational High School and converted into an independent
4 national high school to be known as the Baclay National High School.

5
6 SEC. 2. All personnel, assets, liabilities and records of the Tukuran Technical-
7 Vocational High School – Baclay Extension are hereby transferred to and absorbed by the
8 Baclay National High School.

9
10 SEC. 3. The Secretary of Education shall immediately include in the Department’s
11 program the operationalization of the Baclay National High School, the initial funding of which
12 shall be charged against the current year’s appropriation of the Tukuran Technical-Vocational
13 High School – Baclay Extension. Thereafter, the amount necessary for the continued operation
14 of the school shall be included in the annual General Appropriations Act.

15
16 SEC. 4. Within ninety days (90) from the approval of this Act, the Secretary of
17 Education shall formulate the rules and regulations implementing the provisions of this Act.
18 Such implementing rules and regulations shall provide for the school’s organization,
19 administration, operations and management, in accordance with Republic Act No. 9155, or the
20 “Governance of Basic Education Act of 2001,” Republic Act No. 10533, or the “Enhanced
21 Basic Education Act of 2013,” and other basic education-related laws.

23 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
24 *Gazette* or in a newspaper of general circulation.
