AN ACT  
CONVERTING THE NABITASAN ELEMENTARY SCHOOL IN BARANGAY NABITASAN, LA PAZ DISTRICT, ILOILO CITY INTO AN INTEGRATED SCHOOL TO BE KNOWN AS THE NABITASAN INTEGRATED SCHOOL, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1 SECTION 1. The Nabitasan Elementary School in Barangay Nabitasan, La Paz  
2 District, Iloilo City is hereby converted into an integrated school to be known as the Nabitasan  
3 Integrated School.

4  
5 SEC. 2. All personnel, assets, liabilities and records of the Nabitasan Elementary  
6 School are hereby transferred to and absorbed by the Nabitasan Integrated School.

7  
8 SEC. 3. The Secretary of Education shall immediately include in the Department's  
9 program the operationalization of the Nabitasan Integrated School, the funding of which shall  
10 be included in the annual General Appropriations Act.

11  
12 SEC. 4. Within ninety days (90) from the approval of this Act, the Secretary of  
13 Education shall formulate the rules and regulations implementing the provisions of this Act.  
14 Such implementing rules and regulations shall provide for the school's organization,  
15 administration, operations and management, in accordance with Republic Act No. 9155, or  
16 the "Governance of Basic Education Act of 2001", Republic Act No. 10533, or the "Enhanced  
17 Basic Education Act of 2013", and other basic education-related laws.

18  
19 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*  
20 *Gazette* or in a newspaper of general circulation.
