EXPLANATION OF VOTE BY SENATOR HONTIVEROS

Pursuant to the manifestation of Senator Villanueva, following is the explanation of the affirmative vote of Senator Hontiveros on Senate Bill No. 1594 which was deemed read and inserted into the *Journal* and *Record of the Senate*:

A short manifestation, just to put it on record.

Under Sec. 11 of the OTOP bill, each LGU is mandated to create OTOP Program Offices.

However, upon inquiry with the sponsor's office, I was informed that this provision will have no adverse effects or unintended consequences for LGUs who are not capable of developing their product offering and/or setting up their own OTOP program offices.

In effect, with the response from the sponsor's office, municipal LGUs with no demonstrated capacities for OTOP may opt out of the program.

I just wanted it to be put on record for consideration by our implementing agencies when they formulate and implement the rules and regulations for the OTOP program.

SPONSORSHIP SPEECH OF SENATOR VILLAR (M)

Senator Villar (M), on behalf of the Committee on Banks, Financial Institutions and Currencies, submitted, and delivered his sponsorship speech for plenary consideration Senate Bill No. 2020, entitled "An Act Establishing the Maharlika Investment Fund, Providing for the Management, Investment, and Use of the Proceeds of the Fund, and for Other Purposes," under Committee Report No. 58:

It is my honor and privilege to sponsor Senate Bill No. 2020 under Committee Report No. 58, otherwise known as the Maharlika Investment Fund Act.

The Philippine economy is now at a critical period of recovery and growth. Before the pandemic, the country was heading toward becoming one of the fastest-rising economies in the region. The government was able to bring infrastructure development back to the fore after years of underinvestment. Our fiscal health was stronger than ever, with our debt-to-GDP ratio reaching a record low of 39.6% in 2019. Reforms to improve our tax system and Ease of Doing Business allowed us to build a business environment conducive to long-term growth.

Our strong macroeconomic fundamentals enabled us to provide support to those who need it most during the pandemic, without significantly compromising our physical health. But the journey toward our long-term goals of reducing poverty and raising the quality of life for all Filipinos may take much longer, if we do not put in the right investments that will give the Philippine economy the momentum to zoom forward. With high inflation and slower economic growth threatening both developed and emerging economies globally, we have to train our eyes on the future.

As policymakers, we have to take bold steps toward exploring measures that will contribute to high growth that cannot be easily reversed by external headwinds and future crises. For this reason, I am urging my fellow lawmakers to consider the passage of the Maharlika Investment Fund Act. This is a timely measure that should be given utmost attention and urgency by this Congress.

As the Philippines' first-ever sovereign wealth fund, it is designed to catalyze economic development by mobilizing government financial assets that are otherwise limited in use by current legal frameworks. With the Fund's dual objectives of optimizing financial returns and accelerating the development of infrastructure and other priority projects in key sectors, this will be an important instrument to generate consistent and stable investment returns to advance the Philippines' long-term development goals.

The Maharlika Investment Fund will support the administration's economic goals set in the medium-term fiscal framework: the Eight-Point Socioeconomic Agenda and the Philippine Development Plan 2023 to 2028, in a way that will ease the pressure on the government's fiscal space.

The Maharlika Investment Fund will quicken the implementation of NEDA-endorsed infrastructure projects. In particular, big-ticket infrastructure, such as in green and blue projects,



countryside development, and other employment-generating projects. Key examples include public road networks, tollways, green energy, water, agro-industrial ventures, and telecommunications. These critical infrastructures offer high-return investments and greater socioeconomic impact on the economy.

Just this month, the NEDA Board, which is chaired by the President, approved 194 high-impact priority projects under the new Infrastructure Flagship Project List for the Build, Better, More Program. The Maharlika Investment Fund will play a key role in accelerating the implementation of these big-ticket projects.

Some of our big-ticket priority projects may be undertaken by Maharlika Investment Corporation through coinvestments with global financial institutions and multilateral partners, opening another corridor for foreign direct investments. This is especially significant, considering that the Philippines will soon lose its access to official development status, as the country graduates to upper middle-income status.

Moreover, sovereign wealth funds are tried and tested investment vehicles used by governments in developed and emerging countries to achieve their economic goals. Having our own sovereign wealth fund will grant us access to the world's sovereign wealth fund community, which is abundant in opportunities for cofinancing and knowledge transfer.

In fact, more than 50 countries already have their own sovereign wealth funds. Some examples include Indonesia, Vietnam, and Kenya. The Indonesia Investment Authority or INA, in particular, is often cited as the ideal model for the Philippines, as it was used for investing in big-ticket infrastructure projects.

Now, allow me to clarify the capitalization requirement for the establishment of the MIF. The initial capitalization of the Maharlika Investment Corporation will come from the investable funds of the Land Bank of the Philippines and the Development Bank of the Philippines, as well as the contributions of the national government. The latter will include dividend remittances of the Bangko Sentral ng Pilipinas; the national government's share of PAGCOR's income; and proceeds from privatization and the transfer of assets. Other sources such as royalties and special assessments may be tapped as well.

LANDBANK's investment to the Maharlika Investment Corporation will only account for around 3.7% of the investable funds, while the DBP's investment will be equivalent to around 3% of its investable funds. These GFIs are likely to earn more than what they are earning now, considering that they are investing in conservative instruments such as government securities. The involvement of these GFIs as contributors of the initial seed fund is reasonable, and will not crowd out the other lending obligations that they need to fulfill under their respective mandates.

In fact, the expected return of Maharlika, which is estimated to be around 8.6% on average, is much higher than their cost of capital and the return in their current investment placements. Globally, capitalization of sovereign wealth funds is no longer limited to surplus revenues generated by national resources. It also includes varying sources including budgetary contributions, as in the case of the Indonesia Investment Authority.

As a government-owned and -controlled corporation, the Maharlika Investment Corporation will be run professionally and on a commercial basis. It will pay taxes; be governed by the Government Procurement Reform Act and its rules; and shall be subject to the provisions of the GOCC Governance Act of 2011.

To ensure that these gains will be realized, the Fund will be established with the highest standards of accountability, fiscal responsibility, and good governance. The proposed Fund will adhere to the Santiago Principles, which pertain to the generally accepted principles and practices to ensure the effective operations of sovereign wealth funds globally; and will be governed by the relevant investment and risk management guidelines.

The Maharlika Investment Corporation would be governed by a Board of Directors with nine members. The Secretary of Finance will serve as the chairperson, while the CEO of Maharlika Investment Corporation will be the vice chairperson. Members include the President and CEO of the Land Bank of the Philippines and Development Bank of the Philippines; two regular directors;



and three independent directors from the private sector. The economic team will work closely with the Fund's administrators as its advisory board to help ensure that they will comply with proper financial reporting and auditing standards. This is also to align investment decisions with fiscal and monetary policies.

The Advisory Board shall be composed of the Secretary of the Department of Budget and Management, the Secretary of National Economic and Development Authority, and the National Treasurer. To ensure a level playing field, the exemptions and privileges were removed from the originally filed bill. The transactions and assets of MIC and the MIF shall be subject to local and national taxes.

Other than matters relating to the organization's structure, staffing pattern, and compensation structure, the MIC shall be subject to the provisions of RA 10149, or the GOCC Act of 2011. All procurement activities shall be subject to and governed by the provisions of RA 9184, or the Government Procurement Reform Act, except in the engagement of professional or technical services necessary for the selection of investments.

Now, in order to ensure accountability and proper governance of the Fund, several layers of oversights will be put in place: 1) The Board is required to appoint an internal auditor, which shall be independent from the management of the MIC and shall be under the direct control and supervision of the Board of Directors; 2) an internationally recognized audit firm will serve as the external auditor for the Fund to audit its financial statements; 3) the books and accounts of the funds shall be subject to the strict examination by the Commission on Audit; and 4) a joint Congressional oversight committee will be constituted to oversee, monitor, and evaluate the implementation of the MIF Act. This committee shall be composed of five members each from the House of Representatives and the Senate.

Finally, as an additional measure for transparency, all documents of the Fund in the Maharlika Investment Corporation shall be open, available, and accessible to the public.

I would like to emphasize that the Maharlika Investment Fund has the potential to bring back the Philippines to its high-growth trajectory through investments in the country's developmental projects. Not only will this promote the effective intergenerational management of the country's financial resources, but more importantly, improve the welfare of future generations of Filipinos.

Ultimately, the Philippines will benefit from a well-structured, robust, and effective sovereign wealth fund. The Maharlika Investment Fund has the potential to attract foreign investments, boost national savings, and advance economic growth for Filipinos across generations. And with that, I would like to solicit the full support of my colleagues for the passage of this bill.

No other name is more apt for this competition other than the battle of the golds. One should be a gold medalist in the Hong Kong International Mathematical Olympiad, Thailand International Mathematical Olympiad, or the Guangdong Greater Bay Area Mathematical Olympiad just to be eligible, I will repeat it, just to be eligible to participate in the prestigious World International Mathematical Olympiad.

These mathletes, through their grit and hard work, superbly stood out among gold medalists from 14 countries as they competed in logical thinking, Arithmetic or Algebra, Number Theory, Geometry, and Combinatorics.

This great celebration becomes more meaningful as we implement educational programs and reforms to improve our learners' knowledge and skills critical for the 21st Century world. I could not help but remember an old adage: "Life is a Math equation. In order to gain the most, you have to know how to convert negatives into positives."

The dismal results the country has received in Program for International Students Assessment (PISA) and the Trends in International Mathematics and Science Study (TIMSS) now became the solid springboard, which drew up a clear direction for the future of the Philippine educational system, which is now being shaped by the Education Commission, headed by our chairman, Sen. Win Gatchalian. We just had a technical joint meeting last Thursday with Senators Angara and Cayetano (P).



With this "matherrific" Filipino students, we can see a bright future for Math, for STEM, for education, and for the Philippines as a whole. COSPONSORSHIP SPEECH OF SENATOR REVILLA

In cosponsoring Proposed Senate Resolution No. 429, Senator Revilla delivered the following speech:

I join our colleagues in honoring our young Math wizards for their impressive medal haul in the World International Mathematical Olympiad.

Masasabing isa sa pinakamahirap na subject ang Math, subalit ipinamalas ng isangdaan pitumpu at walo nating delegado sa Thailand ang kanilang husay sa naganap na kompetisyon ng pagalingan sa Matematika. Sa murang edad, ang kanilang galing sa numero ay tunay namang world class.

Our team's exemplary win gained 138 medals in total: 19 gold, 52 silver, and 67 bronze, besting 13 other countries that qualified for WIMO 2023. Sa musmos nilang edad, pinatunayan nila na tunay na "Math-tinik" ang kabataang Pinoy, na kahit pa tayo ay itinuturing na third world country, ang hanay ng ating mga kabataan ay maituturing na first class at tunay na maipagmamalaki—kayang-kayang makipagsabayan, kayang-kayang makipagpaligsahan, at kayang-kayang magwagi sa laban sa ibang mga bansa. Kahanga-hanga ang kanilang naging tagumpay.

Sa ating mga batang Math geniuses, ang aking pagsaludo sa bawat isa sa inyo. Ipagpatuloy ninyo ang paghasa ng inyong galing at ipinagmamalaki namin kayo. Mabuhay kayong lahat.

MANIFESTATION OF SENATOR PIMENTEL

Senator Pimentel expressed his congratulations to the 19 Filipino gold medal student recipients at the World Mathematical Olympiad, revealing that as a student, he only reached the Metro Manila Olympiad level, whereas the honorees reached the World Math Olympiad level. He assured the young mathematicians of the senators' full support and expressed hope that they would serve as good role models and encourage other students to be interested in Math, Science, and Reading, especially given the dismal performance of Filipino learners in international assessments.

He likewise lauded Senator Villanueva for filing the resolution to honor the awardees.

COSPONSORSHIP SPEECH OF SENATOR DELA ROSA

In cosponsoring Proposed Senate Resolution No. 429, Senator Dela Rosa delivered the following speech:

I rise today to cosponsor Proposed Senate Resolution No. 429, congratulating the 19 Filipino students who were awarded gold medals at the World International Mathematical Olympiad.

Napakabigat na kompetisyon ito. Mathematical na, world pa.

There is an online article, entitled "Why Filipino Students Hate Math?" The word is not even "dislike." The word used in the article is "hate." Kinamumuhian ng maraming mag-aaral ang

matematika. Maraming estudyante ang nahihirapan sa math, kasama na ako roon sa mga estudyante na iyon.

When I enrolled at the Mindanao State University, iyong aking kurso na in-enrol, kasi naging scholar ako roon, was Bachelor of Science in Electrical Engineering. After the first semester, hirap na hirap ako sa Math 17. Parang almost pasang-awa—tres iyong nakuha ko. So, realizing that I will not be able to maintain the required average grade in order for me to maintain my scholarship, I decided to shift to another course na walang mathematics, iyong B. S. Public Administration na walang math. Kaya humahanga talaga ako sa mga batang ito, kaya napilitan talaga akong mag co-sponsor sa kanilang galing.

Among the reasons identified in the article is the pressure and anxiety that envelope the teaching of math, and it is also this pressure and anxiety that gets handed down from parents, teachers, down to our children and their students.

Sa tingin ko, marami sa mga kabataan ay natatakot sa math dahil natatakot silang magkamali. Marahil, naranasan nilang mapahiya, o mapagalitan dahil nagkamali sila. I think it is in this space of being open to making mistakes that our children can begin to learn to love mathematics. Kapag nakita nila na ang pagkakamali ay bahagi ng pagkatuto, at kapag nakita nila ang kahalagahan ng math lalo na pagdating sa problem-solving, mas maiintindihan din nila na ang galing sa math ay nasusukat sa kakayahan ng isang taong tanggapin ang pagkakamali, at mas pagbutihin na ang gawain sa susunod na pagkakataon.
