May isang awitin po ang bandang Asin na ang pamagat ay Masdan Mo Ang Kapaligiran— "Lahat ng bagay na narito sa lupa, Biyayang galing sa Diyos kahit no'ng ika'y wala pa. Ingatan natin at 'wag nang sirain pa, 'Pagkat pag Kanyang binawi, tayo'y mawawala na." This song was written and performed many years ago, way back when I was around 16 years old and yet, its message still rings true.

Environmentally, we stand at a very precarious position. On one hand, the Philippines can still boast of being a biological storehouse, being home to what may be considered the greatest concentration of unique species per unit area in the whole world. On the other hand, we are also quick to threaten this biodiversity, with our pollution, trafficking, and unsustainable practices.

I said it in the previous speech, and allow me to repeat: Thank God for the leadership of Sen. Loren Legarda. Today what we truly need is a leader who will fight for the preservation, conservation, and enrichment of our natural resources. *Tunay na naisapuso ni Sen. Loren na ang lahat ng mayroon tayo ay biyaya ng Diyos sa atin kaya nararapat lamang na ating pangalagaan.*

With that, I humbly congratulate Sen. Loren on this well-deserved Biodiversity Hero Award, and I wish that more leaders will follow her lead.

MANIFESTATION OF SENATOR HONTIVEROS

In expressing support to Senate Concurrent Resolution Nos. 6 and 9, Senator Hontiveros stated that the word "commendatore" (commander) refers to a member of an Italian honorary order of chivalry who ranks next above an officer and next below a grand officer, and "chivalry" refers to the medieval knightly system with its religious, moral, and social code, or combination of qualities expected of an ideal knight, especially courage, honor, courtesy, justice, and readiness to help the weak. She said that as a fellow woman-leader, Senator Legarda truly lived in accordance to the greatness given to her by the Italian Republic.

SPONSORSHIP SPEECH OF SENATOR LEGARDA

In sponsoring Proposed Senate Resolution No. 547, Senator Legarda delivered the following speech accompanied by a slide show presentation:

It is with deep sense of pride and honor to sponsor the resolution congratulating and commending Larry Apolinario for his exceptional performance and for becoming the champion of the First Philippine Trail Running Association (PHILTRA) National Championships.

I would like to congratulate Larry Apolinario, a proud fellow Antiqueño, and the 2023 champion of the first-ever Philippine Trail Running Association National Championships. The Philippine Trail Running Association National Championships was held on February 26, 2023 at Bontoc, Mountain Province.

At the age of 26 years old, Larry prevailed over the country's elite trail runners and made history as the inaugural champion of the 42-kilometer mountain marathon that featured a trail course of more than 3,000 meters of elevation gain. Larry finished the grueling marathon in only five hours, forty-seven minutes, and nine seconds.

Finishing a 3,000-meter mountain marathon in such an amount of time is not an endeavor of the lighthearted. Today, I commend Larry's strength, determination, grit, and perseverance for remaining steadfast in his pursuit of a professional trail running career despite several of life's challenges.

Proudly hailing from the Iraynon-Bukidnon community in Barangay Capnayan, Municipality of Laua-an in Antique, Larry started from humble beginnings and has relentlessly persisted to reach his trail running dreams.

Larry is the seventh child among eleven children of a modest family. He is currently the first *kagawad* of his barangay, a farmer, a part-time motorcycle driver or a "*habal-habal*" driver, and is a local guide for mountaineers and tourists going to the Mt. Igmatongtong, which is a beautiful hiking destination located in Brgy. Capnayan, Laua-an. This is perhaps a trek that Sen. Pia Cayetano might want to try in the coming weeks.

His first race was the inaugural Tracing Iraynon-Bukidnon Trail (TIBT) in 2017 where he finished only minutes before the champion. After the 2017 TIBT, Larry gradually dominated the local and international trail running scene by winning several championships, garnering multiple awards, and breaking course records. Just last year, Larry was able to compete in his first international trail running competition that was conducted in Hanoi, Vietnam.

In his interviews, Larry would express his sincere desire to bring pride to the Philippines, but especially to his home province of Antique and his Iraynon-Bukidnon community. The Iraynon-Bukidnon community is one of the local indigenous communities in the province of Antique. I am truly delighted by Larry's success and his sense of origin. I have also supported and long advocated for the welfare and continual support of my fellow Antiqueños and its IP communities.

Having sponsored Republic Act No. 10689 which declared August 9 as National Indigenous People's Day, I believe that the recognition and protection of the rights and causes of our IPs are crucial in achieving inclusive growth and genuine nation-building. Our IPs play a vital role in national development, and we must always push for the provision of adequate support to programs that support their growth.

As exhibited by Larry, Filipinos have a huge potential in dominating the international trail running scene. I believe in our athletes' excellence and that is why I did not think twice about helping Larry with his provisions, but we need more government programs that support the development and training of Filipino athletes and IPs who are active in sports.

Despite Larry's exceptional success, there is still much to be done in order to ensure that more indigenous persons would have access to programs and initiatives to build their strength and develop their potential. In this way, we would be encouraging and stimulating the careers of the future Larry Apolinarios.

By successfully besting elite trail runners and by entering multiple elite competitions, Larry Apolinario has brought pride and honor to the Philippines, and the Iraynon-Bukidnon community.

Larry not only serves as an inspiration to his community but also all Filipinos, especially the Indigenous Peoples community, to continuously aim for their dreams and to believe in their full potential.

This afternoon, we celebrate and congratulate the 2023 PHILTRA champion, Larry Apolinario.

Nahanap at nabigyan ng parangal ang mga unang awardees sa tulong nina former NYC chairperson Mabel Villarica Mamba and former NYC Commissioner at ng dating kasamahan natin, Sen. Bam Aquino.

Pang-dalawampung batch ng TAYO awardees ang pinaparangalan natin ngayon. Ibig sabihin, higit sa dalawang dekada nang tumatakbo ang TAYO Foundation. Ibig sabihin, hindi siya ganoon kabata, hindi rin siya ganoon katanda.

Kahanga-hanga na sa loob ng panahong ito, aabot sa 380 youth organizations ang nabigyan ng parangal at higit sa limang libong grupo ang napapabilang sa nationwide network nito. Kasama rito ang mga tanyag na grupo tulad ng Street to Schools, Mga Tala at Tula, GoodGov PH, the Association of Young Environmental Journalists, Center for Sustainability PH Inc., One Million Lights Philippines, A-HA Learning Center, at marami pang iba.

Pang-apat po, ang Leader's Council ng Scouting Officers organization ng Sacred Heart School ng Ateneo de Cebu University sa pangangasiwa ni Therese Erlyn Napuli. Nagwagi ang organisasyon na ito dahil sa kanilang Love to Learn: Learn to Earn community program na tumutulong sa mga tinatawag na Children in conflict with the law (CICL) para hindi na sila mapasabak sa krimen muli.

Pang-lima po, ang Open Arms Organization na pinapangatawan ni Rod Charlie Delos Reyes. Ang Open Arms Organization ay isang non-profit na registrado sa SEC na sinimulan ng isang barkada na taga-Batangas City para tumulong sa mga sector na nahihirapan. Sa pamamagitan ng kanilang flagship project, ang Embrace a Child program, nais nilang bigyan ang mga mahihirap na pamilya ng access sa mga rehabilitation services at social programs.

Pang-anim po, ang PINTAKASI na pinapangatawan ni Gabriel Villaruel. Ito ay non-profit multi-arts organization na nakabase sa Alabat Island, Quezon Province. Nagsisilbing tagpuan ang organization ng mga artists at malikhaing indibidwal ng Alabat Island. Siya rin ang nangunguna sa pag organisa sa Buwan ng Sining or Arts Month kung saan puwedeng itanghal ng mga artist ang kanilang mga obra.

Pang-pito po, ang Project TALA organization na pinapangatawan ni Mark Matta Sotto. Ang Project TALA ay isang grupo ng mga volunteer sa Isabela Province na nagsagawa ng mga awareness at advocacy campaigns hinggil sa HIV-AIDS sa pamamagitan ng mga dula at pang teatrong palabas.

Pang-walo ay ang SK ng Barangay Talomo River sa Davao del Sur sa pangangasiwa ni SK Chairperson Leonieljun Aresco. Ang SK ay isa sa 182 na SK ng Davao City. Nagwagi sila dahil sa Project Descartes nila na isang libre na online enrichment at tutorial program sa limang pre-Calculus subject para sa mga interesadong senior high school at freshman college students.

Pang-siyam po, ang Shafaat Agriculture Cooperative na pinangungunahan ni Sittie Asia Mai. Umusbong ang kooperatiba mula sa Mushroom for Change Social Enterprise na nagbibigay ng dagdag na pagkakakitaan ang mga low-income farmers sa bayan ng Ditsaan Ramain, Lanao del Sur. Sa pamamagitan ng kooperatiba na nagtatanim ng mushroom, nagkakaroon ng additional income ang mga magsasaka pati ang mga internally displaced people (IDP) mula sa Marawi at ang mga out-of-school youth (OSY).

At this point, Senate President Zubiri invited Larry Apolinario, winner of the 2023 PHILTRA National Championships, and the Ten Accomplished Youth Organizations to the podium for a photo opportunity.

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 4:24 p.m.

RESUMPTION OF SESSION

At 5:05 p.m., the session was resumed with Sen. Ejercito presiding.

COAUTHORS

Senator Villanueva manifested that Senators Tolentino and Go were coauthors of Senate Bill No. 1480.

COMMITTEE REPORT NO. 11 ON SENATE BILL NO. 1480

(Continuation)

Upon motion of Senator Villanueva, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 1480 (Committee Report No. 11), entitled

AN ACT RATIONALIZING THE DISABILITY PENSION OF VETERANS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 6948, ENTITLED, AN ACT STANDARDIZING AND UPGRADING THE BENEFITS FOR MILITARY VETERANS AND THEIR BENEFICIARIES, AS AMENDED.

Senator Villanueva stated that the parliamentary status was the period of interpellations.

Thereupon, the Chair recognized Senator Estrada, sponsor of the measure, and Senator Pimentel for his interpellation.

INTERPELLATION OF SENATOR PIMENTEL

Preliminarily, Senator Pimentel noted that the measure would amend an existing law, Republic Act No. 6948, which was amended by Republic Act No. 7696. Moreover, he noted that under the proposed measure, veterans with disability ratings between 10% to 30%, who were initially receiving a monthly pension of P1,000, would receive P4,500; and those with a disability rating of 100% would receive P10,000, an increase from their current monthly pension of P1,700.

Asked by Senator Pimentel as to when the last adjustment to the disability pension was made, Senator Estrada stated that the benefit was last amended in 1994 with Republic Act No.7696. On that note, Senator Pimentel believed that it was high time an update on the law was made.

Asked if the proposed increase in monthly disability pension had taken into account the inflation rates since 1994, Senator Estrada stated that the current value of P1,000, which was the minimum amount of the benefit, would be around P287, a significant decrease in their purchasing power. Senator Pimentel opined that the amounts stipulated in the bill could be advantageous to disabled veterans, if inflation rates were factored into the adjustment. Senator Estrada concurred.

Senator Pimentel then inquired as to the rationale for the deletion of the phrase "unless he is actually receiving a similar pension for the same disability from other government funds or from the United States Government" from lines 6 to 9 which on page 1 of the proposed bill. He noted that the phrase was not deleted at the time Republic Act 7696 amended the original law.

In response, Senator Estrada clarified that while Congress, with the passage of Republic Act No. 9499 in 2008, had already allowed Filipino World War II veterans to continue receiving pensions and benefits from the Philippine government regardless of similar pensions provided by the United States government, Filipino veterans were not receiving a similar pension for their disability from other government funds other than what they receive from the Philippine Veterans Affairs Office (PVAO). In this regard, Senator Pimentel opined that if the intended consequence was the explanation provided by Senator Estrada, then he would agree to delete the phrase on page 1, lines 6 to 9 of the bill.

Senator Pimentel underlined additional provisions of the mother law, Republic Act No. 6948, that also mention "the United States Government," particularly Sections 10, 11, and 20. He proposed, in the interest of consistency, that the phrases in the aforementioned provisions be deleted as well, believing that the provisions could limit the right or opportunity of Filipino veterans to obtain compensation from the U.S. government. Senator Estrada replied that he was open to the proposal of reviewing the entire mother law in order to maximize the benefits provided to Filipino veterans. Senator Pimentel also reminded Senator Estrada of the Constitution's "one subject, one title rule." He thanked Senator Estrada for being receptive to his proposal.

At this point, Senator Pimentel queried if there had been disputes arising from the disability rating system being used by the Philippine government. Senator Estrada replied in the negative. Asked further if the government had not bothered to devise its own rating system because it was already satisfied with the existing U.S. system, Senator Estrada replied in the affirmative. He then said that all applications for disability pension would be referred to the PVAO Disability Rating Board, which would determine the extent of the veteran's disability based on the findings of the Disability Discharge Board and the individual's clinical records. In addition, he stated that the decision would be consistent with the U. S. Department of Veterans Affairs' Schedule for Rating Disabilities.

As to the proposed measure's projected budgetary impact, Senator Estrada noted that from April to December 2023, P327.14 million would be required to execute the proposed adjustments to the disability pension of Filipino veterans. He said that the amount could be covered by the appropriations in the Pension and Gratuity Fund administered by the PVAO and, thus, no appropriation would be required for that fiscal year.

Asked if the enactment of the measure would necessitate an additional amount of P400 million per year, Senator Estrada replied that the increase in disability pension could be absorbed by the Pension and Gratuity Fund administered by the PVAO, on account of its yearly infusion by the Department of Budget and Management (DBM) amounting to P10 billion, which was rarely being used.

Senator Pimentel then sought clarification on whether the same transfer of P10 billion to the PVAO in the following year would be sufficient to cover the new disability pension rates proposed in the bill. Senator Estrada responded affirmatively. Inquired as to length of time that the PVAO has received surplus funds, Senator Estrada responded that the fund was also utilized for the veterans' hospitalization. Senator Pimentel believed that it would be problematic if the P400 million budgeted for disability benefits had a substantial impact on the amounts allocated for hospitalization expenses.

Senator Estrada informed the Body that the DBM had only allocated P100 million for the hospitalization benefits of veterans, despite the fact that hospitalization costs were estimated to exceed P300 million. In light of this, he asked the Body to consult with the DBM over the prospect of appropriating additional funds for the purpose. Senator Pimentel thanked Atty. Rolando Villaflor, Chief of the Legal Affairs Division of the PVAO, for providing information on the matter. Subsequently, he emphasized that while it may be essential to expand government's support for

veterans' disability benefits, it would be ideal if the Pension and Gratuity Fund could absorb the additional equivalent expense. He then expressed his support for Senator Estrada's request for an increase to the existing P10.858 billion fund. He reiterated his earlier opinion on the potential impact of the allocation of disability benefits on the hospitalization funds intended for veterans.

After conferring with PVAO, Senator Estrada stated that the funds allocated for hospitalization expenses will come from the Maintenance and Other Operating Expenses (MOOE) and not from the Pension and Gratuity Fund. In that regard, he stated that said fund had remained intact throughout the years. Giving a brief overview of its funding allocation, he informed the Body that in 2018, the DBM allocated P10.1 billion to the fund; in 2019, P10.18 billion; in 2020, P10.858 billion, or a difference of P609 million; in 2021, P9.6 billion; in 2022, P10.8 billion; and finally, in 2023, P10.8 billion. In addition, he stated that although the DBM gave the PVAO P10.8 billion in 2022, the actual expenses or obligations were only P9.8 billion, resulting in a surplus of P1.028 billion, which he believed might be used to fund the disability pension increase for Filipino veterans.

Regarding the last paragraph on Pension Rates in the mother law, which is Section 5, paragraph (h) of Republic Act No. 6948; and which appeared from page 2, line 30 to page 3, line 14 of the measure, Senator Pimentel noted that there were proposed deletions on page 3, lines 4 to 5 regarding the phrases "with or" and "or non-service connected." He expressed concern that deleting the words "with or" and the phrase "or non-service connected" might result in a more restrictive provision compared to the original version which covers all veterans who have reached the age of 70. Senator Estrada explained that under the bill, veterans with 100% service-connected disability would receive the adjusted disability pension of P10,000, whereas those without a service-connected disability would still be entitled to a monthly pension of P1,700. He further clarified that it is only the P500 benefit for the veteran's spouse and for each of his unmarried minor children that was being proposed to be rationalized.

On whether 70-year old veterans would still be entitled to the maximum disability pension regardless of whether or not they have an actual disability, Senator Estrada replied in the affirmative.

Asked if a 70-year old veteran is considered to be totally disabled and would be entitled to the 100% monthly pension equivalent to P10,000 a month, he clarified that the 100% disability rate or P10,000 monthly pension would only be for veterans with actual disabilities, such as those who lost their hands and limbs, or those with amputated extremities.

Responding to further queries, he stated that he had been informed by the resource person that the deletion of the words "with or" would not cause any problems. Senator Estrada reiterated that under the measure, veterans with 100% service-connected disability would receive the adjusted disability pension of P10,000 while those aged 70 years old without service-connected disability would be entitled to a monthly pension of P1,700. He affirmed that the phrase "non-service connected" had been deleted because a veteran who reaches the age of 70 is deemed to be totally disabled and shall be entitled to receive P1,700 per month.

Senator Pimentel reiterated that he would further study the bill, as he believed that increasing the veterans' disability pension was long overdue. He then lauded Senator Estrada for sponsoring the measure and expressed his full support for it.

SUSPENSION OF SESSION

PRIVILEGE SPEECH OF SENATOR CAYETANO

Availing herself of the privilege hour, Senator Cayetano (P) delivered the following speech urging Congress to review several discriminatory laws against women:

It is Women's Month and we celebrate as often, anywhere and everywhere, as we can.

I take this opportunity to discuss a concern that I have raised in the previous congresses, and these is the need to review discriminatory laws against women.

I chaired the Committee on Women, Children, Family Relations and Gender Equality for six years, and during this period, I had the opportunity to review these laws.

The Constitution is very clear that the State recognizes the role of women in nation building and shall ensure the fundamental equality before the law of women and men. We also have our Magna Carta of Women and the Philippines also ratified the Convention on the Elimination of all forms of Discrimination Against Women. These are the reasons why the Philippines often ranks as one of the most gender-equal countries globally based on the Annual Gender Gap Report published by the World Economic Forum. So, we do what we can but there is still room for improvement. We have been regressing in gender parity in the last few years.

As legislators, our primary job is to ensure that we pass laws that advance the status and protect the rights of women. However, while we do this, we must also acknowledge that the laws with provisions that are discriminatory against women are relics from the past and must be amended or repealed.

At the beginning of the Nineteenth Congress, I filed Proposed Senate Resolution No. 25, which directed the Committee on Women, Children, Family Relations and Gender Equality and

other appropriate committees to conduct a review, in aid of legislation, on these precise laws with such provisions that are discriminatory.

The outcome from previous Congresses is as follows: In the Fourteenth Congress (2007 to 2010) and the Fifteenth Congress (2010 to 2013), we did have these committee hearings that I mentioned, and, again, in the Sixteenth Congress (2013 to 2016).

The review of the previous Congresses resulted in the repeal of Article 351 of the Revised Penal Code, which used to penalize premature marriages, and amendment of the Anti-Mail Order Bride Act.

We still have existing laws which are discriminatory or contain distinctions, exclusions, or restrictions against women. This is Article 14 on parental consent of the Family Code – this is all on the Family Code – Article 96 on Joint Administration of Community Property; Article 124 on Joint Administration of Conjugal Property; Article 211 on Joint Parental Authority; and Article 225 on Joint Legal Guardianship Over the Property of the Unemancipated Common Child.

In these provisions, it is the man, it is the husband, who is given these responsibilities. Why? No other reason than he is the husband and he is the man. In many cases, and in many families, the woman is actually more involved in these matters and it is the man who is given this decision-making role. So, these are things that we really need to review.

In the Revised Penal Code, there is Article 333 on adultery, Article 334 for concubinage, and Article 247 on death or physical injuries under exceptional circumstances.

I understand that no less than our Majority Leader filed a bill in his first term as Member of the House of Representatives wherein the law seeks to equalize the penalty for marital infidelity.

There are also provisions on the Code of Muslim Personal laws.

So, to conclude, as chairperson of the Committee on Sustainable Development Goals, Innovation and Futures Thinking, this representation is committed to building a more sustainable future for women and their children and, as I always say, the goal is not to give preference to women; the goal is to create gender partnership. We give preference to women because, like other sectors that have been traditionally given less opportunities, that is the reason why we create opportunities for them to rise above the discriminatory practices that they have experienced in life. But the ultimate goal is gender equality among all.

So, with that, I end my speech knowing that I am in good company. Our male colleagues here have always shown support and, at the proper time, I believe the chairperson of our Committee on Women, Children, Family Relations and Gender Equality will be able to hear this, we have had discussions in the past, and I think we will have the support of our colleagues on this.

Thank you, and Happy Women's Month to all of us.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva expressed his support for the measure and confirmed that he had filed the Anti-Marital Infidelity Bill when he was a Member of Congress in 2002. He recalled that the measure had been passed on Third Reading by the House of Representatives, but was not passed by the Senate. He stated that he has filed Senate Bill No. 1140, which seeks to remove the unequal treatment between the crimes of adultery and concubinage, in the Nineteenth Congress.

MANIFESTATION OF SENATOR HONTIVEROS

Senator Hontiveros stated that as chairperson of the Committee on Women, Children, Family Relations and Gender Equality, she valued the advocacy put forth by Senator Cayetano (P) in her privilege speech, and expressed her appreciation for the support of both women and men Members of the Senate.

Senate President Zubiri conveyed his support for gender parity in the law as well.

REFERRAL OF SPEECH TO COMMITTEE

Upon motion of Senator Villanueva, there being no objection, the Chair referred the privilege speech of Senator Cayetano (P) to the Committee on Women, Children, Family Relations and Gender Equality.

SPECIAL ORDER

Upon motion of Senator Villanueva, there being no objection, the Body approved the transfer of Committee Report No. 60 on Senate Bill No. 1615 from the Calendar for Ordinary Business to the Calendar for Special Orders.

COMMITTEE REPORT NO. 60 ON SENATE BILL NO. 1615

Upon motion of Senator Villanueva, there being no objection, the Body considered, on Second Reading, Senate Bill No. 1615 (Committee Report No. 60), entitled

AN ACT RECOGNIZING THE MUNICIPALITY OF BALER IN THE PROVINCE OF AURORA AS THE "BIRTHPLACE OF PHILIPPINE SURFING."

Pursuant to Section 67, Rule XXIII of the *Rules of the Senate*, with the permission of the Body, upon motion of Senator Villanueva, only the title of the bill was read without prejudice to the insertion of its full text into the *Record of the Senate*.

The Chair recognized Senator Angara for the sponsorship.

SPONSORSHIP SPEECH OF SENATOR ANGARA

In sponsoring Senate Bill No. 1615, Senator Angara delivered the following speech:

Kami po ay tumatayo ngayon para i-sponsor ang Committee Report No. 60 para ideklara ang aming bayan ng Baler sa probinsiya ng Aurora bilang "birth place of Philippine surfing." Ito ay counterpart ng House Bill No. 5961 ni Aurora Representative Rommel Angara sa Kamara de Representante along with 60 other coauthors, at itong panukala ay pumasa sa Third Reading noong nakaraang November 21, 2022.

Kilala ang bayan ng Baler bilang isa sa mga tanyag na tourist destinations ng bansa na umusbong sa nakaraang dekada. Isa sa mga pangunahing dahilan kung bakit bumibisita ang mga turista ay para mag-surfing sa mga matataas na alon ng Sabang Beach, Cemento Beach, Charlie's Point at iba pang mga surfing spots sa probinsiya ng Aurora.

Sa katunayan, punong-puno ng mga kilalang surfing spots ang bansa natin bukod sa Baler, tulad ng Pagudpud sa Ilocos Norte, San Juan sa La Union, Daet sa Camarines Norte, Calicoan sa Eastern Samar, at General Luna sa Siargao. May kanya-kanyang pananaw o opinyon kung alin dito ang pinakamaganda. Pero namumukod-tangi ang Baler dahil kinikilala ito bilang pinakaunang lugar kung saan may nag-surfing sa mga alon ng Pilipinas at nag-organisa para dito.

Amerikano Missionaries

Ayon sa pahayag ng ating mga resource persons, simula 1969 pa, pinupuntahan na ng mga misyonaryong dayuhan ang Baler para mag-surfing. Binansagan bilang mga "Amerikano," kahit na iba-iba ang kanilang nasyonalidad, ang mga misyonaryong ito ay ang mga unang tumulong at nag-udyok sa mga taga-Baler na sakyan ang mga alon sa Sabang Beach.

The Travels of Steve Scott

Unti-unti itong nagbago sa paglipas ng panahon. Ayon sa paglalahad ni Steve Scott, isang Amerikanong surfer na nakatira sa Subic Naval Base, binisita raw niya at ng kanyang mga kaibigan ang Baler noong taong 1972, dala-dala ang unang modernong surfboard. Iniwan ni G. Scott ang surfboard niya sa Baler at napunta raw ito sa mga bata ng Baler.

Apocalypse Now

After Mr. Scott's visits, there are other accounts of foreigners visiting Sabang Beach in 1975 ostensibly to scope out the area and surf. But the story between Baler and surfing took a deeper turn in the year 1976, when world-renowned director Francis Ford Coppola chose the remote beach town as the main filming location for his multi-awarded Vietnam War epic "Apocalypse Now."

For the film, Baler was dressed up to be a seaside Vietnamese village. Some shooting days even included helicopters, jet planes, and explosions to simulate the ravages wrought by the Vietnam War. Film buffs might remember the memorable character, Colonel Kilgore, played by the great Robert Duvall, who notoriously said: "I love the smell of napalm in the morning."

In the same scene where he said the famous line, Colonel Kilgore ordered some of his men to surf the waves even while they were being shot at by their enemies, off-camera. Cut scenes of the men surfing amid the gunshots and explosions were of the waves that many Baler surfers enjoy today in a location called "Charlie's Point." This is the same area where the famous "Ride of the Valkyries" scene was shot. Here is a short clip.

Iniwan ng mga crew member ng Apocalypse Now ang kanilang mga surfboards para magamit ng mga batang Baler. Sa puntong ito talagang nagkaugat ang pagmamahal ng mga taga-Baler sa surfing. Sa paglipas ng mga taon, lalong umusbong at lumago ang mga surfing activities nila.

Nagsimulang burnuo ng mga local surfing groups ang mga taga-Baler hanggang sa napansin ito ng mga international surfing organizations. In August 1983, opisyal na itinatag ang Philippine-USA Surfing Cultural Exchange sa Baler ang NSSA-Philippine and Interscholastic Surfing Competition, at iilang mga "Baler Boys" ang hinikayat na sumali, kasama si Lysander Quertijero, at Edmund "Djanggo" Mendoza, a local surfing legend.

Mahalagang sabihin ang punto na ang pinakaunang Philippine surfing team na pinili ng Department of Tourism noong 1986 ay binuo ng tatlong taga-Baler. Naulit ito noong 1987, kung saan pitong taga-Baler ang pinili para sa Philippine Surfing Team. Nangyari uli ito noong sumunod na mga taon, at hanggang ngayon po madalas may mga taga-Baler na sumasali sa mga international surfing competition.

Sa madaling salita, sa pamamagitan ng panukalang batas, nais nating kilalanin ang Baler bilang pinakaunang lugar sa Pilipinas kung saan umusbong at naging organisado ang surfing bilang isang pormal na sport.

Ultimately, in pushing for this declaration, we seek to provide our hometown Baler with a policy tool from which they can entice more visitors and boost its tourism, which is one of the municipality's major industries. And by recognizing Baler as the birthplace of Philippine surfing, in no way do we seek to diminish or disregard the vital role which other surfing destinations continue to play in deepening Filipinos' love for the sport and in raising the country's international profile in it. We merely seek to leverage the characteristics that are specific and unique to our town, and to use them as a platform for boosting our tourism.

Simple lamang po ang pakay: Una, kilalanin ang mahalagang papel na ginampanan ng Bayan ng Baler sa simula at paglago ng surfing sa Pilipinas; at pangalawa, bigyan ng mas malawak na pagkakataon ang Bayan ng Baler para itulak pa lalo ang turismo nito upang mabigyan ng mas maraming trabaho at kita ang mga kababayan namin doon.

INQUIRY OF SENATE PRESIDENT ZUBIRI

At this juncture, Senate President Zubiri asked Senator Angara if he knew how to surf. The latter answered in the affirmative.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva expressed his support for the measure, stating that he learned to surf in Baler, Aurora and confirmed that it was the best place for the sport.

COAUTHORS

Upon their request, Senate President Zubiri and Senator Villanueva were made coauthors of Senate Bill No. 1615.

MANIFESTATION OF SENATOR HONTIVEROS

In expressing her support for Senate Bill No. 1615, Senator Hontiveros narrated that when her late husband, Frank Baraquel, was a teenager, he accompanied his uncle who was then the cook for the biggest movie production shot in Baler, Aurora – *The Apocalypse Now*. She added that Frank was like the big brother to the younger Charlie Sheen who was brought along by his father, Martin Sheen, who had a prominent role in the movie. She stated that up until that moment, Frank's family stayed in Aurora. She added that the story was told to her by Frank when they were still dating, and had been retold when they were still starting as a family. She believed that Frank would have been happy to hear her expression of support for the measure, because it was in Baler, Aurora where surfing was born in the Philippines and where her late husband's fondest memories lived.

In response, Senator Angara thanked Senator Hontiveros, adding that he had hoped for a more romantic story to flash on the screen. He nevertheless expressed appreciation for the support and fond memories of her late husband. He also thanked Senator Villanueva, who he believed was not able to go surfing as his father, then Senator Angara had him on a tight schedule.

MANIFESTATION OF SENATE PRESIDENT ZUBIRI

For his part, Senate President Zubiri informed the Body that Baler is known for its waves and surfing. He averred that at one point in history, the town was hit by a tsunami and the Angaras were one of those who survived it.

On another note, he stated that the Siege of Baler will be celebrated on June 30. He relayed to the Body that, earlier, he was with the Spanish Ambassadors who wanted to make sure that he would meet Senator Angara, and the rest of the Members.

MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva stated that he considers himself to be one of the Baler guys, and admitted that his chief-of-staff, Albert Basa, was also from Baler, Aurora. He then expressed his support for the measure.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 1615

Upon motion of Senator Villanueva, there being no objection, the Body suspended consideration of the bill.

SUSPENSION OF SESSION

With the permission of the Body, the session was suspended.
