	SECTION 1. Section 1 of Republic Act No. 8996 is hereby amended to
reac	l as follows:
	"SECTION 1. Nature and Scope of Franchise Subject to
	the provisions of the Constitution and applicable laws, rules and
	regulations, there is hereby granted to End Time Mission
	Broadcasting Service, Inc., hereunder referred to as the grantee,

its successor or assigns, a franchise to construct, install,

establish, operate and maintain for [religious,] educational and 1 [non-] commercial purposes and in the public interest, radio and television broadcasting stations [anywhere in Luzon] IN THE PHILIPPINES, where frequencies and channels are still available 4 for radio and television broadcasting, through microwave, satellite or whatever means, including the use of any new 6 7 technologies in television and radio systems, with the 8 corresponding technological auxiliaries and facilities, special broadcast and other program and distribution services and relay stations." 10

SEC. 2. Dispersal of Ownership. - In accordance with constitutional provision to encourage public participation in public utilities, the grantee shall offer at least thirty percentum (30%) of its outstanding capital stock or a higher percentage that may hereafter be provided by law in any securities exchange in the Philippines within five years from the time it has achieved the status of a national broadcasting network. A "national broadcasting network" is hereby defined as one that operates three or more radio and/or television stations. Noncompliance therewith shall render the franchise ipso facto revoked.

SEC. 3. Amendments of the Title of Republic Act No. 8996. - The title. of Republic Act No. 8996 is hereby amended to read as follows:
