CALL TO ORDER

At 3:01 p.m., the Senate President, Hon. Juan Miguel "Migz" F. Zubiri, called the session to order.

As to the rationale of the amendment, Senator Gatchalian explained that the attachment of the Office of the National Taxpayer Advocate (ONTA) to the DOF was aligned with the US Framework where the Taxpayer Advocate Service (TAS) was constituted as an independent organization within the Internal Revenue Service (IRS). But he clarified that ONTA's attachment to the DOF shall only be limited for purposes of administrative supervision in order to ensure the independence of ONTA and to preclude any conflict of interest or undue influence in the day-to-day operations of the two agencies.
