AN ACT

AMENDING REPUBLIC ACT NO. 10583, OTHERWISE KNOWN AS “AN ACT
CONVERTING THE MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE IN
THE MUNICIPALITY OF BONTOC, MOUNTAIN PROVINCE INTO A STATE
UNIVERSITY TO BE KNOWN AS THE MOUNTAIN PROVINCE STATE
UNIVERSITY, WITH CAMPUSES IN THE MUNICIPALITIES OF TADIAN, BAUKO,
PARACELIS AND BARLIG, ALL LOCATED IN MOUNTAIN PROVINCE AND
APPROPRIATING FUNDS THEREFOR”

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** Section 9 of Republic Act No. 10583 is hereby amended to read as
2 follows:

4 “**SEC. 9. *The University President.*** – The University shall be
5 headed by a President, who shall render full-time service and who shall be
6 appointed by the Board, subject to the guidelines, qualifications and
7 standards set by the Board, upon recommendation of a duly constituted
8 search committee. The University President shall have a term of four (4)
9 years and shall be eligible for reappointment for another
10 term[: *Provided, That in order to effect a smooth transition to a state*
11 *university, the incumbent President of the Mountain Province State*
12 *Polytechnic College shall serve as the [interim] FIRST President of the*
13 *University*].

1 [Within three (3) months from the approval of the law establishing
2 the University, the Board shall constitute the Search Committee for the
3 Presidency (SCP).]

6 WITHIN SIX (6) MONTHS BEFORE THE EXPIRATION OF
7 THE TERM OF OFFICE OF THE PRESIDENT OF THE UNIVERSITY,
8 THE BOARD SHALL CONSTITUTE THE SEARCH COMMITTEE
9 FOR THE PRESIDENCY.

13 The salary of the President of the University shall be in accordance
14 with [the Revised Compensation and Position Classification System, as
15 modified by Joint Resolution No. 4 dated June 17, 2009 and other pertinent
16 budget and compensation laws, and shall be comparable to that being
17 received by the Presidents of similar educational institutions] REPUBLIC
18 ACT NO. 11466, OTHERWISE KNOWN AS THE “SALARY
19 STANDARDIZATION LAW OF 2019”, AND SUCH OTHER LAWS
20 AMENDATORY THERETO, WHICH MAY HEREINAFTER BE
21 ENACTED, AND THE JOINT CIRCULAR FOR STATE
22 UNIVERSITIES AND COLLEGES’ LEVELING INSTRUMENTS, AND
23 GUIDELINES OF THE CHED AND THE DBM.

27 SEC. 2. *TRANSITORY PROVISION.* – IN ORDER TO EFFECT A SMOOTH
28 TRANSITION TO A STATE UNIVERSITY, THE INCUMBENT PRESIDENT OF THE
29 MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE SHALL SERVE AS THE
30 FIRST PRESIDENT OF THE UNIVERSITY WHO SHALL NOT BE ELIGIBLE FOR
31 REAPPOINTMENT.

33 SEC. 3. *SEPARABILITY CLAUSE.* – IF, FOR ANY REASON, ANY PART OR
34 PROVISION OF THIS ACT IS DECLARED INVALID OR UNCONSTITUTIONAL, THE
35 REMAINING PARTS OR PROVISIONS NOT AFFECTED ARE IN FULL FORCE AND
36 EFFECT.

38 ~~[SEC. 2]~~ SEC. 4. *REPEALING CLAUSE.* – All laws, presidential decrees, executive
39 orders, and rules and regulations contrary to or inconsistent with the provisions of this Act
40 are amended, repealed, or modified accordingly.

42 ~~[SEC. 3]~~ SEC. 5. *EFFECTIVITY.* – This Act shall take effect AFTER fifteen (15)
43 days ~~[after]~~ FOLLOWING its publication in the *Official Gazette* or in a newspaper of general
44 circulation.
