MANIFESTATION OF SENATOR ESTRADA

Senator Estrada delivered the following manifestation on the approval of Senate Bill No. 1480 on Third Reading:

This is to express my sincerest gratitude to my dear colleagues for lending support to this measure, which I truly feel is long overdue. Our veterans who sustained disabilities and injury in the line of duty have long waited for this legislation to update the monthly disability pension rates which have remained unchanged for 29 years.

Thank you to our chairperson of the Committee on Finance and coauthor of this measure, Sen. Sonny Angara. To our distinguished Minority Floor Leader Sen. Aquilino "Koko" Pimentel III for helping this sponsor in refining provisions of the measure. Also to the members of this august Chamber who are coauthors and cosponsors of this bill: Majority Floor Leader Sen. Joel Villanueva, Senate President Pro Tempore Sen. Loren Legarda, Sen. Manuel "Lito" M. Lapid, Sen. Cynthia Villar, and our Committee on National Defense and Security, Peace, Unification and Reconciliation committee vice chairpersons Sen. Francis Tolentino, Sen. Christopher Lawrence T. Go, Sen. Ramon "Bong" Revilla Jr., Sen. Ronald "Bato" Dela Rosa, and Sen. Robinhood C. Padilla.

I am proud to be part of this Senate, under the leadership of our Senate President Juan Miguel "Migz" Zubiri, who truly cares for the welfare of the Filipino people. This legislation is one way of honoring our military and war veterans who served and defended the country in their prime, in ensuring that in their twilight years, they and their families are accorded adequate benefits and assistance.

EXPLANATION OF VOTE OF SENATOR DELA ROSA

In explaining his affirmative vote, Senator Dela Rosa stated that the day's approval of the measure on rationalizing the disability pension of veterans is a testament that the government has



not and will never forget the sacrifices of the country's veterans. He said that they had endangered their own lives in order for the Filipinos to have the freedom they currently enjoy.

Senator Dela Rosa stated that as a former military officer and police officer, he had witnessed the veterans' valor, selflessness, and patriotism. He emphasized that no amount of money could ever adequately compensate for their service and dedication; therefore, they should not be denied the compensation and recognition they so rightfully deserve.

He believed that the veterans should receive a pension sufficient for their medical and daily needs. He believed that the bill's enactment into law would assist them in coping with the escalating costs of essential goods like medicines.

SPONSORSHIP SPEECH OF SENATOR CAYETANO (P)

In sponsoring Proposed Senate Resolution No. 50 and Proposed Resolution No. 88, Senator Cayetano (P) delivered the following speech:

I rise to sponsor Proposed Senate Resolution Nos. 88 and 89 which I filed last August 2022. So, they are almost one year late in having the Senate give them honor. But better late than never.



Both resolutions commend and congratulate the Philippine Women's National Football Team, also known as the "Filipinas," for their achievements.

Making Philippine sports "herstory" by winning in two major football tournaments with historic results. And I do not even know if this is up to date when I say two because this is based on the resolution, as I said, that I filed last year.

So, as the Majority Leader has read into the *Record*, we have members of the Filipinas Team present and we have also presented the men and women who have been supporting this team, the team led by PFF President Nonong Araneta, Atty. Edwin Gastanes, and, of course, their team manager, Jefferson Cheng.

On that note, let me just include some of the highlights of their career.

The Filipinas qualified for the 2023 Women's FIFA World Cup. This is a first in Philippine history both in the men and women's team. Often, we need to correct reports because, I am not just talking for women's football, but many times, there will be announcements, even international, not just locally, about achievements of certain male football players; and, of course, they have achieved many things as well. But then they forget to take into consideration that many times, the women have already achieved that. But, usually, late in recognizing that these women have achieved these milestones and mapapansin lamang after ulit banggitin na the men have achieved this.

So, women athletes are used to that, but I commend our team and men and women who support them, precisely because they have dreamt their dreams and have now made it part of history that we have qualified for the Women's FIFA World Cup.

So, in the qualifying match, they won against Chinese-Taipei in the AFC Women's Asian Cup quarter finals in India. This is the first time, as I said, that any Philippine football team has secured a spot in this prestigious football tournament. They entered the semi-finals of the Asian Football Confederation Women's Asian Cup for the first time ever. As of March 24, 2023, FIFA reported that the Philippines earned their highest standing to date, ranked 49th in the Women's Football in the whole world.

Saan kayo nanggaling two years ago, out of curiosity? From 76. Noong bata ka pa, Nonong, nagpo-football ka, wala pang ranking? No ranking yet. So, we are now ranked 49th.

They won the Philippines first ever championship title at the Women's ASEAN Football Federation (AFF) championship. This is the one that was held here, which I watched. In July 2022, the Filipinas were crowned as the AFF Women's Champions following their victory against Thailand. First time ever that the Philippine Football Team, either men's or women's, has won a title under the AFF banner. They beat then defending champion title holder, Vietnam, during their semi-finals match.

So, in preparation for 2023 FIFA World Cup, that will be held in Australia and New Zealand from July 20 to August 20, wherein the Philippines will compete in New Zealand, the Filipinas have been conducting training camps led by their head coach, Alen Stajcic.

As the FIFA Women's World Cup comes closer, the Filipinas have been training hard and joining prestigious football tournaments. My understanding is that most of the members of the team are members of their own teams in their different clubs. So, in between tournaments where they played together, they go back home and they compete with their teams which serves as their continuous training.

So, from September to November 2022, the Filipinas joined various international friendlies with teams such as New Zealand, Costa Rica, Chile, and Papua New Guinea. And February 2023, the Women's Team also debuted in their maiden Pinatar Cup in Spain where they gained tremendous experience playing against teams from Iceland, Wales, and Scotland. And I had the pleasure of joining them there as their head of delegation.

In April 2023, the team battled it out for the Paris 2024 Olympic Qualifying Tournament versus Pakistan, Tajikistan, and Hong Kong where they were able to progress to the second round.

Their participation in many international friendlies with other teams have yielded favorable and promising results. Sacrificing their time and efforts away from their family and loved ones,



to prepare for the World Cup is something that is not a stranger to any member of this team and any of their supporting crew. They have and they continue to endure long training hours that we can only imagine.

The Filipinas and other female athletes have served as an inspiration for the country. They have achieved what would have been considered impossible only a few years ago. This is an accomplishment not just for Philippine sports but for Philippine women and for Philippine athletes. Hard work, dedication, and passion for the sport are the building blocks for reaching goals, dreams, and successes.

Many, if not all, of these athletes have started very young. They have been able to harness their passion into a craft. They have the discipline and they have what it takes to work together as a team to accomplish their goals. They bring pride and honor to the country and inspired athletes not just in the country but worldwide.

Congratulations to the Filipinas.

REMARKS OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri congratulated the Filipinas football team for bringing pride to the country. He said that the senators even watched their games.

He disclosed that his Arnis team was competing that day in Cambodia at the 2023 Southeast Asian Games. He also informed the Body that the Philippines had overtaken Singapore in the events, placing fifth in the ranking of the countries. He hoped that the Filipino athletes could defeat Cambodia and be ranked fourth place in the events.

Upon motion of Senator Villanueva, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 2021 (Committee Report No. 59), entitled

AN ACT TO INSTITUTIONALIZE THE SHARED SERVICE FACILITIES (SSF) PROJECT FOR MICRO, SMALL, AND MEDIUM ENTERPRISES (MSMES) BY AMENDING REPUBLIC ACT NO. 6977 OTHERWISE KNOWN AS THE MAGNA CARTA FOR SMALL ENTERPRISES AS AMENDED BY REPUBLIC ACT NO. 9501 OTHERWISE KNOWN AS THE MAGNA CARTA FOR MICRO, SMALL AND MEDIUM ENTERPRISES.



Senator Villanueva stated that the parliamentary status was the period of individual amendments.

Thereupon, the Chair recognized Senator Angara, sponsor of the measure.

PIMENTEL AMENDMENT

As proposed by Senator Pimentel and accepted by the sponsor, there being no objection, the Body approved the following amendment:

1. On page 1, after line 9, insert the following paragraphs:

THE SSFS PROGRAM SHALL ENTAIL SETTING UP COMMON SERVICE FACILITIES OR PRODUCTION CENTERS FOR CERTAIN PORCESSES TO GIVE MSMES ACCESS TO BETTER TECHNOLOGY AND MORE SOPHISTICATED EQUIPMENT TO TECHNOLOGY TO ACCELARATE THEIR BID FOR COMPETITIVENESS AND HELP THEM GRADUATE TO A NEXT LEVEL WHERE THEY COULD TAP BETTER AND WIDER MARKETS AND BE INTEGRATED IN THE GLOBAL SUPPLY CHAIN. THE PROJECT MAY BE IMPLEMENTED IN COOPERATION WITH DOST, AND OTHER AGENCIES, THE ACADEME, LGUS, AND PRIVATE ORGANIZATIONS.

SHARED SERVICE FACILITIES REFER TO MACHINERY, EQUIPMENT, TOOLS, SYSTEMS, ACCESSORIES AND OTHER AUXILARY ITEMS, SKILLS, AND KNOWLEDGE THAT ARE BEING PROVIDED BY THE DTI UNDER A COMBINED AND COLLECTIVE SYSTEM TO ITS TARGET BENEFICIARIES.;

VILLANUEVA AMENDMENT

As proposed by Senator Villanueva and accepted by the sponsor, there being no objection, the Body approved the following amendment:

2. On the same page, line 11, after the acronym "DTI," insert a comma (,) and the phrase IN COORDINATION WITH RELEVANT GOVERNMENT AGENCIES, LOCAL GOVERNMENT UNITS, PRIVATE INSTITUTIONS, AND STAKEHOLDERS;

Senator Villanueva explained that the amendment was meant to avoid duplication of functions such as that of the DOST, which implements the Community Empowerment through Science and Technology (CEST) programs, and whose intervention for livelihood opportunities include innovation and support system, funding, technology, trainings, and the like.

PIMENTEL AMENDMENT TO HIS AMENDMENT

3. On his previous amendment on page 1, line 9, as proposed by Senator Pimentel and accepted by the sponsor, there being no objection, the Body approved the insertion of the word GOVERNMENT between the words "OTHER" and "AGENCIES."

REMARKS OF SENATOR LEGARDA

At the outset, Senator Legarda thanked Senator Angara for further enhancing Senate Bill No. 2021 in order to address the sustainable recovery and development of the country's MSMEs, given that they serve as the backbone of the local economy as they represent 99.5% of business enterprises in the country. She recalled that she had authored the MSME Law (Republic Act No. 9501) in 2007 to expand the scope of assistance given to small and medium enterprises (SMEs) to also include the microenterprises.

With Senate Bill No. 2021, she expected that once passed into law, it would further enhance Republic Act No. 9501 and would institutionalize the SSF for MSMEs.



She then called the attention of the DTI to automatically consider the measure and, once the bill is signed into law and institutionalizes the SSF program nationwide, that it requests funds that would already be included in the National Expenditure Program so that allocations for the program would no longer have to be inserted as amendment to the 2024 General Appropriations Bill. She opined that such funds would help the MSMEs recover from the effects of the pandemic. She also expressed her confidence that the DBM, NEDA, and the DOF would already include the SSF fund once the program is institutionalized into law.

In one committee hearing prior to the COVID-19 pandemic and right after the Marawi siege, she recalled that she had to push for the earmarking of the inadequate noninstitutionalized P50-million SSF budget for the victims of the Marawi crises and another P200 million for the extension programs of state universities and local government universities as cooperators of the DTI SSF, while the rest of the P1 billion augmentation in the DTI budget went to other MSMEs.

LEGARDA AMENDMENTS

As proposed by Senator Legarda and accepted by the sponsor, there being no objection, the Body approved the following amendments:

- 4. On page 2, line 15, insert the following paragraphs to read as follows: *PROVIDED, THAT,* IN GRANTING SSFS, THE DTI SHALL:
 - A. TIMELY PROCESS THE APPLICATIONS FOR THE GRANTING OF SSFS IN COMPLIANCE WITH THE PROVISIONS OF REPUBLIC ACT NO. 11032 OR THE "EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018" ON THE MAXIMUM PRESCRIBED PROCESSING TIME DEPENDING ON THE COMPLEXITY OF THE TRANSACTIONS; PROVIDED, THAT THE APPLICATION HAS MET ALL THE REQUIREMENTS INCLUDING AMONG OTHERS THE CONDUCT OF MARKET STUDY AND OTHER RECOMMENDATIONS THAT MAY BE IDENTIFIED BY THE NATIONAL TECHNICAL WORKING GROUP (NTWG);
 - B. CONSULT WITH THE COOPERATORS ON THE APPROPRIATE PROJECTS TO BE GRANTED TO THEM;
 - C. ENSURE THAT THE MACHINERY, EQUIPMENT, AND TOOLS ARE PROPER, SUITABLE, USABLE, AND APT WITH THE CAPABILITIES AND REQUIREMENTS OF THE FACILITIES;
 - D. COORDINATE WITH SUCS AND LUCS WHERE THE SSF AND/OR SSF-FAB LABS ARE ESTABLISHED IN SETTING GUIDELINES FOR THE EQUITABLE UTILIZATION OF SAID FACILITIES AMONG USERS WITHIN AND OUTSIDE THE EDUCATIONAL INSTITUTIONS;
 - E CLOSELY COORDINATE AND IMMEDIATELY ASSIST THE COOPERATORS WITH THEIR ISSUES OR CONCERNS REGARDING THE IMPLEMENTATION OF THEIR PROJECTS; AND
 - F. PARTNER WITH OTHER GOVERNMENT AGENCIES, IF NEEDED, TO HELP ENSURE THE SUCCESS OF THE PROJECTS.

Senator Legarda stated that the amendment aims to address capacity-building challenges usually faced by cooperators on the ground in the implementation of the project, such as the inability to use tools and equipment provided due to lack of training, lack of capital, and political issues.

5. After such paragraphs, insert a new paragraph to read as follows:

**PROVIDED, FURTHER, THAT THE DTI SHALL ENSURE THAT THE SSFS CREATED UNDER THIS ACT ARE CONSISTENT WITH THE NATIONAL INNOVATION AGENDA AND STRATEGY DOCUMENT.

Senator Legarda emphasized the need for coherent and consistent programs and policies in the roadmap for the country's vision and long-term goals for innovation. Relative thereto,

she mentioned that she authored the Philippine Innovation Act (Republic Act No. 11293) after the 2015 Asia-Pacific Economic Cooperation meeting. Given the existing laws and Senate Bill No. 2021, she expressed hope that there would soon be a convergence between the NEDA, DTI, and other concerned government agencies.

ANGARA AMENDMENT

6. On page 2, line 23, after "SSFs," as proposed by Senator Angara, there being no objection, the Body approved the insertion of the phrase "AND SSF-FAB LABS."

TERMINATION OF THE PERIOD OF INDIVIDUAL AMENDMENTS

There being no other amendment, upon motion of Senator Villanueva, there being no objection, the Body closed the period of individual amendments.

APPROVAL OF SENATE BILL NO. 2021 ON SECOND READING

Submitted to a vote, there being no objection. Senate Bill No. 2021 was approved on Second Reading.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 2021

Upon motion of Senator Villanueva, there being no objection, the Body suspended consideration of the bill.

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 4:40 p.m.

RESUMPTION OF SESSION

At 4:41 p.m., the session was resumed.

COMMITTEE REPORT NO. 40 ON SENATE BILL NO. 1964

(Continuation)

Upon motion of Senator Villanueva, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 1964 (Committee Report No. 40), entitled

AN ACT INSTITUTIONALIZING THE GRANT OF A TEACHING SUPPLIES ALLOWANCE FOR PUBLIC SCHOOL TEACHERS AND APPROPRIATING FUNDS THEREFOR.

Senator Villanueva stated that the parliamentary status was the period of committee amendments.

Thereupon, the Chair recognized Senator Revilla, sponsor of the measure.

TERMINATION OF THE PERIOD OF COMMITTEE AMENDMENTS

There being no committee amendment, upon motion of Senator Villanueva, there being no objection, the Body closed the period of committee amendments and proceeded to the period of individual amendments.



INDIVIDUAL AMENDMENTS

As proposed by the following senators and accepted by the sponsor, there being no objection, the following amendments were approved by the Body, one after the other:

By Senator Legarda

 On page 1, line 12, after the phrase "consistent with the," insert the phrase POLICY AND GUIDELINES.

As to the rationale of the amendment, Senator Legarda stated that DepEd Order No. 34 provides the directive that:

"Starting November 2, 2022, all public and private schools shall have transitioned to five days in-person classes. After the said date, no school shall be allowed to implement purely distance learning or blended learning...The transition to five days in-person classes...entails judgment to the... learning modality..."

Hence, she said, the amendment emphasized on the enforced guidelines and implemented learning modality of the DepEd.

- On the same page and line, after the word "learning," insert the word DELIVERY and, after the word "modalities," insert the acronym LDMs;
- Still on the same page and line, after the word "recognized," insert the word IMPLE-MENTED; and
- · On page 2, line 2, delete the phrase "learning delivery modalities."

By Senator Pimentel

• On page 2, lines 4 to 7, delete the proviso "Provided, That the Teaching Supplies Allowance shall be automatically adjusted to its present value every three (3) years to account for the changing prices of teaching supplies and materials and the implementation or conduct of various LDMs." and change the colon (:) to a period (.).

Senator Pimentel explained that every time there would be a proposed increase, they would have to go to Congress and the legislature should be sensitive to the needs of the teachers. He stated that with his amendment, beginning school year 2024-2025, the teaching supplies allowance for teachers would be P10,000 but subject to congressional review in subsequent years.

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 4:51 p.m.

RESUMPTION OF SESSION

At 4:54 p.m., the session was resumed.

MANIFESTATION OF SENATOR CAYETANO (P)

Senator Cayetano (P) requested the sponsor to read the amended Section 3 of the bill because her proposed amendments would be based on the current status of the measure. In reply, Senator Revilla said that Senator Pimentel's last amendment deleted the automatic adjustment provision of the bill.



SUSPENSION OF SESSION

Upon motion of Senator Revilla, the session was suspended.

It was 4:56 p.m.

RESUMPTION OF SESSION

At 4:57 p.m., the session was resumed.

INQUIRIES OF SENATOR CAYETANO (P)

Senator Cayetano (P) observed that the objective of the amendment of Senator Legarda was to ensure that the cash allowance would be used only in accordance with the guidelines of the DepEd and taking into consideration the different deliveries of learning modalities.

Replying to the queries of Senator Cayetano (P), Senator Revilla stated that the funds would be disbursed in cash to the teachers on an annual basis.

On whether the teachers would have to produce receipts for the purchase of the supplies, he said that the allowance would not be subject to liquidation.

Asked how it could be ensured that the cash allowance would be used for the specified purpose, Senator Revilla that the teacher would have to be trusted, however, he would be willing to accept any proposed amendment by Senator Cayetano (P) on the matter.

SUSPENSION OF SESSION

Upon motion of Senator Revilla, the session was suspended.

It was 5:01 p.m.

RESUMPTION OF SESSION

At 5:03 p.m., the session was resumed.

Senator Cayetano (P) clarified that it was not her intention to make the issue complicated, as she recognized that the teachers are the first to contribute to augment the needs of the classroom. She added that teachers sometimes use their personal money to feed a hungry student or buy a student a pair of shoes. She doubted that the expenses she mentioned would be covered by the cash allowance envisioned by the bill.

Senator Revilla lamented that the examples cited by Senator Cayetano (P) would not be covered by the teaching supplies allowance. But he said that the Secretary of Finance took note of the concerns raised by Senator Cayetano (P).

PROPOSED AMENDMENT OF SENATOR CAYETANO (P)

On page 2, line 2 of the bill, after the words "learning delivery modalities," Senator Cayetano (P) proposed the insertion of the phrase AND FOR ANY NEED A TEACHER DEEMS SUITED FOR THE BENEFIT OF THE LEARNER. She said that such amendment would broaden the scope of the measure to cover not just supplies, but other incidental expenses that teachers are known to shoulder to improve learning delivery.



CAYETANO-ANGARA AMENDMENT

Senator Angara proposed to amend the amendment of Senator Cayetano (P) on page 2, line 2, after the words "learning delivery modalities," by inserting the phrase AND OTHER EXPENSES INCIDENTAL TO THE LEARNING OF THE CHILD.

Senator Cayetano (P) accepted the amendment to her amendment.

Senator Revilla accepted the amendment as amended and, there being no objection, the same was approved by the Body, subject to style.

Senator Cayetano stated that her amendment would address the reality that teachers spend their own money to assist their learners as if the latter were their own children.

TERMINATION OF THE PERIOD OF INDIVIDUAL AMENDMENTS

There being no other individual amendment, upon motion of Senator Villanueva, there being no objection, the Body closed the period of individual amendments.

APPROVAL OF SENATE BILL NO. 1964 ON SECOND READING

Submitted to a vote, there being no objection, Senate Bill No. 1964 was approved on Second Reading, subject to style.

SUSPENSION OF CONSIDERATION OF SENATE NO. 1964

Upon motion of Senator Villanueva, there being no objection, the Body suspended consideration of the bill.

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 5:11 p.m.

RESUMPTION OF SESSION

At 5:46 p.m., the session was resumed with Senate President Zubiri presiding.

SUSPENSION OF SESSION

With the permission of the Body, the session was suspended.

It was 5:46 p.m.

RESUMPTION OF SESSION

At 5:52 p.m., the session was resumed.

MOTION TO CONSIDER SENATE BILL NO. 2020

Senator Villanueva moved that the Body resume consideration of Senate Bill No. 2020, otherwise known as the "Maharlika Investment Fund Act of 2023."



MOTION TO ADJOURN

Senator Pimentel moved to adjourn for lack of quorum. The Majority Leader objected.

SUSPENSION OF SESSION

With the permission of the Body, the session was suspended.

It was 5:53 p.m.

RESUMPTION OF SESSION

At 5:55 p.m., the session was resumed.

Upon resumption, Senate President Zubiri directed the Senate Secretary to call the roll to determine the existence of a quorum.

COMMITTEE REPORT NO. 58 ON SENATE BILL NO. 2020

(Continuation)

Upon motion of Senator Villanueva, there being no objection, the Body resumed consideration, on Second Reading, of Senate Bill No. 2020 (Committee Report No. 58), entitled

AN ACT ESTABLISHING THE MAHARLIKA INVESTMENT FUND, PROVIDING FOR THE MANAGEMENT, INVESTMENT, AND USE OF THE PROCEEDS OF THE FUND, AND FOR OTHER PURPOSES.

Senator Villanueva stated that the parliamentary status was the period of interpellations.

Thereupon, the Chair recognized Senator Villar (M), sponsor of the measure, and Senator Dela Rosa for his interpellation.

INTERPELLATION OF SENATOR DELA ROSA

In reply to Senator Dela Rosa's query, Senator Villar (M) stated that a sovereign wealth fund is a state-owned special purpose investment fund which has the general purpose of maximizing state assets, promoting the development of the state, and generating robust return.



Regarding the difference between the Maharlika Investment Fund (MIF) and the funds of government-owned and -controlled corporations, Senator Villar (M) said that the sovereign investment fund would be invested on flagship infrastructure or agriculture projects that would generate huge returns in the form of equity, company shares, funds generated abroad, or funds from institutional investors.

As to why there was a need to establish a Maharlika Investment Corporation (MIC) when the existing government financial institutions already provide funds for the same purpose, Senator Villar (M) replied that as former Secretary of the DPWH, he saw the need for additional fund sources to propel more infrastructure, agriculture, and energy projects, considering the limited budget derived from the General Appropriations Act. Through the MIF, he said, the government would have other sources of funding.

Noting the proposed P500-billion authorized capital stock for the Maharlika Investment Corporation, Senator Dela Rosa inquired if there was a GOCC that has a capital stock of almost the same amount. Senator Villar (M) replied that Land Bank has an authorized capital stock of P800 billion and a net income of P40 billion.

With respect to the estimated annual income of another fund source which is PAGCOR, Senator Villar (M) stated that for 2022, PAGCOR earned a total of P55 billion less five percent (5%) franchise tax that goes to the Bureau of Internal Revenue, and the amount of P52.8 billion was retained by PAGCOR and the national government, or P26.4 billion each. Pursuant to the ten percent (10%) allocation for MIF, he explained that P2.64 billion from PAGCOR would go to the Maharlika Investment Corporation.

Senator Dela Rosa also pointed to the National Development Company (NDC) which is the Philippines' leading state-owned enterprise investing in diverse industries including development projects. He asked whether the NDC would cease to exist after the establishment of the MIC, and whether the MIF initiative could be reconciled with the government's plan to streamline the bureaucracy. In reply, Senator Villar (M) noted that during the committee hearings, it was explained that the Maharlika Investment Corporation would even complement NDC's goals in yielding funds for other government projects, if the MIC board of directors would allow it. He assured that the NDC would not be dissolved.

On whether there would be a cap on the administrative and operational expenses of the MIC, and how many employees and financial consultants would be hired for the operation of the Maharlika Investment Corporation, Senator Villar (M) stated that as provided for by law, the allocation for administrative expenses at two percent (2%) would be used for the manpower complement based on the MIC board of directors' discretion. He noted that more or less, the cap on the initial capital would be P125 billion, and that such amount would not be a one-time contribution because the Bangko Sentral ng Pilipinas (BSP) would also contribute to the fund over a few years.

To the remark that the 2% allocation seemed onerous, Senator Villar (M) believed that it was at par with that of other GOCCs.

Senator Dela Rosa then asked which countries have successful sovereign wealth funds and how much their annual profit was. He also inquired as to the biggest loss incurred by a sovereign wealth fund and whether the bill has provisions that would ensure that the Philippines would not experience the same fate.

Senator Villar (M) stated that 5% of PAGCOR's P55 billion revenues in 2022 would be withheld as franchise tax to the BIR. He stated that P26.4 billion, or half of the P52.8 billion, would



be retained by PAGCOR, with the other half going to the national government. In addition to the P26.4 billion earmarked for the national government, he stated that P2.64 billion, or 10% of what PAGCOR retained, would be added to PAGCOR's capital contribution to the Maharlika Investment Corporation.

Senator Dela Rosa stated that the National Development Company is the Philippines' leading state-owned enterprise, investing in diverse industries, including development projects. In this regard, he inquired as to the reason for the need to establish the MIF and the MIC. He also inquired as to how the measure might be reconciled with the government's aim to streamline the bureaucracy.

Senator Villar (M) responded by recalling that the same issue was raised during the bill's committee hearings, during which the NDC opined that the establishment of the Maharlika Investment Corporation may possibly be complementary to their goals. He acknowledged that the NDC has been around for a long time, supporting businesses in reaching their next level. Similarly, he stated that the Maharlika Corporation could invest in other governmental projects as long as they generate a specified amount acceptable to its board of directors.

Asked if NDC would be dissolved, he replied in the negative, saying that the NDC and the MIC can co-exist, which the NDC supports.

In reply to further queries, Senator Villar (M) said that the amount allocated for administrative and operational expenses of the MIC is comparable to that of other GOCCs, which is 2% as provided for in the law.

Asked how many employees and financial consultants would be required to have a functional Maharlika Investment Corporation, he stated that there will board of directors who will have discretion with the use of the fund within the 2% cap on the initial capital of approximately P125 billion.

Senator Dela Rosa stated that he would often hear the expression "high risk, high return" being associated with investment. In this regard, he inquired as to which countries have already established a successful sovereign fund and how big their annual profit or income was. He also inquired as to which country has the sovereign fund with the largest loss in history. He also asked if the measure has mechanisms to ensure that the MIC does not suffer the same fate as that country.

In reply, Senator Villar (M) said that the Norway Investment Fund, China Investment Corp., Abu Dhabi Investment Authority, and Vietnamese State Capital Investment Corporation are among the existing sovereign funds. He believed that it is important to look at the state funds not in the short term, but rather for a minimum of a five years and up to 10 years. He noted, for example, the Norway Investment Fund, which has averaged a 10% despite periodic dips. He said that looking at investments over a certain lifespan would allow them to see the cumulative average growth rate (CAGR) as the long-term return.

In terms of the Maharlika Fund, he stated that the minimum target return would be 8%. Nonetheless, considering that nothing is definite when it comes to investing, he assured that experts will be consulted to minimize losses. In fact, he stated that there will be an advisory board comprised of respected and competent finance personalities, namely, the DBM, the Treasurer, and the NEDA, who will guide the board of directors of MIC, comprised of nine members representing the private sector as well as those who have invested capital in the company, in generating the returns required in Maharlika.



He once again referenced the Norway Wealth Fund as having the worst performance of any sovereign wealth fund ever recorded, with paper losses of negative (-) 14% in the first half of 2022. However, he emphasized the need of analyzing investments over an extended period of time, which in the case of the Norway Wealth Fund was 10 years, in order to determine overall performance. He noted that like the Philippine Stock Exchange (PSE), it has an upward trajectory but with no straight returns.

He expressed confidence that the minimum target return of 8% was realistic, citing his experience as a former DPWH secretary, when he witnessed more 15% IRR from a number of infrastructure projects vetted by NEDA. Apart from having several projects that may generate revenue for the government, he believed that the Maharlika has enough safeguards in place to ensure that the government achieves a good rate of return.

Asked if the Norway Wealth Fund mentioned still exists, Senator Villar (M) replied in the affirmative.

INTERPELLATION OF SENATOR POE

Senator Poe stated that based on previous discussions, PAGCOR would contribute around P2 billion to the Fund's budget. Senator Villar (M) responded in the affirmative, noting that it is an estimate based on PAGCOR's revenue generation from the previous year because it still does not know what its revenue will be next year.

Asked how much PAGCOR earns on average every year, he said that PAGCOR earns between P55 billion to P60 billion per year.

Senator Poe stated that if LANDBANK and others would contribute a substantial amount, it would be difficult to track what PAGCOR spends; thus, that it would be better for PAGCOR to contribute more to a fund such as the one under consideration where it can be tracked.

Asked on the current inflation rate in the Philippines, Senator Villar (M) replied that the latest inflation figure was around 6.6%. In terms of a fund's average yield, he confirmed that a fund would have a yield of 6% to 8%.

Senator Poe noted that the Norway Wealth Fund had experienced its worst period, with paper losses of negative (-) 14% in the first half of 2022. She then inquired as to when the aforementioned fund reached its peak. Senator Villar (M) replied that he has yet to get the information.

On another matter, Senator Poe stated that if the 2% administrative expenses previously mentioned are factored in the average expected return of 8%, the Fund would have to outperform predictions or the yields from the previous two years. Senator Villar (M) responded that the ideal goal is to fund inflation in any fund. However, he recognized that the inflation was currently higher that it has been in previous years. As a result, he believed that if the 6% inflation rate continues, the targets would need to be revised. Nonetheless, he stated that there is an assumption that inflation would be on a downward trajectory.

Senator Poe, on the other hand, averred that when the economy reopened following the COVID-19 pandemic, the opposite happened. Reiterating that the administrative fee provided is 2% at the most, according to the Secretary of Finance, she inquired as to how much would it be and whether such a number was a little too generous. Senator Villar (M) said that the amount would be 2% of the total funds under administration, which is P75 billion.

In response to an earlier question concerning the best performance of the Norway Wealth Fund, he stated that the highest rate it obtained in a year was 25%. Senator Poe remarked that



Norway's performance had been rather promising. However, she stated that, unlike Norway, which has surplus income, the Maharlika Fund would draw on resources that have already been allocated.

As regards the board members in the Maharlika Fund, Senator Villar (M) reiterated that it would be comprised of nine directors. As to the qualifications of the members and who would appoint them, he stated that the advisory board, which includes the DBM, the NEDA, and the Treasurer recommends, while the President appoints.

Asked if each member of the board of directors is required to have experience in finance, Senator Villar (M) replied in the affirmative, citing the extensive qualifications for the board of directors under Section 20 of the bill, to wit: "The regular directors shall be citizens of the Philippines, at least 35 years of age, and must be of good moral standing and reputation, of recognized probity and independence, and have substantial experience and expertise in any of the following: (i) corporate governance and administration, (ii) investment in financial assets, (iii) management of investments in the global and local markets. The regular directors shall be appointed by the President of the Philippines upon recommendation of the Advisory Body for a term of three (3) years."

Senator Poe noted that the provision cited by Senator Villar (M) on the qualifications of the board of directors does not specify a time period or number of years of experience. Senator Villar (M) believed that the required time period or number of years of experience in finance should be included in the measure's IRR.

At this juncture, Senator Poe thanked Senator Villar (M) for his responses and stated that due to the lateness of the hour, she will continue with her more detailed questions the next session week session.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 2020

Upon motion of Senator Villanueva, there being no objection, the Body suspended consideration of the bill.

SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

Senator Villanueva manifested that Senator Legarda was designated co-chairperson of the subcommittee on Senate Bill No. 238 (Northern Antique Protected Seascape and Landscape Act of 2022) created on February 8, 2023.

He stated that pursuant to Section 25 of Republic Act No.11641 (Department of Migrant Workers Act), and in accordance with the letter dated May 15, 2023 from the Office of Senator Tulfo, as delegated by Senator Estrada, the chairperson of the Committee on Labor, Employment and Human Resources Development, Senate President Zubiri designated the following senators to the Joint Congressional Oversight Committee on Migrant Workers — chairperson, Senator Tulfo; vice chairperson, Senator Estrada; and members, Senators Go, Revilla, Pimentel, and Hontiveros.
