





**AN ACT**  
**RENAMING THE TAMBACAN BRIDGE TRAVERSING THE ILIGAN RIVER LOCATED IN**  
**BARANGAY TAMBACAN, CITY OF ILIGAN IN THE NORTHERN MINDANAO REGION,**  
**AS THE MARIANO LLUCH BADELLES SR. BRIDGE**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

- 1 **SECTION 1.** The Tambacan Bridge traversing the Iligan River located in Barangay Tambacan, City of  
2 Iligan in the Northern Mindanao region, is hereby renamed as the Mariano Lluch Badelles Sr. Bridge.  
3
- 4 **SEC. 2.** The Department of Public Works and Highways shall issue the necessary rules, orders, and  
5 circulars to implement the provisions of this Act within sixty (60) days from its effectivity.
- 6 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a  
7 newspaper of general circulation.
