AN ACT

**RE-NUMBERING THE CEBU FIRST, SECOND, THIRD AND FOURTH DISTRICT
ENGINEERING OFFICES TO CONFORM AND CORRESPOND, RESPECTIVELY, WITH THE
NUMBERING OF THE LEGISLATIVE DISTRICTS IN THE PROVINCE OF CEBU THEREBY
REPEALING REPUBLIC ACTS NUMBERED 9043 AND 9218**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** The current district engineering offices in the Province of Cebu shall be renumbered
2 accordingly to conform and correspond, respectively, with the numbering of the four (4) legislative districts
3 of the province. Each District Engineering Office shall serve the cities and municipalities under the
4 respective legislative district.

6 **SEC. 2.** The Cebu First District Engineering Office, to be located within the First Legislative
7 District of the Province of Cebu, shall serve the Cities of Talisay, Carcar and Naga and the Municipalities
8 of Minglanilla, Sibonga and San Fernando. The Cebu Second District Engineering Office, to be located
9 within the Second Legislative District of the Province of Cebu, shall serve the Municipalities of Argao,
10 Dalaguete, Alcoy, Baljoon, Oslob, Santander and Samboan. The Cebu Third District Engineering Office,
11 to be located within the Third Legislative District of the Province of Cebu, shall serve the City of Toledo
12 and the Municipalities of Aloguinsan, Asturias, Balamban, Barili, Pinamungajan and Tuburan. Finally, the
13 Cebu Fourth District Engineering Office, to be located within the Fourth Legislative District of the Province
14 of Cebu, shall serve the City of Bogo and the Municipalities of Bantayan, Daanbantayan, Madridejos,
15 Medellin, San Remegio, Santa Fe, Tabogon, and Tabuelan.

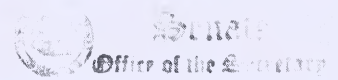

17 **SEC. 3.** Within sixty (60) days from the effectivity of this Act, the Secretary of Public Works
18 and Highways shall issue the necessary rules and regulations for the effective implementation of this Act.

20 **SEC. 4.** Republic Act No. 9043 entitled "AN ACT CONSTITUTING THE SECOND
21 ENGINEERING DISTRICT IN THE PROVINCE OF CEBU, INTO TWO SEPARATE AND DISTINCT
22 ENGINEERING DISTRICTS, ONE TO BE LOCATED IN THE MUNICIPALITY OF MINGLANILLA
23 AND THE OTHER IN THE MUNICIPALITIES OF ARGAO, BOTH IN THE PROVINCE OF CEBU",
24 and Republic Act No. 9218 entitled "AN ACT CONSTITUTING THE FIRST DISTRICT ENGINEERING
25 OFFICE IN THE PROVINCE OF CEBU, INTO TWO SEPARATE AND DISTINCT ENGINEERING
26 OFFICES, ONE TO BE LOCATED IN THE CITY OF CEBU AND THE OTHER IN THE CITY OF
27 DANA O, BOTH IN THE PROVINCE OF CEBU", are hereby repealed accordingly.

1 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or
2 in a newspaper of general circulation.

EXPLANATORY NOTE

District Engineering Offices or DEOs of the Department of Public Works and Highways (DPWH) are mandated to develop our country's infrastructure. They are the forefronts in executing infrastructure improvements in every legislative district.

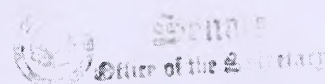
There is however a need to streamline and re-number the DEOs to be consistent with the numbering of the legislative districts to ensure better service delivery and avoid confusion among stakeholders.

The bill seeks to renumber all the DEOs in the Province of Cebu to correspond with the numbering of the legislative districts to guarantee a more effective and accurate delivery of infrastructure projects in the province.

In view of the foregoing, approval of this measure is earnestly sought.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 Section 1. The current district engineering offices in the Province of Cebu shall
2 be renumbered accordingly to conform and correspond, respectively, with the
3 numbering of the four (4) legislative districts of the province. Each District Engineering
4 Office shall serve the cities and municipalities under the respective legislative district.
- 5 Sec. 2. The Cebu First District Engineering Office, to be located within the First
6 Legislative District of the Province of Cebu, shall serve the Cities of Talisay, Carcar and
7 Naga and the Municipality of Minglanilla, Sibonga and San Fernando. The Cebu Second
8 District Engineering Office, to be located within the Second Legislative District of the
9 Province of Cebu, shall serve the Municipalities of Argao, Dalaguete, Alcoy, Baljoon,
10 Oslob, Santander and Samboan. The Cebu Third District Engineering Office, to be
11 located within the Third Legislative District of the Province of Cebu, shall serve the
12 City of Toledo and the Municipalities of Aloguinsan, Asturias, Balamban, Barili,
13 Pinamungajan and Tuburan. Finally, the Cebu Fourth District Engineering Office, to be
14 located within the Fourth Legislative District of the Province of Cebu, shall serve the
15 City of Bogog and the Municipalities of Bantayan, Daanbantayan, Madridejos, Medellin,
16 San Remegio, Santa Fe, Tabogon, and Tabuelan.

1 Sec. 3. Within sixty (60) days from the effectivity of this Act, the Secretary of
2 Public Works and Highways shall issue the necessary rules and regulations for the
3 effective implementation of this Act.

4 Sec. 4. Republic Act No. 9043, entitled "An Act Constituting the Second
5 Engineering District in the Province of Cebu, into Two Separate and Distinct
6 Engineering Districts, One To Be Located in the Municipality of Minglanilla and the
7 Other in the Municipalities of Argao, Both in the Province of Cebu", and Republic Act
8 No. 9218, entitled "An Act Constituting the First District Engineering Office in the
9 Province of Cebu, into Two Separate and Distinct Engineering Offices, One To Be
10 Located in the City of Cebu and the Other in the City Of Danao, Both in the Province
11 of Cebu", are hereby repealed accordingly.

12 Sec. 5. This Act shall take effect fifteen (15) days after its publication in the
13 Official Gazette or in a newspaper of general circulation.
