**AN ACT**  
**ENABLING THE COMMISSION ON ELECTIONS TO ESTABLISH AN**  
**AUTOMATED AND ONLINE SYSTEM FOR VOTER REGISTRATION,**  
**PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES**

EXPLANATORY NOTE

The right to suffrage or the right to vote, which is enshrined in our Constitution, is an essential attribute of a democratic country like the Philippines. It enables the people to participate in the process of government in order to assure that its powers are derived from the consent of the governed.

Before one can exercise one's right to vote, one must first be registered to the local Commission on Elections (COMELEC) offices. Yet, registration appears to be a time-consuming and exhausting process, and could be the main reason why many qualified citizens are deterred from registering, rendering them unable to participate during the elections.

Thus, to encourage citizens to register, this bill seeks to enable COMELEC, as far as practicable, to adopt, design, and use an automated and online system for voter registration. This will cover the electronic and online filing and processing of the application for registration, transfer of registration, reactivation, correction of voter registration entries, and such other requests and processes relative to the voter's registration and records.

These will result to more efficient, convenient, and accessible registration process, which will undoubtedly encourage more qualified citizens to participate in the electoral process.

In view of the foregoing, the passage of the bill is earnestly sought.



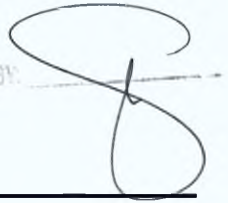

**AN ACT**  
**ENABLING THE COMMISSION ON ELECTIONS TO ESTABLISH AN**  
**AUTOMATED AND ONLINE SYSTEM FOR VOTER REGISTRATION,**  
**PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           Section 1. *Declaration of Policy.* – It is the policy of the State to establish a  
2 system of registration that ensures and guarantees a clean, complete, permanent, and  
3 updated list of voters. To encourage and ensure a continuing system of voter  
4 registration, the State shall adopt and make use of technologies that shall facilitate  
5 and allow the automated and online registration of voters, taking into account the  
6 integrity, completeness, and accuracy of the list of voters.

7           Sec. 2. *Automated and Online Voter Registration System.* – The Commission on  
8 Elections (COMELEC) shall, as far as practicable, adopt, design, and use an automated  
9 and online system for voter registration that enables the electronic and online filing  
10 and processing of the application for registration, transfer of registration, reactivation,  
11 correction of voter registration entries, and such other requests and processes relative  
12 to the voter’s registration and records.

13           The COMELEC shall also endeavor to use the same automated and online  
14 system for the verification and approval of application for voter registration, transfer  
15 of registration, reactivation, correction of voter registration entries, and such other  
16 requests and processes relative to the voter’s registration and records as may be

1 practicable, bearing in mind the State's policy of ensuring the integrity and accuracy  
2 of the voters list and records.

3       *Sec. 3. Automated and Online Verification.* – Where online verification of the  
4 application or request is not feasible in the meantime, the system shall nonetheless  
5 allow the applicant to submit his or her application or request through the COMELEC's  
6 online platform. The same application and the information contained therein, including  
7 the demographics of the applicant, shall be processed electronically and shall be  
8 automatically stored in the COMELEC database for pending voter registration  
9 application or requests.

10       The system shall promptly provide the applicant with complete and detailed  
11 information as to the steps required to complete the application or request.

12       *Sec. 4. Personal Filing.* – The automated and online filing of application for  
13 voter registration shall not preclude the personal filing of applications for registration,  
14 transfer of registration, reactivation, correction of voter registration entries, and such  
15 other requests, which shall continue to be available and conducted in the office of the  
16 Election Officer during office hours.

17       *Sec. 5. Automated and Electronic Notice of Approval or Disapproval* – The  
18 automated and electronic system of voter registration shall include a feature that  
19 automatically informs the applicant of the successful submission of his or her  
20 application or request. The system shall provide detailed instructions on how the  
21 applicant may follow up or complete the application for registration or requests, the  
22 estimated time to complete the processing of the application or request, details on the  
23 notice of approval or disapproval of the application and requests, further remedies  
24 available in case of disapproval, and such other information necessary to promptly  
25 assist the applicant with his or her application or request.

26       *Sec. 6. Secure Internet Website and Online Platforms.* – The COMELEC shall  
27 design, devise, adopt, or otherwise use a secure Internet Website or online platform  
28 where such applications may be filed by voters and/or applicants. Security measures  
29 shall be put in place to protect and guarantee the completeness, accuracy, and

1 integrity of voter registration forms, applications, and information submitted and filed  
2 through such Internet Website or online platform.

3       *Sec. 7. Automatic Registration* - Within ten (10) years from the effectivity of  
4 this Act, the COMELEC shall implement a program wherein persons registered under  
5 the existing National ID Program shall be automatically registered as voter of the place  
6 of their declared residence upon reaching the allowable voting age.

7       *Sec. 8. Implementing Rules and Regulations.* – The COMELEC, in coordination  
8 with the appropriate government agencies, including the Department of Science and  
9 Technology (DOST) and the Department of Information and Communications  
10 Technology (DICT), and in consultation with relevant stakeholders, shall promulgate  
11 the implementing rules and regulations within ninety (90) from the effectivity of this  
12 Act.

13       *Sec. 9. Appropriation.* – The amount necessary for the effective implementation  
14 of this Act shall be included in the budget of the COMELCE in the annual General  
15 Appropriations Act.

16       *Sec. 10. Separability Clause* – Any portion or provisions of this Act that may be  
17 declared unconstitutional or invalid shall not have the effect of nullifying other portions  
18 or provisions hereof as long as such remaining portions or provisions can still subsist  
19 and be given effect in their entirety.

20       *Sec. 11. Repealing Clause* – All laws, presidential decrees, executive orders,  
21 memoranda, circulars, rules and regulations, and other issuances or parts thereof,  
22 which are inconsistent with this Act, are hereby repealed, amended, or modified  
23 accordingly.

24       *Sec. 12. Effectivity Clause* – This Act shall take effect fifteen (15) days after its  
25 publication in the *Official Gazette* or in at least two (2) newspapers of general  
26 circulation.
