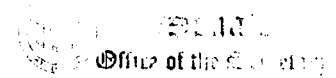

Recommending the approval of House Bill No. 6704 with amendments, taking into consideration Senate Bill Nos. 1699 and 1788.

**MR. PRESIDENT:**

The Committees on Higher, Technical and Vocational Education; Ways and Means; and Finance to which were referred **House Bill No. 6704**, introduced by Representatives Yap (E.), Go (M.), Suansing (M.A.), Eudela, Rodriguez (R.), *et al.*, entitled:

**"AN ACT  
ESTABLISHING A COLLEGE OF MEDICINE IN THE BENGUET  
STATE UNIVERSITY LOCATED IN THE MUNICIPALITY OF LA  
TRINIDAD, PROVINCE OF BENGUET, TO BE KNOWN AS THE  
BENGUET STATE UNIVERSITY-COLLEGE OF MEDICINE, AND  
APPROPRIATING FUNDS THEREFOR"**

taking into consideration **Senate Bill No. 1699**, introduced by Senator Tuifo, entitled:

**"AN ACT  
ESTABLISHING A COLLEGE OF MEDICINE IN THE BENGUET  
STATE UNIVERSITY IN THE MUNICIPALITY OF LA TRINIDAD,  
PROVINCE OF BENGUET, TO BE KNOWN AS THE "BENGUET  
STATE UNIVERSITY COLLEGE OF MEDICINE", AND  
APPROPRIATING FUNDS THEREFOR"**

and **Senate Bill No. 1788**, introduced by Senator Marcos, entitled:

**"AN ACT  
ESTABLISHING A COLLEGE OF MEDICINE IN THE BENGUET  
STATE UNIVERSITY LOCATED IN THE MUNICIPALITY OF LA  
TRINIDAD, PROVINCE OF BENGUET, TO BE KNOWN AS THE  
BENGUET STATE UNIVERSITY COLLEGE OF MEDICINE, AND  
APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 6704, taking into consideration Senate Bili Nos. 1699 and 1788, be approved with the following amendments:

1. On Page 2, Line 14, delete the phrase "as amended" and the comma "(,)" after the phrase;
2. On Page 2, line 18, section 4, replace the acronym "BSU" with the word **"COLLEGE"**;
3. On the same page, line 21, delete the phrase "its guidelines on qualifications standards, and based on" and insert the phrase **"THE GUIDELINES, QUALIFICATIONS AND STANDARDS SET BY THE BOARD, AND UPON"**;

4. On the same page, line 48, section 6, insert the word "**SEX**" and a comma "(,)" before the word "gender";
5. On the same page, line 49, delete the word "preference";
6. On page 3, line 1, section 6, delete the phrase "guidelines on qualification standards" and insert the phrase "**GUIDELINES, QUALIFICATIONS AND STANDARDS**";
7. On the same page, line 3, delete the phrase "church or religious sect" and insert the phrase "**RELIGIOUS DENOMINATION**";
8. On the same page, line 16, section 7, insert the word "**SEX**" and a comma "(,)" before the word "gender";
9. On the same page, line 17, delete the word "or" before the word "ethnic", then after the word "origin" insert a comma "(,)" and the phrase "**OR ANY OTHER FORMS OF DISCRIMINATION**";
10. On the same page, lines 23 to 31, delete the entire Section 9 and replace it with the following:

**"SEC. 9. LOAN OR TRANSFER OF SUPPLIES, APPARATUSES, OR EQUIPMENT, AND DETAIL OF PERSONNEL TO THE COLLEGE. – HEADS OF NATIONAL GOVERNMENT AGENCIES AND INSTRUMENTALITIES MAY, UPON THE REQUEST OF THE BOARD THROUGH THE PRESIDENT OF THE BSU, LOAN OR TRANSFER SUPPLIES, APPARATUSES, OR EQUIPMENT, AND DETAIL PERSONNEL TO THE COLLEGE: PROVIDED, THAT SUCH LOAN, TRANSFER OR DETAIL SHALL NOT BE DETRIMENTAL TO PUBLIC SERVICE.**

**"THE PERSONNEL TO BE DETAILED TO THE COLLEGE SHALL PERFORM SUCH DUTIES AS MAY BE DEEMED REQUIRED BY THE DEAN OF THE COLLEGE AND THE TIME SPENT FOR SUCH DUTIES SHALL BE COUNTED AS PART OF THE DETAILED PERSONNEL'S REGULAR SERVICE."**

11. On page 4, line 4, insert a new Section 12 to read as follows:

**"SEC. 12. COMPLIANCE WITH CHED REQUIREMENTS. — THE BSU, PRIOR TO THE ESTABLISHMENT OF THE COLLEGE AND THE OFFERING OF NEW AND REVISED COURSES AND PROGRAMS RELATED THERETO, SHALL ENSURE COMPLIANCE WITH THE APPLICABLE POLICIES, STANDARDS AND GUIDELINES OF THE CHED."**

12. Finally, renumber the succeeding sections accordingly.





AN ACT

**ESTABLISHING A COLLEGE OF MEDICINE IN THE BENGUET STATE UNIVERSITY LOCATED IN THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET, TO BE KNOWN AS THE BENGUET STATE UNIVERSITY-COLLEGE OF MEDICINE, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. Establishment.** – There is hereby established a medical school in the Benguet  
2 State University (BSU) located in the Municipality of La Trinidad, Province of Benguet, to be  
3 known as the “*Benguet State University-College of Medicine*”.

4  
5           **SEC. 2. General Mandate.** – The Benguet State University-College of Medicine,  
6 hereinafter referred to as the “College”, shall primarily offer a Doctor of Medicine Program,  
7 including an Integrated Liberal Arts and Medicine Program, consisting of basic science and clinical

1 courses, and using a learner-centered, competency-based, and community-oriented approach. The  
2 primary goal of the College shall be to develop a corps of professional physicians to help strengthen  
3 the healthcare system of the country, as well as to respond to the human resource development  
4 needs of the Province of Benguet and the Cordillera Administrative Region.  
5

6  
7 The College is also mandated to undertake research and extension services and provide  
8 progressive leadership in these areas.  
9

10 **SEC. 3. Governance.** – The governance of the College shall be vested in the Board of  
11 Regents of the BSU, hereinafter referred to as the Board, whose powers are defined under  
12 Presidential Decree No. 2010, entitled “Converting the Mountain State Agricultural College in the  
13 Municipality of La Trinidad, Province of Benguet, into a University, to be Known as the Benguet  
14 State University, and Appropriating Funds Therefor”, as amended, and other applicable laws and  
15 regulations, unless otherwise provided or amended elsewhere in this Act.  
16

17 **SEC. 4. Administration.** – The administration of the College shall be vested in the Dean of  
18 the BSU insofar as may be authorized by its Board.  
19

20 **SEC. 5. The College Dean.** – The College shall be headed by a Dean who shall be  
21 appointed by the Board, subject to its guidelines on qualifications standards, and based on the  
22 recommendation of the President, following a process of consultation with the constituents of  
23 the College. The Dean shall render full-time service, serve a term of three (3) years, and may be  
24 reappointed to another term.  
25

26 Within six (6) months from the effectivity of this Act, the President of the BSU shall  
27 constitute the Search Committee for the Deanship.  
28

29 The powers and duties of the Dean of the College, in addition to those specifically provided  
30 for in this Act, shall include those usually pertaining to the Office of the Dean of similar state  
31 universities and colleges and those delegated by the President.  
32

33 The salary of the Dean of the College shall be in accordance with Republic Act No. 11466,  
34 otherwise known as the “Salary Standardization Law of 2019”, and such other laws amendatory  
35 thereto, which may hereinafter be enacted, and shall be comparable to that being received by the  
36 Deans of similar educational institutions.  
37

38 In case of vacancy in the Office of the Dean by reason of death, compulsory retirement,  
39 resignation, removal for cause, or incapacity of the Dean to perform the functions of the office,  
40 the Board shall, upon the recommendation of the President, designate an Officer-in-Charge of the  
41 College, pending the appointment of a new Dean: *Provided*, That the Officer-in-Charge shall  
42 serve only during the unexpired portion of the term.  
43

44 The Dean of the College shall be assisted by a College Secretary, who shall be appointed  
45 by the Board.  
46

47 **SEC. 6. The Faculty.** – The Board shall, upon the recommendation by the President of  
48 the BSU, appoint the faculty members of the College: *Provided*, That no political belief, gender  
49 preference, cultural or community affiliation or ethnic origin, nor religious opinion or affiliation  
50 shall be a matter of inquiry in the appointment of faculty members of the College: *Provided*,



1 *further*. That said appointment shall be subject to the guidelines on qualification standards set  
2 by the Board: *Provided, finally*. That no member of the faculty shall teach for or against any  
3 particular church or religious sect.  
4

5 **SEC. 7. *Scholarship Programs and Admission.*** – The College shall provide scholarships  
6 and other affirmative action programs to assist poor but deserving students who qualify for  
7 admission to the College. Students who have availed themselves of the scholarship program under  
8

9  
10 Republic Act No. 11509, otherwise known as the “Doktor Para sa Bayan Act”, shall render a return  
11 service in accordance with the said law. Students availing themselves of other nationally-funded  
12 scholarship programs to complete the medicine degree program under the College may be required  
13 to render a return service depending on the contract to be signed between the student and the  
14 College.  
15

16 No student shall be denied admission to the College by reason of gender, religion, cultural  
17 or community affiliation, physical disability, or ethnic origin.  
18

19 **SEC. 8. *Academic Freedom and Institutional Autonomy.*** – The College shall enjoy  
20 academic freedom and institutional autonomy, pursuant to Paragraph 2, Section 5 of Article XIV  
21 of the Constitution.  
22

23 **SEC. 9. *Authority to Loan or Transfer Apparatus, Equipment or Supplies, and Detail of***  
24 ***Personnel.*** – Upon the request of the Board, through the President of the BSU, the heads of the  
25 bureaus and offices of the national government may loan or transfer to the college such  
26 apparatus, equipment or supplies as may be needed by it, and detail employees for duty therein  
27 when, in the judgment of the head of bureau or office, the apparatus, equipment, supplies or  
28 services of such employees can be spared without serious detriment to public service.  
29

30 The employees so detailed shall perform such duties as required of them by the Dean of  
31 the College, and the time so served shall be counted as part of their regular service.  
32

33 **SEC. 10. *Assets, Liabilities, and Personnel.*** – All appropriations, assets, both real and  
34 personal, personnel, and records of the College, as well as its liabilities or obligations, shall be  
35 titled or named after the BSU.  
36

37 All parcels of land belonging to the government to be occupied by the College shall be the  
38 property of the BSU, and titled under its name: *Provided*, That should the BSU cease to exist or  
39 be abolished or should such aforementioned parcels of land be no longer needed by the BSU, the  
40 same shall revert to the Municipality of La Trinidad or to the Republic of the Philippines, as the  
41 case may be.  
42

43 **SEC. 11. *Duty and Tax Exemptions.*** – The importation by the College of medical books  
44 or publications, medical equipment or instruments which are for medical, laboratory or scientific  
45 purposes shall, upon certification by the Commission on Higher Education (CHED), be exempt  
46 from customs duties in accordance with the provisions of Republic Act No. 10863, otherwise  
47 known as the “Customs Modernization and Tariff Act”.  
48

49 All grants, bequests, endowments, donations, and contributions made to and used actually,  
50 directly, and exclusively for educational purposes by the College, shall be exempt from donor’s  
51 tax and the same shall be considered as allowable deduction from gross income for purposes of

1 computing the taxable income of the donor in accordance with the provisions of the National  
2 Internal Revenue Code of 1997, as amended.

3  
4 **SEC. 12. *Suppletory Application.*** – The provisions of Republic Act No. 8292, otherwise  
5 known as the “Higher Education Modernization Act of 1997”, shall form part of this Act.

6  
7 **SEC. 13. *Appropriations.*** – The amount necessary to carry out the provisions of this Act  
8 shall be included in the annual General Appropriations Act.

9  
10 **SEC. 14. *Implementing Rules and Regulations.*** – Within sixty (60) days from the approval  
11 of this Act, the Board shall, in consultation with the CHED, issue rules and regulations to  
12 implement the provisions of this Act.

13  
14 **SEC. 15. *Separability Clause.*** – If, for any reason, any part or provision of this Act is  
15 declared invalid or unconstitutional, the remaining parts or provisions not affected are in full force  
16 and effect.

17  
18 **SEC. 16. *Repealing Clause.*** – All laws, presidential decrees, executive orders, and rules  
19 and regulations contrary to or inconsistent with the provisions of this Act are amended, repealed,  
20 or modified accordingly.

21  
22 **SEC. 17. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in  
23 the *Official Gazette* or in a newspaper of general circulation.
