#### ANACT

DECLARING JULY 31 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF TANGALAN, PROVINCE OF AKLAN, TO BE KNOWN AS "TANGALAN DAY", IN COMMEMORATION OF ITS FOUNDATION DAY, AND IN HONOR OF THE BRAVERY OF THE LOCAL HEROES OF THE VIVO REVOLT

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. July 31 of every year is hereby declared a special nonworking holiday in the Municipality of Tangalan, Province of Aklan, to be known as "Tangalan Day", in commemoration of its foundation day, and in honor of the bravery of the local heroes of the Vivo Revolt.
- SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
