AN ACT

DECLARING MARCH 7 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE ISLAND GARDEN CITY OF SAMAL, PROVINCE OF DAVAO DEL NORTE, IN COMMEMORATION OF ITS FOUNDATION DAY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. March 7 of every year is hereby declared a special nonworking holiday in Island Garden City of Samal, Province of Davao del Norte, in commemoration of its foundation day.
- SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
