**AN ACT DECLARING JUNE 21ST OF EVERY YEAR A SPECIAL
NONWORKING HOLIDAY IN THE CITY OF BAYUGAN, PROVINCE
OF AGUSAN DEL SUR IN COMMEMORATION OF ITS CHARTER
DAY**

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 **SECTION 1.** June 21 of every year is hereby declared a special
2 nonworking holiday in the City of Bayugan, Province of Agusan del Sur in
3 commemoration of its Charter Day.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general circulation.
