AN ACT

DECLARING JULY 5 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF BAMBANG, PROVINCE OF NUEVA VIZCAYA, TO BE KNOWN AS "BAMBANG DAY", IN COMMEMORATION OF ITS FOUNDATION ANNIVERSARY

*Be it enacted by the Senate and House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1.** July 5 of every year is hereby declared a special nonworking holiday in the
2 Municipality of Bambang, Province of Nueva Vizcaya, to be known as "*Bambang Day*", in
3 commemoration of its foundation anniversary.

5 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
6 *Gazette* or in a newspaper of general circulation.
