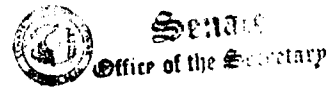





AN ACT

**DECLARING NOVEMBER 11 OF EVERY YEAR AS A SPECIAL (NON-WORKING)
HOLIDAY IN THE MUNICIPALITY OF TAYSAN, PROVINCE OF BATANGAS, IN
CELEBRATION OF ITS FOUNDING ANNIVERSARY**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** November 11 of every year is hereby declared a special (non-working)
2 holiday in the Municipality of Taysan, Province of Batangas, in celebration of its founding
3 anniversary.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the
5 *Official Gazette* or in at least two (2) newspapers of general circulation.
