AN ACT

CREATING A DISTRICT ENGINEERING OFFICE IN THE SECOND LEGISLATIVE DISTRICT OF THE PROVINCE OF DAVAO DEL NORTE, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. A district engineering office of the Department of Public Works and Highways is hereby created in the Second Legislative District, Province of Davao Del Norte, to be located in the Municipality of Carmen, and referred to as the Davao Del Norte Second District Engineering Office.
- SEC. 2. The Davao Del Norte Second District Engineering Office shall serve the City of Panabo, the Island Garden City of Samal and the Municipalities of B.E. Dujali, Carmen and Santo Tomas, all located in the Second Legislative District of the Province of Davao Del Norte.
- SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of the Davao Del Norte Second District Engineering Office, the funding of which shall be included in the annual General Appropriations Act.
- SEC. 4. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
