ANACT

CREATING A DISTRICT ENGINEERING OFFICE IN THE CITY OF ANTIPOLO, PROVINCE OF RIZAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. A district engineering office of the Department of Public Works and Highways is hereby created and to be located in the Second Legislative District in the City of Antipolo, Province of Rizal and referred to as the Rizal Third District Engineering Office.
- SEC. 2. The Rizal Third District Engineering Office shall serve the First and Second Legislative Districts of Antipolo City, Province of Rizal.
- SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of the Rizal Third District Engineering Office, the funding of which shall be included in the annual General Appropriations Act.
- SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
