



AN ACT  
CREATING A DISTRICT ENGINEERING OFFICE IN THE SECOND  
LEGISLATIVE DISTRICT OF DAVAO CITY, AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           **SECTION 1.** A district engineering office of the Department of Public Works and  
2 Highways is hereby created in the Second Legislative District of Davao City, to be located  
3 at the DPWH Depot in Barangay Panacan, Davao City, and referred to as the Davao City  
4 Third District Engineering Office.

5           **SEC. 2.** The Davao City Third District Engineering Office shall serve the  
6 barangays of, Agdao Proper, Paciano Bangoy, Centro, Kap. T. Monteverde, Lapu-lapu,  
7 Leon Garcia, Sr., R. Castillo, San Antonio, Ubalde, V. Duterte, W. Aquino, Acacia,  
8 Buhangin Proper, Cabantian, Callawa, Communal, Indangan, Mandug, Pampanga, A.  
9 Angliongto, Sr., Hizon, Sr., Sasa, Tigatto, Waan, Bunawan Proper, Gatungan, Ilang,  
10 Lasang, Mahayag, Mudiang, Panacan, San Isidro, Tibungco, Colosas, Fatima, Lumiad,  
11 Mabuhay, Malabog, Mapula, Panalum, Pandaitan, Paquibato Proper, Paradise Embac,  
12 Salapawan, Sumimao and Tapak, all located in the Second Legislative District of  
13 Davao City.

14           **SEC. 3.** The Secretary of Public Works and Highways shall include in the  
15 Department's program the operationalization of the Davao City Third District  
16 Engineering Office, the funding of which shall be included in the annual General  
17 Appropriations Act.

18           **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the  
19 *Official Gazette* or in a newspaper of general circulation.
