**AN ACT
DECLARING NOVEMBER 3 OF EVERY YEAR A SPECIAL NONWORKING
HOLIDAY IN THE MUNICIPALITY OF KALIBO, PROVINCE OF AKLAN,
TO BE KNOWN AS THE "KALIBO FOUNDATION DAY"**

*Be it enacted by the Senate and House of Representatives
of the Philippines in Congress assembled:*

- 1 **SECTION 1.** November 3 of every year is hereby declared a special nonworking holiday
2 in the Municipality of Kalibo, Province of Aklan, to be known as the "Kalibo Foundation Day".
- 3 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
4 *Gazette* or in a newspaper of general circulation.
