COMMEMORATION OF ITS FOUNDATION DAY

*Be it enacted by the Senate and House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1.** June 18 of every year is hereby declared a special nonworking holiday in the
2 Municipality of Sta. Maria, Province of Davao Occidental in commemoration of its foundation
3 day.

5 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
6 *Gazette* or in a newspaper of general circulation.
