AN ACT

**DECLARING JANUARY 8 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY
IN THE MUNICIPALITY OF PAVIA, PROVINCE OF ILOILO, TO BE KNOWN AS
“PAVIA DAY”, TO COMMEMORATE ITS FOUNDATION ANNIVERSARY**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** January 8 of every year is hereby declared a special non-working holiday in
2 the Municipality of Pavia, Province of Iloilo, to be known as “*Pavia Day*”, to commemorate its
3 foundation anniversary.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
5 *Gazette* or in a newspaper of general circulation.
