AN ACT

DECLARING JANUARY 8 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY IN THE MUNICIPALITY OF PAVIA, PROVINCE OF ILOILO, TO BE KNOWN AS "PAVIA DAY", TO COMMEMORATE ITS FOUNDATION ANNIVERSARY

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. January 8 of every year is hereby declared a special non-working holiday in 2 the Municipality of Pavia, Province of Iloilo, to be known as "*Pavia Day*", to commemorate its 3 foundation anniversary.

4 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official* 5 *Gazette* or in a newspaper of general circulation.
