AN ACT

**DECLARING NOVEMBER 7 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF CUENCA, PROVINCE OF BATANGAS, TO BE KNOWN AS "CUENCA FOUNDATION DAY", IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. November 7 of every year is hereby declared a special nonworking holiday  
2 in the Municipality of Cuenca, Province of Batangas to be known as "Cuenca Foundation Day",  
3 in commemoration of its founding anniversary.

5           SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official*  
6 *Gazette* or in a newspaper of general circulation.
