AN ACT TO DECLARE DECEMBER OF EVERY YEAR AS "NATIONAL VOLUNTEER MONTH" IN THE ENTIRE COUNTRY, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9418, OTHERWISE KNOWN AS THE "VOLUNTEER ACT OF 2007"

EXPLANATORY NOTE

As a member of the International Secretariat for Volunteer Service (ISVS), by virtue of Executive Order No. 134 s.1964, the Philippines has created the Philippine National Volunteer Service Committee to serve as the liaison between the ISVS and the Philippine government agencies in order to foster economic cooperation in the through participation in the ISVS programs.

Executive Order No. 635 s.1980, creating the Philippine National Volunteer Service Coordinating Agency (PNVSCA), was issued to effectively formulate the policies and guidelines concerning the volunteer service programs in the country.

In 2007, Republic Act No. 9418 or the "Volunteer Act of 2007" was enacted to provide a policy framework on volunteerism. It highlighted the fundamental principles of the voluntary sector to harness and harmonize the same for an integrative and effective partnership for local and national development.

The United Nations General Assembly, on 05 December 1985, issued Resolution 40/212 inviting countries to observe annually every 5th of December as the International Volunteer Day for Economic and Social Development. This is in recognition for all the contributions done by volunteers through their hard work and personal sacrifices. The same also endeavors to stimulate more people in all walks of

life to partake in the nobility of volunteer service and provide greater awareness in the valuable efforts of volunteers.

In response to the UN General Assembly Resolution, Proclamation No. 55 s. 1998 was issued declaring the month of December every year as the National Volunteer Month. This bill therefore seeks to amend Republic Act No. 9418 in order to declare the month of December of every year as the *"National Volunteers Month"*, enjoining all Filipino citizens to strengthen the *bayanihan* spirit by inculcating volunteerism in our Filipino values especially in the Filipino youths.

In view of the foregoing, the immediate passage of this bill is earnestly sought.

AN ACT

TO DECLARE DECEMBER OF EVERY YEAR AS "NATIONAL VOLUNTEER MONTH" IN THE ENTIRE COUNTRY, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9418, OTHERWISE KNOWN AS THE "VOLUNTEER ACT OF 2007"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 13 of Republic Act No. 9418, otherwise known as the "*Volunteer* Act of 2007", is hereby amended to include a new section denominated as Section 13 A, and shall read as follows:

"SEC. 13. 4 Institutional Mechanism for Research, 5 Documentation, Recognition and Modeling of Best Volunteer 6 **Practices.** - To carry out the purposes of this Act, an institutional 7 mechanism shall be established, to be spearheaded and administered by the PNVSCA, for continuing research, documentation, recognition and 8 9 modeling of best volunteer practices as an important component of 10 implementing development programs and projects and undertaking 11 humanitarian activities. For this purpose, the PNVSCA in consultation with 12 any and all relevant government agencies, NGOs, private institutions and 13 persons shall effect the setting up of the mechanism as well as determine 14 all requirements and, or necessary acts to ensure its effective 15 implementation.

16"SEC.13-A.DECLARATIONOF NATIONAL17VOLUNTEER MONTH. – THE MONTH OF DECEMBER OF18EVERY YEAR SHALL BE DECLARED AS NATIONAL19VOLUNTEER MONTH IN THE ENTIRE COUNTRY, IN20RECOGNITION OF THE CONTRIBUTIONS MADE BY21VOLUNTEERS TO SOCIETY.

1 PURSUANT THERETO, DECEMBER 5 OF EVERY YEAR 2 IS ALSO DESIGNATED AS THE NATIONAL VOLUNTEER 3 DAY, CORRESPONDING TO THE INTERNATIONAL 4 VOLUNTEER DAY. THE CELEBRATION OF THE NATIONAL VOLUNTEER 5 MONTH SHALL BE SPEARHEADED BY THE PNVSCA 6 7 FOR COORDINATION PURPOSES. 8 ALL HEADS OF GOVERNMENT AGENCIES AND 9 INSTRUMENTALITIES, INCLUDING **GOVERNMENT-**OWNED AND CONTROLLED CORPORATIONS, AS WELL 10 11 AS LGUS, AND EMPLOYERS IN THE PRIVATE SECTOR 12 ARE HEREBY MANDATED TO ENJOIN ALL THEIR ACTIVELY 13 PERSONNEL ТО PARTICIPATE AND 14 SUPPORT ACTIVITIES AND PROGRAMS FOR THE OBSERVATION AND CELEBRATION OF NATIONAL 15 VOLUNTEER MONTH." 16

SEC. 2. This Act shall take effect fifteen (15) days after its publication in the Official
Gazette or in a newspaper of general circulation.
