### INTRODUCED BY SEN. JINGGOY EJERCITO ESTRADA

### **EXPLANATORY NOTE**

Education is the prime motive force for the development of a nation. This is recognized by the Constitution by making education the foremost concern of the State. Providing access for academic and technical development must be the responsibility of the government.

The bill is recognizing and providing the mechanism for the establishment and propagating the open and distance learning educational modes of the Philippines. Though certain higher educational institutions have been using this mode for pedagogical purposes, this bill entrusts to the University of the Philippines Open University to be the vanguard for the development of these learning systems. The University shall assist and provide for necessary expertise for schools wishing to create open and distance learning programs.

This learning mode will provide access to those who wish to enhance their academic and technical training without being bound by the logistical difficulties present in our educational landscape. By opening this portal of learning, the future is assured of its development and growth.

These being the premises, the passage of this bill is most earnestly sought.

#### INTRODUCED BY SEN, JINGGOY EJERCITO ESTRADA

#### AN ACT

INSTITUTIONALIZING THE OPEN LEARNING AND DISTANCE EDUCATION SYSTEM IN THE PHILIPPINES, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

**SECTION 1**. **Short Title** – This Act shall be known as the "Open and Distance Learning System of Education Act."

- SEC 2. Declaration of Policy. It is hereby declared a policy of the State to expand and further democratize educational opportunities for our people in a more effective and economical manner through utilization of innovative educational technologies. In view thereof, the State recognizes the open and distance learning system as a necessary mode to achieve equitable access to quality tertiary education even as it guarantees the academic freedom of higher educational institution.
- **SEC 3**. *Definition of Terms*. For the purposes of this Act, the following terms shall mean:
  - (a) Open Learning System an institutionalized system of delivery of educational services that allows for wider access to educational opportunities by overcoming barriers resulting from geographical isolation and personal or work commitments.
  - (b) Distance Education a method of learning and teaching employing print, radio, television, computer-based communications, satellite broadcasting teleconferencing or other educational technologies that allows students to study on their own without having to regularly attend classes in conventional classrooms.
- SEC 4. Institutionalization of the Open and Distance Learning System. The open and distance learning system, hereinafter referred to as the

System, is hereby institutionalized in the Philippines in accordance with the provisions of this Act.

- **SEC 5.** Coverage. The Act shall apply to public and private higher educational institutions with existing open and distance learning programs, and to other institutions that shall later be authorized as qualified implements of the System.
- **SEC 6.** Role of the Commission on Higher Education. The Commission on Higher Education, hereinafter referred to as the CHED, shall plan. Set standards, coordinate, monitor and authorize the effective implementation of open learning and distance education in the country in accordance with the provisions of this Act. It shall:
  - (a) Formulate, promulgate and implement the necessary rules and regulations to maintain same quality of education and uniform standards of performance for both distance and residential students of participating higher education institutions;
  - (b) Monitor, evaluate and effect the continuation or closure of programs in accordance with the provisions of the implementing rules and regulations;
  - (c) Review and approve proposals from educational institutions for new open and distance education programs, and;
  - (d) Recommend to the Department of Budget and Management, supplemental budget for open learning and distance education programs of participating higher education institutions.
- SEC 7. Criteria for Commission on Higher Education's Approval of New Open and Distance Education Programs. Higher education institutions applying for CHED's approval to establish open and distance learning programs shall be evaluated based on the following criteria, among others, to be defined by the CHED:
  - (a) Qualified faculty with experience and/or training in open and distance education;
  - (b) Relevant curricular programs;
  - (c) Appropriate instructional materials;
  - (d) Appropriate student support services and delivery systems;
  - (e) Linkages with other appropriate institutions as resource centers and:
  - (f) Recognized research programs on open and distance learning.

SEC 8. Role of the University of the Philippines Open University. The University of the Philippines Open University, hereinafter referred to as the UPOU, shall be designed as the national open university. It shall set up the model programs, undertake relevant research and development projects, assist other interested higher education institutions in developing open learning and distance education programs and provide technical assistance to the CHED in open and distance education matters.

The University of the Philippines Open University shall support start up programs for duly recognized higher education institutions and shall provide necessary support for the educational institution's pursuit of an educational system catering to and specific to the needs of the institution.

- SEC 9. Role of Government Broadcast Stations and Telecommunications Network. Government broadcast stations and telecommunications networks shall provide the necessary assistance and coordination in support of the System.
- **SEC 10.** Appropriations. For the initial implementation of this Act, the amount of Fifty Million Pesos (P50,000,000.00) from the President's organizational fund shall be divided equally between the CHED and the UPOU. Thereafter, the amount necessary for the continuous implementation of this program by the CHED and UPOU shall be included in the General Appropriations Act.
- **SEC 11.** Separability Clause. If any provision of this Act shall be held to be unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.
- **SEC 12.** Repealing Clause. All laws, decrees, executive orders, presidential proclamations, rules and regulations or parts thereof contrary to or inconsistent with the provisions of this Act, is hereby repealed or modified accordingly.
- **SEC13. Effectivity Clause.** This Act shall take effect fifteen (15) days from the complete publication in the Official Gazette or in at least two (2) newspapers of general circulation.
