
has considered the same and has the honor to report the bill back to the Senate with the recommendation that it House Bill No. 5013 be approved without amendment.

AN ACT APPROPRIATING THE SUM OF THIRTEEN BILLION ONE
HUNDRED MILLION PESOS (P13,100,000,000.00) TO FUND
THE ADJUSTMENT IN COMPENSATION OF NATIONAL
GOVERNMENT EMPLOYEES AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Appropriations and Use of the Fund.* – The amount of
2 Thirteen billion one hundred million pesos (P13,100,000,000.00) is hereby
3 appropriated to cover the funding requirements for the One thousand pesos
4 (P1,000.00) per month additional allowance of national government employees
5 covered by Republic Act No. 6758 (the Compensation and Position
6 Classification Act of 1989), as amended, and the military and uniformed
7 personnel.

8 SEC. 2. *Release of Fund.* – The amount herein appropriated shall be
9 released to the departments, bureaus, offices and agencies by the Department
10 of Budget and Management (DBM) in accordance with budgeting laws, rules
11 and regulations.

12 SEC. 3. *Authority to Grant Additional Allowance to Government-*
13 *Owned and/or -Controlled Corporations (GOCCs) and Local Government*
14 *Units (LGUs).* – Subject to the availability of funds, GOCCs covered by
15 Republic Act No. 6758 (the Compensation and Position Classification Act of
16 1989), as amended, and LGUs are likewise authorized to grant additional
17 allowance chargeable against their respective funds: *Provided,* That if the
18 funds are not sufficient for the grant of this additional allowance, the same may
19 be partially implemented at a rate uniformly applied to all their respective
20 personnel: *Provided, further,* That in the case of LGUs, the personal services
21 limitation under Republic Act No. 7160 (the Local Government Code of 1991)
22 shall be waived for purposes of the grant of the additional allowance.

1 SEC. 4. *Implementing Rules and Regulations.* -- The DBM shall issue
2 the necessary rules and regulations to implement the grant of the additional
3 allowance.

4 SEC. 5. *Effectivity.* -- This Act shall take effect beginning January 1, 2006.
