6	SECTION 1. Short Title This Act shall be know	n as the "Local Emergency	

7 Centers Act of 2007"

8 SECTION 2. *Declaration of Policy* It is hereby declared the policy of the State 9 to: (1) provide emergency centers throughout the country to aid citizens during times of 10 disaster and calamities; and (2) provide proper disaster preparedness and emergency 11 rescue training to volunteers.

SECTION 3. Local Emergency Centers. There shall be established one Local
 Emergency Center (hereinafter referred to as Center) in every municipality throughout
 the country.

15 SECTION 4. *Membership and training.* – All able-bodied citizens who are 18 16 years of age and above, and resident of the respective municipality where they are 17 applying for membership with the Center, shall be eligible for membership. Members of 18 the Centers shall undergo proper disaster preparedness and emergency rescue training. 19 Trainees shall be provided with the necessary materials and paraphernalia as needed 20 during the course of their training.

SECTION 5. *Purpose of the Centers*. – The purpose of a local emergency
centers shall be:

1	1. to provide temporary housing, medical, and humanitarian
2	assistance to individuals and families dislocated due to an emergency or major
3	disaster;
4	2. to provide centralized locations for the purpose of training; and
5	3. to provide centralized locations to improve the coordination of
6	preparedness, response, and recovery efforts of government, private, and not-for-
7	profit entities and faith-based organizations.
8	SECTION 6. Minimum requirements of Centers A site designated as a local
9	emergency center shall be
10	1. capable of meeting for an extended period of time the housing, health, and
11	other humanitarian needs of a large number of individuals affected by an
12	emergency or major disaster;
13	2. environmentally safe and shall not pose a health risk to individuals who
14	may use the center;
15	3. capable of housing necessary equipment for training and first responders
16	coordination requirements during non-disaster periods;
17	4. capable of hosting the infrastructure necessary to rapidly adjust to
18	temporary housing, medical, and humanitarian assistance needs; and
19	5. easily accessible at all times and be able to facilitate handicapped and
20	medical facilities, including during an emergency or major disaster.
21	SECTION 7. Implementing Agency. – The Department of National Defense
22	(DND), in coordination with the respective local government units shall be the
23	implementing agencies for this Act. The DND shall formulate implementing rules and
24	regulations for this Act not later than 90 days after its enactment.
25	SECTION 8. Separability Clause If any provision or part thereof, is held
26	invalid or unconstitutional, the remainder of the law or the provision not otherwise
27	affected shall remain valid and subsisting.

1 SECTION 9. *Repealing Clause.* – Any law, presidential decree or issuance, 2 executive order, letter of instruction, administrative order, rule or regulation contrary to, 3 or inconsistent with the provisions of this Act is hereby repealed, modified or amended 4 accordingly.

5 SECTION 10. *Effectivity Clause.* – This Act shall take effect fifteen (15) days
6 after its publication in at least two (2) newspapers of general circulation.
