The Committee on Local Government to which was referred House Bill No. 4567, introduced by Representative Aquino (R.), entitled:







AN ACT DECLARING FEBRUARY 4 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN THE CITY OF SAN FERNANDO,  
PROVINCE OF PAMPANGA TO BE KNOWN AS THE  
"CITYHOOD DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. To commemorate the conversion of the City of San  
2 Fernando, Province of Pampanga into a component city, February 4 of every  
3 year is hereby declared a special nonworking holiday in the said city to be  
4 known as the "Cityhood Day".

5           SEC. 2. This Act shall take effect upon its approval.
