Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. To commemorate the liberation of the town of Biffan from
- 2 the Japanese Imperial Forces by the 47th Division, 48th Regiment of the
- 3 Hunters ROTC Guerillas under the command of Colonel Emmanuel de
- 4 Ocampo, February 5 of every year is hereby declared a special nonworking
- 5 holiday in the Municipality of Biñan, Province of Laguna to be known as
- 6 "Biñan Liberation Day".
- 7 SEC. 2. The municipal government of Biñan, Laguna is hereby
- 8 mandated to coordinate the efforts of all sectors in Biñan for the effective
- 9 implementation of this Act.
- SEC. 3. This Act shall take effect immediately upon its approval.
