However, R.A. No. 69 fails to provide guidelines for the proper use of franking privileges. Thus, the privilege is exposed to potential abuse. To prevent abuse, this bill regulates the legislative franking privilege.*

10	SECTION 3. Frankable Mail Matter "Frankable mail matter" specifically includes,

13	governments regarding programs, decisions, and other related matters of public

1	SECTION 4. Separability Clause If any provision or part hereof, is held invalid or
2	unconstitutional, the remainder of the law or the provision not otherwise affected shall remain
3	valid and subsisting.

SECTION 5. *Repealing Clause*. – Any law, presidential decree or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent with, the provision of this Act is hereby repealed, modified or amended accordingly.

SECTION 6. *Effectivity Clause.* – This Act shall take effect fifteen (15) days after its
publication in at least two (2) newspapers of general circulation.
