AN ACT DECLARING SEPTEMBER 20 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN ILIGAN CITY TO CELEBRATE  
THE TOURISM WEEK OF THE CITY AND TO HONOR THE  
FEAST OF SAINT MICHAEL ARCHANGEL, PATRON SAINT OF  
THE CITY

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. September 20 of every year is hereby declared a special  
2 nonworking holiday in Iligan City in observance of the celebration of the  
3 Tourism Week of Iligan City and to honor the Feast of St. Michael Archangel,  
4 patron saint of the city.

5           SEC. 2. On this day, all officials, city and national government agencies  
6 or instrumentalities, civic, religious and other nongovernment organizations,  
7 including private companies, shall recognize it as a day of celebration. The  
8 city government shall lead the appropriate activities.

1           SEC. 3. All laws, decrees, orders, rules and regulations and other  
2   issuances or parts thereof which are inconsistent with or contrary to any  
3   provision of this Act are hereby deemed repealed, amended or modified  
4   accordingly.

5           SEC. 4. This Act shall take effect upon its approval.
