AN ACT GRANTING PHILIPPINE CITIZENSHIP TO REV. FR. ULRICH
H. SCHLECHT, SVD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. Rev. Fr. Ulrich H. Schlecht is hereby granted Philippine
2 citizenship with all the rights, privileges and prerogatives appurtenant thereto.

3 SEC. 2. Upon the taking and registration of the Oath of Allegiance to the
4 Republic of the Philippines before the Bureau of Immigration and the issuance
5 to him of the Certificate of Naturalization, Rev. Fr. Ulrich H. Schlecht shall
6 enter upon the full enjoyment of Philippine citizenship.

7 SEC. 3. This Act shall take effect upon its approval.
