*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. To commemorate the creation of the Municipality of  
2 Dulag, Province of Leyte, August 20 of every year is hereby declared a special  
3 nonworking holiday in the said municipality to be known as "Municipal  
4 Foundation Day".

5           SEC. 2. This Act shall take effect upon its approval.
